A RESOLUTION AUTHORIZING THE MAYOR AND FISCAL OFFICER TO ENTER INTO AN AGREEMENT WITH JACOB BROOKS TO SERVE AS ZONING INSPECTOR AND UNSAFE BUILDING INSPECTOR FOR THE VILLAGE OF ALEXANDRIA, OHIO AND DECLARING AN EMERGENCY

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF ALEXANDRIA, COUNTY OF LICKING, STATE OF OHIO, THAT:

SECTION 1. The Mayor and the Fiscal Officer be, and they hereby are, authorized and directed to enter into an agreement with Jacob Brooks to serve as Zoning Inspector and Unsafe Building Inspector for the Village of Alexandria, Ohio, a copy of which agreement is attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

SECTION 2. The hourly rate of pay for Jacob Brooks as Zoning Inspector and Unsafe Building Inspector, which shall be set on a calendar year basis by the Mayor and the Fiscal Officer, shall be between \$250-500/month.

AGREEMENT

THIS AGREEMENT, made at Licking County, Ohio, this 30 day of ^{July} 2024, by and between the VILLAGE OF ALEXANDRIA, 4 West Main Street, Alexandria, Ohio 43001(hereinafter the "Village") and Jacob Brooks ("Brooks"):

WHEREAS, the Village of Alexandria wishes to engage the services of Brooks as a Zoning Inspector and Unsafe Building Inspector; and

WHEREAS, Brooks is willing to serve as Zoning Inspector and Unsafe Building Inspector for the Village of Alexandria, Ohio, under the terms and conditions set forth herein.

NOW, THEREFORE, IT IS HEREBY AGREED between the Village and Brooks as follows:

1. The Village of Alexandria hereby hires Brooks to serve as Zoning Inspector and Unsafe Building Inspector for the Village of Alexandria, Ohio. Brooks shall perform such duties as assigned.
2. Brooks shall be an employee of the Village and shall be paid \$300.00 per month.
3. This Agreement will continue to run and be binding on the parties until terminated. This Agreement may not be modified in any manner except by the written consent of the Village and Brooks. This Agreement may not be assigned by either party.
4. Either party may terminate this Agreement by giving the other party thirty (30) days prior written notice.
