RESOLUTION NUMBER 2026-06

A RESOLUTION PROVIDING FOR SUBMISSION OF AN AMENDMENT TO VILLAGE INCOME TAX, STATING THE RATE OF INCOME TAX, THE PURPOSE OF THE INCOME TAX, THE DATE OF THE ELECTION AT WHICH THE QUESTION IS TO BE PUT BEFORE THE VOTERS AND DIRECTING THE BOARD OF ELECTIONS TO CONDUCT THE ELECTION.

WHEREAS, the Village of Alexandria on January 20, 2026 adopted Ordinance No. 2026-03, which Ordinance amends Ordinance 2019-06, Exhibit A to increase the tax rate by one-half of one percent (0.50%) commencing July 1, 2026; and

WHEREAS, it is Village Council's determination that it is necessary to increase the municipal tax rate by one-half of one percent (0.50%) from one percent (1.0%) to provide necessary funds for the general municipal operations of the Village of Alexandria; and

WHEREAS, pursuant to Ohio Revised Code Section 718.04, the Village Council must submit this issue to the electorate of the Village for approval or rejection;

WHEREAS, pursuant to Ohio Revised Code Section 718.04, the legislative authority of the municipal corporation wishing to impose an income tax greater than one percent (1%) must pass an ordinance authorizing the income tax and pass a resolution stating the rate of the income tax, the purpose of the income tax, the date of the election at which the question is to be put before the voters, and direct the board of elections to conduct the election.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ALEXANDRIA, LICKING COUNTY, OHIO, with at least a majority of its members elected thereto concurring.


SECTION ONE: Subject to the approval of the Ordinance by the electors of the Village, there is hereby adopted a one-half of one percent (0.50%) increase in the rate of the income tax from the current one percent (1%) rate to one and one-half percent (1.5%) per annum.

SECTION TWO: As required by Chapter 718 of the Ohio Revised Code, the amendment specified in the Ordinance shall take effect only if approved by the affirmative vote of the electors of the Village of Alexandria, Ohio who shall vote on the question at the primary/special election on May 5, 2026.


SECTION THREE: Subject to the approval of the electors of the Village of Alexandria of the increase in the municipal income tax rate enacted in Ordinance 2026-03, Ordinance 2019.06, Exhibit A, Section 1 and Section 3 (first paragraph only) are hereby repealed and replaced by the Ordinance 2026-03, effective July 1, 2026.
