

RESOLUTION 2026-17

AMENDED RESOLUTION AUTHORIZING THE MAYOR AND VILLAGE ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH KARLI (ALYX) GRIMSLEY TO SERVE AS DEPUTY CLERK FOR THE VILLAGE OF ALEXANDRIA, OHIO, AND DECLARING AN EMERGENCY

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF ALEXANDRIA, COUNTY OF LICKING, STATE OF OHIO, THAT:

SECTION 1. The Mayor and the Village Administrator be, and they hereby are, authorized and directed to enter into an agreement with Karli (Alyx) Grimsley to serve as Deputy Clerk for the Village of Alexandria, Ohio, a copy of which agreement is attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

SECTION 2. The hourly rate of pay for Karli (Alyx) Grimsley as Deputy Clerk shall be \$18/hour.

SECTION 3. The Deputy Clerk shall be bonded for ten thousand dollars (\$10,000). The Village shall pay the cost of such bond.

SECTION 4: This Resolution is hereby declared an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the Village, and shall take effect and be in force immediately upon its adoption.

AGREEMENT

THIS AGREEMENT, made at Licking County, Ohio, this ____ day of June, 2026, is by and between the VILLAGE OF ALEXANDRIA, 4 West Main Street, Alexandria, Ohio 43001 (hereinafter the "Village") and Karli (Alyx) Grimsley ("Grimsley"):

WHEREAS, the Village of Alexandria wishes to engage the services of Grimsley as a Deputy Clerk; and

WHEREAS, Grimsley is willing to serve as Deputy Clerk for the Village of Alexandria, Ohio, under the terms and conditions set forth herein.


NOW, THEREFORE, IT IS HEREBY AGREED between the Village and Grimsley as follows:

1. The Village of Alexandria hereby hires Grimsley to serve as Deputy Clerk for the Village of Alexandria, Ohio. Grimsley shall report to the Village Administrator and shall perform such duties as assigned. Grimsley will provide up to and a maximum of eight (8) hours of work time per week.
2. Grimsley shall be an at-will employee of the Village and shall be paid \$18.00 per hour.
3. Grimsley shall be bonded for ten thousand dollars (\$10,000). The Village shall pay the cost of such bond.
3. This Agreement may not be modified in any manner except by the written consent of the Village and Grimsley. This Agreement may not be assigned by either party.
