AN ORDINANCE TO ESTABLISH AN APPLICATION POLICY FOR SPECIAL EVENT PERMITS IN THE
VILLAGE OF ALEXANDRIA, OHIO

WHEREAS, the Village of Alexandria, Ohio has determined it is in the best interest of the health, safety, and stability of the Village of Alexandria, Ohio to establish an application process for the posting of banners within the corporate boundaries of the Village of Alexandria;


NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF ALEXANDRIA, STATE OF OHIO WITH A MAJORITY OF THE MEMBERS ELECTED THERETO CONCURRING THAT:

Section 1: The Council of the Village of Alexandria, Ohio adopts the Banner policy attached as Exhibit 1.

Section 2: This Ordinance is hereby declared to be an emergency measure, necessary for the immediate preservation of the public health, safety and welfare. Wherefore, provided this Resolution receives the affirmative vote of three-fourths of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in the force from and after the earliest period allowed by law.



VILLAGE OF ALEXANDRIA
AGREEMENT FOR USE OF BANNER SPACE

The Village of Alexandria, Ohio, hereby authorizes organizations, businesses and groups located within the corporate boundaries of the Village of Alexandria to utilize the promotional space, owned by the Village of Alexandria located in the median area on Granville St and East Main Street, for non-profit purposes in accordance with the following terms and conditions:

1. The space provided is located in the median at the intersection of Granville St & East Main St in the Village of Alexandria.
2. The Renter is responsible for the setting of temporary poles, see images.
3. Only organizations, businesses and groups located within the corporate boundaries of the Village of Alexandria and St Albans Township are permitted to utilize the space and may only be used for non- profit purposes.
4. The Village of Alexandria may limit the number of times any one organization may utilize the space.
5. Applicants are authorized to utilize the display area by completing this form. The Village will reserve the right to hold space for long standing community wide events.
6. Banners are the only medium to be used in the space provided. "Banner" is defined as any sign made of lightweight material. The banner should be single sided and must contain hook/eye on the top, bottom, and center. All banners must be attached using a rope to tie the banner to the pole and must not block or obscure the Village sign.
7. The banner size recommended is three (3) feet by seven (7) feet unless prior approval of Village Administrator.
8. There shall be no limitation on the number of colors for a temporary banner. The use of fluorescent, day-glow, and neon is **prohibited**.
9. Any banner placed in the specified space is only to remain for a period not to exceed fourteen (14) days, commencing on Sunday at 9:00am.
10. Applicants are solely responsible for attaching and removing the banner and the poles within 24 hours of end of event or application deadline, whichever comes first.
11. The Village of Alexandria is not liable for any damage sustained to or by the banner, nor any injuries resulting from the attachment and/or removal of the banner.
