ORDINANCE NUMBER 2025-16

AN ORDINANCE ESTABLISHING AND DESIGNATING CERTAIN TIME LIMITS ON PARKING PLACES LOCATED IN THE BUSINESS DISTRICT AND HANDICAPPED PARKING AND DESIGNATING A NO PARKING ZONE AND DECLARING AND EMERGENCY

WHEREAS,

It is the desire and intent of the Village Council to improve functional parking locations for the various businesses located in the downtown business district of the Village of Alexandria and to provide for adequate handicapped parking and sight lines around parked vehicles;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF ALEXANDRIA, LICKING COUNTY, OHIO, with at least a majority of its members elected thereto concurring:

SECTION ONE: Location of Fifteen-Minute Parking Spaces.

Council for the Village of Alexandria hereby authorizes and creates the following fifteen-minute parking spaces:

- (a) The first parking space located directly in front of 4 West Main Street and the parking space immediately west of it in front of 10 West Main Street shall be designated and marked with signage as being restricted to fifteen-minute parking between the hours of 8:00 a.m. to 6:00 p.m.; and
- (b) The first parking space on the located directly in front of 9 West Main Street and the parking space immediately west of it in front of the area between 9 West Main Street and 15 West Main Street shall be designated and marked with signage as being restricted to fifteen-minute parking between the hours of 8:00 a.m. to 6:00 p.m.; and
- (c) All parking areas identified in sub-sections (a) and (b) shall be subject to Snow Emergency and snow removal restrictions.

SECTION TWO: Location of Two-Hour Parking Spaces.

Council for the Village of Alexandria hereby authorizes and creates the following two-hour parking spaces:

- (a) All parking spaces located along both sides of East and West Main Street within the Village of Alexandria downtown business district, not identified in Section One as fifteen-minute parking or in Section Three as seventy-two hour parking, shall be designated and marked with signage as being restricted to two-hour parking between the hours of 8 :00 a.m. and 6:00 p.m.; and
- (b) The five diagonal parking spaces on the east side of South Liberty Street and south of East Main Street shall be designated and marked with signage as being restricted to two-hour parking between the hours of 8 :00 a.m. and 6:00 p.m.; and
- (c) The first five spaces on the south side of East Main Street proceeding east from the intersection of Main and Liberty Streets shall be designated and marked with signage as being restricted to two-hour parking between the hours of 8:00 a.m. to 6:00 p.m.; and

- (d) The parking space located directly in front of 10 East Main Street shall be designated and marked with signage as being restricted to two-hour parking between the hours of 8:00 a.m. to 6:00 p.m.; and
- (e) The five parking spaces located adjacent to and proceeding north along the east side of North Liberty Street from the handicapped parking space located on the west side of 2 East Main Street shall be designated and marked with signage as being restricted to two-hour parking between the hours of 8:00 a.m. to 6:00 p.m.; and
- (f) All two-hour parking spaces identified in sub-sections (a)-(e) shall be subject to Snow Emergency and snow removal restrictions.

SECTION THREE: Location of Seventy-Two Hour Parking Spaces.

Council for the Village of Alexandria hereby authorizes and creates the following seventy-two hour parking spaces:

- (a) All parking spaces within the Village of Alexandria downtown business district along the North side of West Main Street that are located west of Print Shop Alley and that are located along the South side of West Main Street west of the Museum parking lot drive (with the exception of the No Parking Zone established in Section Six) shall be designated and marked with signage as being restricted to seventy-two hour parking at all times of day and all days of the week; and
- (b) All parking spaces within the Village of Alexandria downtown business district along the North side of East Main Street that are east of 10 East Main Street shall be designated and marked with signage as being restricted to seventy-two hour parking at all times of day and all days of the week; and
- (c) All seventy-two hour parking spaces identified in sub-sections (a) and (b) shall be subject to Snow Emergency and snow removal restrictions.

SECTION FOUR: Handicapped Parking Spaces.

Council for the Village of Alexandria hereby authorizes and creates the following handicapped parking spaces without time limit:

- (a) The parking space on the west side of 2 East Main Street that is closest to the Main Street-Liberty Street intersection shall be designated and marked with signage as being restricted to handicapped parking; and
- (b) The parking space on the east side of 2 West Main Street shall be designated and marked with signage as being restricted to handicapped parking; and
- (c) A third handicapped parking space, which is not van-accessible, shall be located in the museum parking lot at 23 West Main Street and shall be designated and marked with signage as being restricted to handicapped parking.
- (d) Appropriate areas shall be provided and marked to give clear and unobstructed access to these designated handicapped parking areas.
- (e) These handicapped parking spaces and signs marking them will meet and conform with ADA design and dimensions.
- (f) No person shall stop, stand, or park any motor vehicle at special parking locations provided for handicapped persons under this section or at special, clearly marked, parking locations provided for handicapped persons in or on privately-owned parking lots, parking garages, or other parking areas, unless the motor vehicle is displaying a parking card issued under the revised Code or is being operated by or for the transport of a handicapped person and displaying the special license plates authorized by that section.

(g) As used in this section, "handicapped person" has the same meaning as in the Revised Code.

(h) All parking areas identified in sub-sections (a), (b) and (c) shall be subject to Snow Emergency and snow removal restrictions.

SECTION FIVE: Loading Zone.

Council for the Village of Alexandria hereby authorizes and creates the following loading zone:

(a) The space along the east side of 2 West Main Street proceeding north from the handicapped spot to the alley shall be marked with signage as being restricted to loading and unloading.

(b) The loading zone identified in sub-section (a) shall be subject to Snow Emergency and snow removal restrictions.

SECTION SIX: No Parking Zone.

Council for the Village of Alexandria hereby authorizes and creates the following no-parking zone:

(a) The space along the South side of West Main Street west of the Museum parking lot drive shall be a No Parking Zone to improve the sight lines for vehicles exiting the Museum driveway.

SECTION SEVEN: Signage.

The Village Administrator shall direct the Village of Alexandria Service Department to erect and maintain the proper signage designating the parking spaces as set forth herein.

SECTION EIGHT: Penalty.

Any person violating this ordinance shall be guilty of a minor misdemeanor and punished according by fine not to exceed \$250.00.

SECTION NINE: Repeal of Inconsistent and Conflicting Measures.

All prior legislation, or any parts thereof, which is/are inconsistent or in conflict with this measure is/are hereby repealed as to the inconsistent or conflicting parts thereof.

SECTION TEN: Compliance.

It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were conducted in an open meeting of this Council, and that any and all deliberations of this Council, and any of its committees, that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

SECTION ELEVEN: Effective Date.

This Ordinance will take effect at the earliest time allowed by law.

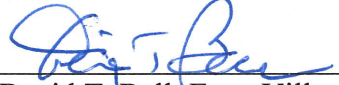
