A RESOLUTION AUTHORIZING THE MAYOR AND VILLAGE ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH JEFF DISBENNETT TO SERVE AS MAINTENANCE TECHNICIAN FOR THE VILLAGE OF ALEXANDRIA, OHIO AND DECLARING AN EMERGENCY

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF ALEXANDRIA, COUNTY OF LICKING, STATE OF OHIO, THAT:

**SECTION 1.** The Mayor and the Village Administrator be, and they hereby are, authorized and directed to enter into an agreement with Jeff Disbennett to serve as Maintenance Technician for the Village of Alexandria, Ohio, a copy of which agreement is attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

**SECTION 2.** The hourly rate of pay for Jeff Disbennett as Maintenance Technician, which shall be set on a calendar year basis by the Mayor and the Village Administrator, shall be between \$18-\$25/hour.

## **AGREEMENT**

THIS AGREEMENT, made at Licking County, Ohio, this \_\_\_\_\_ day of 2025, by and between the VILLAGE OF ALEXANDRIA, 4 West Main Street, Alexandria, Ohio 43001 (hereinafter the "Village") and Jeff Disbennett ("Disbennett"):

**WHEREAS**, the Village of Alexandria wishes to engage the services of Disbennett as a Maintenance Technician; and

**WHEREAS,** Disbennett is willing to serve as Maintenance Technician for the Village of Alexandria, Ohio, under the terms and conditions set forth herein.

NOW, THEREFORE, IT IS HEREBY AGREED between the Village and Disbennett as follows:

- 1. The Village of Alexandria hereby hires Disbennett to serve as Maintenance Technician for the Village of Alexandria, Ohio. Disbennett shall perform such duties as assigned, and will provide up to and a maximum of twenty-four (24) hours of work time per week.
- 2. Disbennett shall be an employee of the Village and shall be paid \$20.00 per hour.
- 3. This Agreement will continue to run and be binding on the parties for a period of one (1) year from the date hereof. This Agreement may not be modified in any manner except by the written consent of the Village and Disbennett. This Agreement may not be assigned by either party.
- 4. Either party may terminate this Agreement by giving the other party thirty (30) days prior written notice.
