

If you are called in for an Investigative Interview, contact us immediately. It doesn't mean you're about to lose your job. Investigative interviews can be positive; often to air out differences or misunderstandings.

Cut out the box below and keep it in your office. If a Postal Inspector or OIG comes to your office and the questions are related directly to you, ask the question 'AM I UNDER INVESTIGATION?' If they say yes, tell them you will not talk to them until your Chapter Member Rep is present.

#### IF YOU RECEIVE A VISIT FROM THE INSPECTION SERVICE OR THE OIG

Statement to be read to Postal Inspectors or OIG:

I request to talk to my UPMA representative before answering any additional questions. If I am a suspect in a criminal matter, please so advise me. If so, I wish to contact my attorney.

If I am under arrest, I request you to so advise me and inform me of the reason or reasons. I will not resist arrest.

I do not consent to a search of my person or property. However, I will not physically resist or obstruct such a person. If you have a search warrant I request to see it at this time.

I will cooperate with you fully, but I will not sign a waiver-of-rights form. I will not admit or deny any allegations, I will not make any written or oral statement unless my attorney and/or UPMA Representative are personally present and so advise me.

The Lost Art of Postage Due

Well, I have been suggesting and/or wanting to have articles in the Hawkeye Heartlander that were helpful, answered often asked questions, or discussed topics that maybe were not widely known about, practiced, or encountered. So here I go — wish me luck — and I hope that everyone can find at least a tidbit of helpful information or learn something new from this article!

I've decided to talk about the lost art of "postage due". I think that in the hustle and bustle of morning distribution —You know, first parcel scanned by X number of minutes from the first clerk's clock in, X number of parcels/hour, flat and letter distribution time to earned, DUT to BT goal, etc. etc. etc.!!! — it's very easy to gloss over or just not even pay attention to our duty to protect our (USPS) revenue. I like to think of it as retail security, not unlike any retail store that uses several different tactics to prevent shoplifting.

Finding items within the mail stream that have not been properly classified and/or paid for is part of our jobs and part of "what we signed up for" when we took on a career with the USPS. Protecting postal revenue is every employee's responsibility, but let's face it, the buck is going to stop with the clerks and/or postmasters — those of us whose job it is to weigh, rate, and apply postage to outgoing mail. It is exactly what we are trained to do in the first place, so naturally we would be the most logical people to be able to recognize these issues when we see them.

So how do you add yet another task to your morning distribution routine? I have instilled the importance of this in my clerk staff and they are getting pretty good at catching several things. I am absolutely sure that we are not catching everything that's out there but are doing what we can to protect the USPS revenue. Below are a few of things that we are seeing and doing:

- 1) Media/Library Mail Did you know that you can open and inspect the contents of certain mail classes? We (USPS employees) are all about the sanctity of the mail. We take an oath regarding that when we are hired, and we all have heard the unbelievable stories of undelivered/stolen mail found in people's garages, basements or vehicles. But, when people choose to mail their items at Media Mail or Library Mail postage rates, they also agree to the possibility of having their parcels inspected at any point in the mail stream to confirm that the contents are eligible to be mailed at those discounted rates. Those heavily discounted postage rates come with conditions that must be met to be eligible for them. Library Mail not only has to qualify to be mailed at that rate but also can only be sent between eligible entities (libraries, museums, universities, etc.) so a quick glance at the to and from addresses can give you a clue. DMM 4.0 gives you a list of specific things that are eligible for Media Mail rates. If a package rattles like M & M's, Nerds, or a puzzle, is soft and squishy like a t-shirt, sounds like a pair of shoes in a box that looks like a shoe box— it's probably worth your time to inspect the contents. Just because a record player, DVD player, etc. are meant to be used to watch or listen to media mail, These items do NOT mean that they can be mailed with media mail rates.
- 2) Priority/Priority Mail Express Did you know that when people use these expedited products in any way, shape or form they also are agreeing to pay those postage rates? If, upon inspection, you find the completely eligible for media mail postage rate books wrapped in a Priority Padded Flat Rate Envelope, guess what??? It is no longer Media Mail but Priority Mail. If it's an Express Flat Rate Envelope but has Priority postage on it, it should be treated as Express Mail AND should be paid for at Express Mail postage rates. If a customer places a box on your counter wrapped in paper and it looks like a Medium Flat Rate Box and it's exactly the same size as a Medium Flat Rate Box when you set one next to it (walks like a duck, quacks like a duck, etc.), it's probably a duck or a Medium Flat Rate Box. You can ask the customer to prove to you that it is not a Medium Flat Rate box. When the Priority Large Flat Rate Box comes in with a "pregnant" bulge and/or when the flap of Priority Flat Rate Envelope barely wraps around the top of the contents and would never have stayed sealed

- if it weren't for the half a roll of tape holding it shut, it's no longer eligible for flat rate postage. Sometimes the mailer "wins" because the by weight and ZIP Code postage is less than the flat rate postage. But if it's coming from California and weighs in at a hefty rate, it's probably short on postage.
- 3) Ground Advantage Did you know that when the Ground Advantage classification replaced the First Class Parcel category, it took on the requirements of First Class Parcels? If the mailer desires the item to be tracked like a parcel, it has to actually be a parcel. If the tax prep documents in a 9" X 12" manilla envelope are important enough that it needs to be tracked, it has to either have some characteristic that makes it a parcel (rigid, variance in thickness of more than ¼", more than ¾" thick, etc.) or it needs to have Priority postage on it. A nicely folded shirt, scarf, or flag in a plastic envelope that is exactly the same size as the contents, is not a parcel just because it's not paper(s) in a large envelope. It's not rigid. It's not longer than 15" or taller than 12" or thicker than ¾". It's uniform in thickness. It's a large envelope!
- 4) Oversized/Overweight Did you know that the fee for oversized or overweight items found in the mail stream is now \$200? Amazon packaging sites have a specific set of box sizes to pack orders in and they also know what the size limitations are for mailing via the USPS. They have a box that is just under the 130" length plus girth limit. If you see them combining two boxes or altering the configuration of a box, it's worth your time to take the measurements and do the math to make sure that it is eligible to even be in the mail stream. After you've measured about 5 or 6 of the "bigs" on the pallet (and been disappointed that it's just under the limit), you quickly get a feel for what oversized looks like. At one point in time I had 4 items taking up space on my workroom floor for this very reason. That's an easy \$800!!

These are just a few things that are relatively easy to watch for. You don't have to weigh every parcel to double check the postage paid. You don't have to open and inspect every Media Mail package. And it really does not take long to become proficient in checking for these things all while scanning and sorting your parcels each day. It has almost become a competition in my office on who can find the item with the most postage due, but my clerks still rock the socks off of the 300 parcels per hour sorting goal. Some of the things that you find when you hone your eye to watching for these things will make you just plain shake your head and say "Nice try, but not on my watch!!" Now that I've planted the seed, happy hunting!!

This is totally off topic but remember —you ALWAYS deserve to be treated with dignity and respect. If you are not, chances are some of your "neighbors" aren't either! There is strength in numbers people!!! Don't "settle" and don't allow or tolerate someone treating you that way. Use your UPMA resources to stop that from happening!! One of those resources is the Tri-State Convention, sure to be a good time, a great networking opportunity, and a learning experience. Get your registrations in now to secure your spot!

## <u>Proposed Retiree By-Law Changes to be voted on at the</u> Retiree meeting at the 2025 Tri-State UPMA Chapter Convention.

#### **Current By-Laws**

Article IV Section 3----The election of officers shall be conducted at the annual Retiree Chapter Convention. Candidates to be elected to their respective offices must be present when their name is placed in the nomination. Members in good standing who are registered for the annual Chapter Convention and present when ballots are cast are eligible to vote in Retiree Chapter officer elections. Elections shall be by majority vote cast by ballot. In the event that no majority is reached, the two (2) candidates with the most votes will compete in a run-off election. Where no contest exists, election may be by acclamation.

#### Proposed Change

Article IV Section 3--- The election of officers shall be conducted at the annual Retiree Chapter Convention. Candidates to be elected to respective offices must be present when their name is placed in nomination placed in nomination or have a letter or email on file with the President and/or Secretary-Treasurer stating their intent to accept if their name is placed in nomination. Members in good standing who are registered for the annual Chapter Convention and present when ballots are cast are eligible to vote in Retiree Chapter officer elections. Elections shall be by majority vote cast by ballot. In the event that no majority is reached, the two (2) candidates with the most votes will compete in a run-off election. Where no contest exists, election may be by acclamation.

Remember, UPMA is here to support you. UPMA members are here to support each other. UPMA is here to keep you educated. UPMA is here to fight for you.



## Iowa UMPA VP Legislative / PAC

Hello Iowa UPMA,

I'm currently working on our office visit schedule for when we visit Capital Hill next month. It's been a bit difficult getting appointments with the Congress people and Senators due to them not being in session the week that we are to be there. But that's ok, because we will meet with their staff members that deal with postal issues. I'm also attempting to schedule a tour of the White House for everyone that will be attending the Legislative Summit this year. I was able to go on a White House tour last year while in DC. It was a tour I will not forget for quite some time. Last year I was also able to visit the House of Congress.

This year in DC, we will be thanking those who voted for the passing of HR82. I believe that was everyone except for Senator Chuck Grassley. We will discuss how important HR5995, MSPB rights for all EAS and modification to Title 39. I have a Legislative telecom the first Tuesday of every month to hear any updates

on what is important, and key topics we will talk about during our meetings with our lowa elected officials.

Doing some research on HR5995, it would be an amendment to Title 5. It would allow all federal employees with non-career time (that's you RCA's PSE's, TA's, CCA's) the ability to retire on time and buy back their non-career time. The topic of MSPB rights for all EAS is said as such, "an employee that doesn't supervise two or more employees doesn't have the right to representation if they are disciplined and possibly terminated." A lot of these employees would be district and HQ employees. I don't personally know of any EAS in the field that doesn't supervise at least two employees, Even Todd Oxley supervises two employees.

After two Legislative telecoms, they haven't touched on or mentioned what wording needs to be modified to Title 39, and how it's important to us at lowa UPMA. I expect they will talk more about Title 39 this next month. During training in DC, on Monday before we meet with the elected officials, they hand out a packet that touches on all topics that we will be discussing.

Each year at the Iowa UPMA State Convention, members can sign up for a chance to win a \$500 stipend to go to Legislative Summitt in DC. This year, Brian Lawson (Boone Postmaster) will be joining us in DC.

This year will be my second trip to DC. Oh my! It was quite an experience and very interesting seeing all the historic things in DC. I was so grateful to have all the other board members there with me last year. They had been there many times and knew exactly where to go and how to get there. DC can be an overwhelming place being from rural lowa. When a tractor drives by my office, my phone alerts me that traffic is heavier than expected!

I hope to see everyone at Tri-State Convention and hopefully some new faces this year as first timers.

Hello, All Fellow members:

We are in the recovery faze of the Christmas period and heading into the MMS. How'd you do?

I think we had a lot of shining moments. There are stories that are above and beyond what a normal mail delivery would need. Thank you all for the extra efforts you all made to deliver the mail/packages and to help your neighboring offices. There are many of you that did reach out and help others, not because you had to but because you wanted to. That tells me that you are committed in our main objective and our mission. Our mission has not changed and with the people of the Postal service we will not fail. I wanted to touch on a couple of items regarding the service needs.

We have had some serious weather issues and delays due to staffing, please make sure you are ready for those occurrences. It will happen to you. Have your network names and numbers for when this occurs. Do you have your SOPs in place for the non-deliverable mail? Here is the SOP for the weather delays or other non-delivery reasons that was sent out to us all, make sure you are following this standard.

#### HOW TO HANDLE NON-DELIVERIES Weather Delay No Access **Delivery Delay** WHY: Massive weather event WHEN: In office, roads impassable WHEN: As situations arise WHEN: At road that is impassable or box unreachable WHERE: At the office WHERE: In office Only REQUIRED: WHERE: At location outside REQUIRED: Permission from POOM Scan in the office ONLY Report in DCV as delayed REQUIRED: Scan in office ONLY 1. Discussion with supervisor Return package to the office with notice left mail

You will not get into trouble for reporting non-deliveries, you must report all non-deliveries to your MPOO as soon as you are aware of the potential for non-deliveries, as well to report those non-deliveries in both DCV and FDB-Operational Impact Reporting-Sitrep at the end of the day. To locate this, you would log into FDB, it is the very first link on the left side. If for some reason you have forgotten the process, reach out to your neighbor, or your MPOO. They will help guide you. There is understanding when you explain what your operation needs are.

NPA- yes, I know this is early to be talking about this. However, I feel we need to keep that a focus from the very beginning. I have had several calls regarding their work hours and SPLY. Check yours out occasionally. It will help you monitor what you need to focus on to improve your goal. I cannot stress enough the importance of LTATS. If you are carrying mail, are you remembering to transfer those into the craft of need?

Are you remembering to pay yourself for those hours that you are carrying, that caused you to work above your 8.5-hour day? Please remember that you are to report your carrying/case time hours into RADAR- other reports- EAS carrying mail report. This does not mean that if you worked 12 hours and carried 10 parcels that you get paid for it. There has been a misconception about how we are reimbursed for our carrying hours. If you work your Nonscheduled day to carry mail and you work 8 total hours or more, you may fill out a 3971 for a relief day worked in the comments write- Do not charge leave per ELM 519.733 - and basically bank a day in the future. You must send this to your MPOO so that they are aware that you worked your SDO and want

to take another date. Make sure that we are utilizing this with the integrity we use with all our reporting tools

If you have a clerk carrying mail, are you making sure that those hours are transferred to that craft you are covering? You may have a rural or city carrier assisting in the office. Make sure you are transferring that time. We have all been really short staffed— between the lock out of hiring, contractual staffing/hiring, the weather or the flu. It has taken it's toll on all of us. There are no people to borrow. Again, it is our mission to service the American public to the best of our ability, safely and efficiently and sometimes we need to look outside of the box. If you need someone to help you look at alternatives, pick up the phone and get someone else's opinion. Make sure that you explain what your issues are to the fullest. Some of you have more going on than others.

Please don't forget that we have a ton of individuals that would be great resources for you, whether you are new into management or not. Whether you are on a detail, or 204b or higher level, or want to reach a higher potential level— reach out. Put your hand up. We all could use some help, and we all have assets within ourselves that could help someone else with their needs or goals. Thank you all for your guidance to me and to others within the USPS community.

Here is the absolute latest info on WEP/GPO. Please remember that is very fluid and changes and updates are given almost daily. For the latest, please make sure that you are signed up for UPMA Gold by contacting Linda Carter @ upmagold@gmail.com.

SOCIAL SECURITY UPDATE: - Dave Cook, UPMAR Legislative Chairman Starting the week of February 24, 2025, SSA is beginning to pay retroactive benefits and will increase monthly benefit payments to people whose benefits have been affected by the WEP and GPO

If a beneficiary is due retroactive benefits as a result of the Act, they will receive a one-time retroactive payment, deposited into the bank account SSA has on file, by the end of March. This retroactive payment will cover the increase in their benefit amount back to January 2024, the month when WEP and GPO no longer apply.

Social Security benefits are paid one month behind. Most affected beneficiaries will begin receiving their new monthly benefit amount in April 2025 (for their March 2025 benefit). Anyone whose monthly benefit is adjusted, or who will get a retroactive payment, will receive a mailed notice from Social Security explaining the benefit change or retroactive payment.

NOTE: A beneficiary may receive two mailed notices, the first when WEP or GPO is removed from their record, and a second when their monthly benefit amount is adjusted for their new monthly payment amount. They may receive the retroactive payment before receiving the mailed notice.

We have been able to expedite payments due to the use of automation. For the many complex cases that cannot be processed automatically, additional time is required to manually update the records and pay both retroactive benefits and the new benefits amount.

We urge beneficiaries to wait until April to inquire about the status of their retroactive payment, since these payments will process incrementally throughout March.

Beneficiaries should also wait until after receiving their April payment before contacting SSA to ask about their monthly benefit amount because the new amount will not be reflected until April for their March payment.

Also, plans are coming together for our IA/NE/SD Tristate Convention in Sioux Falls next month! My goal is to have an outing planned for any retirees that will be there on Friday. While the final agenda has yet to be made available, we will plan to meet after lunch for an outing. If interested, please let me know so you can be included!

As always, please forward any information you may have on PM/Supervisors that have passed in the past year so I may be sure to include them in our Memorial Service.
