رجل أعمال في دبي يندد بحملة لابورتا لبرشلونة بتهمة "خداعه" بمليون يورو

تدعى الشكوى أنها سددت دفعتين نقديتين بين أكتوبر 2020 ويناير 2021

قدم أحمد خوري ، رئيس مجلس إدارة شركة AHK Holding LLC ونائب الرئيس التنفيذي لشركة I&Gm ، لمجموعة طيران الإمارات في دبي ، شكوى ضد رجل أعمال إسباني آخر ، رايكو جي كابريرا ، بتهمة احتيال مزعوم بقيمة مليون يورو. يؤكد خوري في شكواه، التي تمكنت أوكدياريو من الوصول إليها، أن هذه الأموال تم تسليمها «كدعم» للحملة الرئاسية لجوان لابورتا، الرئيس الحالي لنادي برشلونة في أكتوبر 2020 ويناير 2021.

استنكر رجل الأعمال الخوري لشرطة دبي أنه سلم نقدا 4،435،000 درهم إماراتي ، أي ما يزيد قليلا عن 1،000،000 يورو في البورصة. كان من الممكن دفع هذه الأموال على دفعتين في 28 أكتوبر 2020 و 12 يناير 2021 على التوالى. وفقا للشكوى، عمل غارسيا كابريرا كوسيط لنادي برشلونة في دبي وتم استلام

المدفوعات بعد أن ذهب لابورتا شخصيا إلى هذا البلد الشرق أوسطي بحثا عن تمويل لحملته. في الوقت الحالي، قدم خوري شكوى فقط في دبي ضد رايكو جي كابريرا، على الرغم من أنه لا يستبعد القيام بذلك ضد الرئيس الحالى لنادي برشلونة إذا لم يعيدوا الأموال.

كان دعم خوري مشروطا بأن يصبح لابورتا رئيسا لنادي برشلونة. حدث ذلك في مارس 2021، لكن رجل الأعمال العربي انتظر حتى 14 فبراير 2022 لإبلاغ مركز شرطة البرشاء في دبي بالحقائق بعد عدم تلقيه ردا على طلباته المتكررة لاسترداد استثماره، وهي شكوى تمكنت أوكدياريو الأن من الوصول إليها والتي تم جمعها وتوقيعها من قبل العقيد ماجد سلطان حمد سعيد السويدي.

يجب أن نعود إلى صيف عام 2020 عندما قررت جوان لابورتا الترشح لانتخابات رئاسة نادي برشلونة وكانت تبحث عن تمويل للحملة الانتخابية التي ستجري خلال شتاء ذلك العام، على الرغم من إجراء الانتخابات أخيرا في مارس 2021. إنه عندما دخل رايكو غارسيا كابريرا، لاعب الفريق الثاني السابق لبرشلونة ورجل الأعمال في دبي وجزر الكناري، إلى المشهد. رايكو جي كابريرا هو المسؤول الوحيد لشركة لشركة Sport Solutions SL ، وهي شركة مقرها في تينيريفي ، مكرسة ل "إدارة وإدارة العقارات" ، ولكن مع وجود قوي في دبي وفي جميع أنحاء الشرق الأوسط. كابريرا هو لاعب كرة قدم سابق في تينيريفي لعب لبرشلونة ب بين عامي 2005 و 2006 وبعد التوقيع مع ليدز يونايتد ب أنهى مسيرته في موستوليس وتوليدو. بعد تقاعده أصبح وكيلا للفيفا ، وكرس نفسه لعالم الأعمال وأنشأ أساطير برشلونة ، وهو مشروع تم فيه تنظيم مباريات دولية مع لاعبي كرة القدم المخضرمين المتقاعدين في نادي برشلونة ضد قدامي المحاربين في الفرق الدولية المهمة الأخرى.

النقطة المهمة هي أن شركة رايكو كانت ستقدم مشروعا إلى أحمد الخوري ، رئيس شركة البناء والخدمات AHK Holding ونائب رئيس طيران الإمارات للعمليات التجارية في غرب هوس والمحيط الهندي ، بالإضافة إلى رجل مرتبط بكرة القدم في دبي لأنه سبق له أن ترأس ناديا لكرة القدم في ذلك البلد. تم ترتيب الموعد في 12 سبتمبر 2020 في الطابق 53 من برج سبين ، المقر الرئيسي لشركة AHK القابضة ، في دبي ، بين لابورتا وكابريرا وخوري نفسه. في 11 سبتمبر سافروا من برشلونة إلى دبي جوان لابورتا، خيسوس أنغوي (حارس المرمى السابق وعضو طاقمه) ومانانا جيوردازه، سكرتير الثقة الكاملة لجوان لابورتا. التقى الثلاثة ورايكو غارسيا مع أحمد الخوري في 12 وعادوا إلى برشلونة في 13 سبتمبر.

يتكون اقتراح فريق لابورتا، الذي وصلت إليه OKDIARIO، من عرض تقديمي يظهر فيه لابورتا على أنه «أنجح رئيس لنادي برشلونة في العصر الحديث، (...) مع 12 لقبا لكرة القدم و 42 لقبا في رياضات أخرى (كرة السلة وكرة اليد والهوكي)". هذا العرض من نادي برشلونة لرجل الأعمال العربي، والذي لن يصبح ساريا إلا إذا فاز لابورتا في الانتخابات، يتكون من ثلاث نقاط عامة من 2021 إلى 2027: أن يصبح نوعا من السفير التجاري لبرشلونة، لفتح مكتب مخصص للرعاية والترويج حصريا في منطقة الشرق الأوسط وشمال إفريقيا (الشرق الأوسط وشمال إفريقيا) مع إمكانية فتح متاجر وعقد مباراة ودية لكرة القدم Covid للفريق الأول وفرق (الشرق الأوسط وشمال إفريقيا) مع إمكانية فتح متاجر وعقد مباراة ودية لكرة القدم للمتثمار ات رجل الأعمال العربي وكان الاتفاق برمته مشروطا بفوز لابورتا في الانتخابات. إذا لم يفز لابورتا برئاسة برشلونة الخوري لكان قد خسر كل الاستثمار. أجريت الانتخابات التي كان من المقرر إجراؤها في يناير 2021 أخيرا في مارس 2021 وفازت جوان لابورتا.

في وقت سابق ، في أكتوبر 2020 ويناير 2021 ، قام أحمد الخوري بدفعتين نقديتين ، الأولى إلى Rayco في 28 أكتوبر بمبلغ 2,200,000 در هم والثانية في 12 يناير 2021 إلى شخص يتمتع بثقة تامة من Rayco García الذي استلمه نيابة عنه بمبلغ 2,235,000 در هم ، في المجموع Rayco García در هم. و لإثبات هذه الشكوى، قدم رجل الأعمال العربي شكواه مع إيصالين موقعين. الأول من قبل رايكو والثاني

من قبل هذا الشخص الموثوق به ، و هو لاعب كرة قدم سابق معروف في ريال مدريد كان دوليا حتى مع فريق كرة القدم الإسباتي ولديه بطاقة إقامة في الإمارات العربية المتحدة. نتج عن المبلغ الإجمالي سعر صرف الدر هم أنذاك 1,069,785 يورو.



رايكو جارسيا

في ديسمبر 2021 ، لعب نادي برشلونة مباراة ودية دولية ضد بوكا جونيورز في ذكرى الراحل دييغو أرماندو مارادونا. أدرك رجل الأعمال الخوري آنذاك أن برشلونة لن يواجه الاتفاق الذي اتفق عليه مع رايكو جي كابريرا وبدأ في تحريك الآلية القانونية في دبي من خلال محاميه ، مكتب المحاماة الطاهر والصابري للمحاماة. في 10 يناير 2022، ادعى الخوري لأول مرة إعادة استثماره من خلال رسالة أرسلت إلى بويرتو دي لا كروز، في تينيريفي، حيث يمتلك غارسيا كابريرا شركة. ويذكر الاتفاقات الموقعة مع ضمان أن لابورتا كان رئيسا لبرشلونة وخرقها.

في 23 يناير 2022 ، يطالبون بالمال من Rayco G. Cabrera مرة أخرى. في 14 فبراير 2022 ، قدمت AHK Holding of Al Khoory الشكوى في مركز شرطة البرشاء في دبي ، والتي تم جمعها وتوقيعها من قبل العقيد ماجد سلطان حامد ساجد السويدي. ويوضح أن رايكو جي كابريرا «وعد بالدفع (إعادة الأموال) في يناير 2022، لكن ذلك لم يحدث أبدا».

وطالب محامو الخوري في دبي مرة أخرى بالدفع في 23 فبراير/شباط. وفقا لهذا الادعاء، كانت الأموال المقدمة بمثابة «دعم» لترشيح لابورتا. تم إضفاء الطابع الرسمي على تلك الوثيقة في الساعة 4:00 مساء. في ذلك الاجتماع الذي، وفقا للدقائق التي تلت الشكوى، كانوا بالإضافة إلى الخوري، المدير العام لشركة AHK القابضة، سوريش بابو، المحامي محمد علي أحمد العور، الذي عمل كشاهد ورايكو غارسيا نفسه، الذي شوهد وهو يدخل برج أسبين، مقر مجموعة AHK، في بعض الصور التي تمكنت OKDIARIO من الوصول إليها. إن حضور محامي دبي في الاجتماع أمر مهم لأنه يعمل ككاتب عدل للاجتماع ، على النحو الذي يسمح به قانون دبي. في ذلك الاجتماع، تقرر أن يعيد رايكو غارسيا 500,000 يورو قبل 24 يناير 2022 الساعة 5:00 مساء و 569,785 يورو أخرى قبل 28 فبراير 2022. لم يوقع رايكو غارسيا على محضر ذلك الاجتماع.

مر الوقت وسقطت متطلبات الخوري لنادي برشلونة لحضور الاتفاقية من خلال رايكو غارسيا كابريرا أو بالنسبة له لإعادة الأموال في فراغ.

وفي الوقت نفسه، دعا نادي برشلونة أحمد خوري إلى مباراة برشلونة ضد أتلتيكو مدريد في 6 فبراير 2022. دعا البريد الإلكتروني الذي أرسله فيران باستور، من إدارة العلاقات المؤسسية والبروتوكول في نادي برشلونة، خوري لحضور صندوق برشلونة الرئاسي واجتماع في 7 فبراير 2022 في الساعة الواحدة والنصف بعد الظهر. لم يحضر رجل الأعمال.

في 14 مارس 2022، ذهبت شركة محاماة إسبانية في برشلونة برسالة إلى منزل رايكو غارسيا كابريرا للمطالبة بسداد الديون مرة أخرى. دون جدوي.

رايكو يدافع عن نفسه

أكد رايكو جي كابريرا في تصريحات ل OKDIARIO أن كل ما تم استنكاره هو كذبة. "لا أعرف الخوري على الإطلاق، ولم يسبق لي أن تعاملت معه، وليس لدي أي علاقة بحملة لابورتا ولم أشارك في حملة برشلونة

هذه". حتى أنه يقول إن «لدي شكوى مقدمة ضد شخصين من الجنسية الإسبانية لمحاولتهما ابتزازي وحتى حكم نوفمبر 2022 يوضح أنني بريء في هذه القضية برمتها»، يوضح غارسيا كابريرا.

يعترف رايكو غارسيا بأنه يعرف جوان لابورتا وأنه قدمه إلى أحمد الخوري، على الرغم من أن روايته تختلف عن تلك التي تم جمعها في الشكاوى: «قابلت لابورتا في مركز تسوق وتذكرت أن الخوري من محبي برشلونة، لذلك عرضت تقديمهم وخلال ذلك الاجتماع التقطنا صورة معا. كان هناك حديث عن تنظيم مباراة كرة قدم في المستقبل ولكن لم يتم توقيع أو الاتفاق على أي شيء»، يقول غارسيا ل OKDIARIO. عندما طلبت منه هذه الصحيفة أدلة وثائقية على كل ما ادعاه، قال رايكو غارسيا: «يجب أن أريكم ذلك شخصيا و غدا (الاثنين) أنا في مدريد لتراه». كما عرض OKDIARIO على رئيس نادي برشلونة، جوان لابورتا، إمكانية التعليق على هذه المعلومات، لكنه لم يستجب لطلبنا.

A Dubai businessman denounces Laporta's campaign to Barça for "cheating" him of one million euros

The complaint claims to have made two cash payments between October 2020 and January 2021

Ahmed Khoory, chairman of AHK Holding LLC and executive vice president of Gm&I, of the Emirates Airlines group in Dubai, has filed a complaint against another Spanish <u>businessman</u>, Rayco G. Cabrera, for an alleged one million euro scam. Khoory assures in his complaint, to which OKDIARIO has had access, that this money was delivered as "support" to the presidential campaign of <u>Joan Laporta</u>, current president of Barcelona F.C. in October 2020 and January 2021. The businessman Al Khoory has denounced to the Dubai police that **he delivered** in cash 4,435,000 dirhams of the <u>United Arab Emirates (UAE)</u>, just over

1,000,000 euros at the exchange. That money would have been made in two payments on October 28, 2020 and January 12, 2021, respectively. According to the complaint, García Cabrera acted as an intermediary for FC Barcelona in Dubai and the payments were received after Laporta went in person to this Middle Eastern country allegedly in search of financing for his campaign. At the moment, Khoory has only filed a complaint in Dubai against Rayco G. Cabrera, although he does not rule out doing so against the current president of FC Barcelona if they do not return the money.

Khoory's support was contingent on Laporta becoming president of FC Barcelona. That happened in March 2021, but the Arab businessman waited until February 14, 2022 to report the facts to the Al Barsha Police Station in Dubai after not receiving a response to his repeated requests to recover his investment, a complaint to which OKDIARIO now had access and which is collected and signed by Colonel Majed Sultan Hamad Saced Al Suwaidi. We must go back to the summer of 2020 when Joan Laporta decided to stand for election to the presidency of FC Barcelona and was looking for financing for the electoral campaign that would take place during the winter of that year, although the elections were finally held in March 2021. It is when Rayco García Cabrera, former Barcelona second team player and businessman in Dubai and the Canary Islands, would have entered the scene. Rayco G. Cabrera is the sole administrator of RG Consultant & Sport Solutions SL, a company based in Tenerife, dedicated to the "management and administration of real estate", but with a strong presence in Dubai and throughout the Middle East. Cabrera is a former Tenerife footballer who played for Barcelona B between 2005 and 2006 and after signing for Leeds United B ended his career at Móstoles and Toledo. After retiring he became a FIFA agent, dedicated himself to the business world and set up the Barcelona Legends, a project in which international matches were organized with retired veteran footballers of FC Barcelona against veterans of other important international teams.

The point is that Rayco's company would have presented a project to Ahmed Al Khoory, president of the construction and service company AHK Holding and vice president of Emirates Airlines for commercial operations in Western Thus and the Indian Ocean, as well as a man linked to football in Dubai for having previously chaired a football club in that country. The appointment was arranged on September 12, 2020 on the 53rd floor of the Spin Tower, headquarters of AHK Holding, in Dubai, between Laporta, Cabrera and Khory himself. On September 11 they flew from Barcelona to Dubai Joan Laporta, Jesús Angoy (former goalkeeper and member of his staff) and Manana Giordadze,

secretary of total confidence of Joan Laporta. The three and Rayco García met Ahmed Al Khoory on the 12th and returned to Barcelona on September 13. The proposal of Laporta's team, to which OKDIARIO has accessed, consists of a presentation where Laporta appears as the "most successful president of FC Barcelona in modern times, (...) with 12 football titles and 42 titles in other sports (basketball, handball and hockey)". This offer from FC Barcelona to the Arab businessman, which would only become effective if Laporta won the elections, consisted of three general points from 2021 to 2027:to become a kind of commercial ambassador for Barça, to open an office dedicated to sponsorship and merchandising exclusively in the MENA area (Middle East and North Africa) with the possibility of opening stores and holding a friendly football match post Covid of the first team and other U21 teams, "legends", etc ... The friendly match was seen as a way to recover part of the Arab businessman's investment and the whole agreement was contingent on Laporta winning the elections. If Laporta did not win the presidency of Barça Al Khoory would have lost all the investment. The elections that were scheduled for January 2021 were finally held in March 2021 and Joan Laporta won.

Earlier, in October 2020 and January 2021, Ahmed Al Khoory made **two cash payments**, the first to Rayco G. Cabrera on October 28 in the amount of DH 2,200,000 and the second on January 12, 2021 to a person of total confidence of Rayco García who received him on his behalf for DH 2,235,000, in total 4,435,000 dirhams. To prove this complaint, the Arab businessman provided his complaint with two signed receipts. The first by Rayco and the second by this trusted person, who is a well-known former Real Madrid footballer who was even**international with the Spanish football team** and has a residence card in the UAE. The total sum resulted in the exchange rate of the dirham of then 1,069,785 euros.



In December 2021 FC Barcelona played an international friendly match against Boca Juniors in memory of the late Diego Armando Maradona. Businessman Al Khoory understood then that Barça was not going to face the agreement he had agreed with Rayco G. Cabrera and began to move the Dubai legal machinery through his lawyers, the law firm Al-Taher & Al Saberi Advocates.

On January 10, 2022, Al Khoory claimed for the first time the return of his investment through a letter sent to Puerto de la Cruz, in Tenerife, where García Cabrera owns a company. It mentions the agreements signed with the guarantee that Laporta was president of Barcelona and the breach of them.

On January 23, 2022, they claim the money from Rayco G. Cabrera again. On February 14, 2022, the AHK Holding of Al Khoory filed the complaint at Al Barsha Police Station in Dubai, which is collected and signed by Colonel Majed Sultan Hamed Saced Al Suwaidi. It explains that Rayco G. Cabrera "promised the payment (return of the money) in January 2022, but it never happened." Al Khoory's Dubai lawyers again demanded payment on 23 February. According to this claim, the money given was as "support" for Laporta's candidacy. That document was formalized at 4:00 p.m. In that meeting in which, according to the minutes after the complaint, were in addition to Al Khoory, the general director of AHK Holding, Suresh Babu, the lawyer Mohammad Ali Ahmad Al Awar, who acted as a witness and Rayco García himself, who is seen entering the Aspin tower, headquarters of the AHK group, in some images to which OKDIARIO has had access. The presence of the Dubai lawyer at the meeting is of

interest because he acts as a notary of the meeting, as allowed by Dubai law. At that meeting it was decided that Rayco García would return 500,000 euros before January 24, 2022 at 5:00 p.m. and another **569,785 euros** before February 28, 2022. Rayco García did not sign the minutes of that meeting.

Time went by and Al Khoory's requirements for FC Barcelona to attend to the agreement through Rayco García Cabrera or for him to return the money fell into vacuum.

Meanwhile, FC Barcelona invited Ahmed Khoory to Barça's match against Atlético de Madrid on February 6, 2022. **The email sent by Ferrán Pastor, from the Department of Institutional Relations and Protocol of FC Barcelona**, invited Khoory to attend the Barça presidential box and a meeting on February 7, 2022 at half past one in the afternoon. The businessman did not attend.

On March 14, 2022, a Spanish law firm in Barcelona went by letter to the home of Rayco García Cabrera to demand payment of the debt again. Unsuccessfully.

Rayco defends himself

Rayco G. Cabrera has assured in statements to OKDIARIO that everything denounced is a lie. "I don't know Al Khoory at all, nor have I ever had business with him, nor do I have anything to do with Laporta's campaign nor have I ever been involved in this Barca campaign." He even says that "I have a complaint filed against two people of Spanish nationality for trying to blackmail me and even a sentence of November 2022 that makes it clear that I am innocent in this whole issue," explains García Cabrera.

When this newspaper asked him for documentary evidence of everything he claimed, Rayco García said that "I have to show it to you in person and tomorrow (Monday) I am in Madrid for you to see."

OKDIARIO also offered the president of FC Barcelona, Joan Laporta, the possibility of commenting on this information, but he has not responded to our request.
