## ARTICLE 2: AIM / OBJECTIVE

## **ARTICLE 6: MEMBERS CONTRIBUTIONS**

Active members are those who are committed to pay an annual yearly sum of UGX 5,000 (\$1) as a contribution.

Honorary members are those who have rendered outstanding services to the association.

Hence, they are exempted from contributions.

Benefactor members are people who pay a membership fee of \$500 or more and will be offering an annual contribution of \$20 fixed by the general assembly.

The contribution fee may be revised during the general assembly once a year and may not be lower than the basic contribution stated above.

## **ARTICLE 7: EXCUSIONS / TERMINATIONS**

The membership is lost by:

- a. The resignation which can be made at any time by simple letter submitted to the C.E.O or sent through Email without reimbursement of the ongoing contribution.
- b. The death
- c. The termination pronounced by the board of directors for non-payment of the contribution or for a very serious reason. The individual concerned shall be invited through recommendation letter to provide explanations whether physically to the office or in writing.

## **ARTICLE 9: RESOURCES**

The association's resources include:

1. The membership entry fee and contributions.
2. Subsidies from the letter , the departments and municipalities
3. All the resources authorized by the laws and regulations in vigor.

## **ARTICLE 10: ORDINARY GENERAL ASSEMBLY**

The ordinary general assembly includes all the members of the association in spite of their positions.

They meet every year in September.

At least fifteen days before the fixed date, the members of the association are convened by the secretaries for a good preparation of the upcoming assembly whereby they schedule an agenda for the assembly.

The president (**C.E.O**) assisted by the members of the council lead the assembly and explains the moral situation or activities of the association.

The treasurer reports on her management and submits the annual accounts (balance sheet, income statement and appendix) for the approval of the assembly.

The general assembly fixes the amount of the annual contributions and the membership fee to be paid by different categories of members.

Only items on the agenda can be discussed about.

Decisions are taken by majority vote of members present or represented.

It is preceded after all the items discussed on the agenda are done.

### **ARTICLE 11. EXTRAORDINARY GENERAL ASSEMBLY**

If necessary or at the request of a half plus one of the registered members, the president ( C.E.O) may convene an extraordinary meeting according to the procedures prepared for this status and only for the modification of the status , dissolution or for acts relating to buildings.

The convening procedures are the same as for the ordinary general meeting.

### **ARTICLE 12: BOARD OF DIRECTORS**

For the start of the association, there will not be a board of directors, depending on the evolution and the importance that the association would take.

The board of directors will be defined in an extraordinary general assembly to define the modalities.

## **ARTICLE 15: INTERNAL REGULATIONS**

Regulations of procedure are drawn up by the board of directors, which has them approved by the general meeting.

## **ARTICLE 16: DISSOLUTION**

In case of dissolution pronounced according to the procedures stated in article 12, one or more liquidators are appointed and the net assets; if any devolved to a non-profit organization (or to an association with similar purposes) in accordance with the decisions of the extraordinary general meeting which decides on the dissolution.

The net assets could not be devolved to a member of the association, even partially, except recovery of a contribution.

## **ARTICLE 17: FREEDOM**

1. The contributions of members
2. Buildings intended for the administration of the association and the meeting of its members.
3. Buildings strictly necessary for the accomplishment of its intended purpose.

The report and the annual accounts as defined in article 11(including those of the local communities) are addressed each year to the prefects of the department.

Thus, the association undertakes to present its registered and accounting documents on any requisition of the administrative authorities concerning the freedom that they are allowed to receive and allow its
