Why do we give?

“The earth is the Lord’s and everything in it” Psalm 24:1

When we give to God’s work, we are giving back just a small portion of what God has already given us.

All good gifts come from heaven above and God has blessed us with so many things, so when we give regularly to God’s work, we are putting him in his rightful place over our finances. This is an important part of our Christian discipleship.

Anyone that visits the Church can give regularly or give one off donations. Scripture encourages us to give regularly from the first portion of what we have, willingly, generously and with a joyful heart.

In this Church we aim to follow the following principles in managing our money:

- To give a percentage of our income to Home Mission (the funds of the Baptist Union of Great Britain) and to BMS World Mission
- To give a further percentage of our income to support other external charities – decisions about this are made by the members (with Leaders’ proposals)

All of our money is used to advance the Christian faith. As well as tithing (10%) of our income to the above charities (although it is normally more), we also have many payments that are practical and are associated with the organisation and maintenance of the Church. Our principle expenses include:

- Paying our Pastor & Cleaner
- Buying materials to be used in our young people’s work
- Paying gas, electricity and water bills
- Maintaining the Church grounds and buildings
- Reimbursing reasonable expenses to those who volunteer for the Church

“Each of you should give what you have decided in your heart to give, not reluctantly or under compulsion, for god loves a cheerful giver” 2 Corinthians 9:7

How can I give?

You can set up a standing order or online payment using these details:

When you have set this up, you can change the frequency and amount at any time, but it also helps you make your offering and not forget as it's automatic

Using this system helps us budget for the year and set our giving levels as a church.

Alternatively

You can give on a Sunday morning with a cheque made payable to Blisworth Baptist Church, or a cash donation. This allows you to give intentionally; consciously offering your gift as a part of your Sunday worship

Gift Aid

Gift aid allows charities like us to claim back 25% from the government on the tax you have already paid on your earnings.

This means that for every £1 you give BBC, we claim an extra 25p from the government as long as you are a UK taxpayer. A £10 gift becomes £12.50; a £100 gift becomes £125!

What Next?

All you need to do is fill in the gift aid form on the reverse of this sheet and pass on to the church treasurer or any of the leadership team.

If your circumstances change and perhaps you stop paying tax or move house, you need to let us know.
