### Tuition fees

The tuition fees will be paid by DAAD directly to the host institution. Study programme: PhD In-Region/ Academic year of study: 2nd year.

The university fees amounting to 800,000.00 XOF will be transferred to the institution. The stipend and research allowance will be disbursed to your personal bank account. The scholarship can be extended up to 3 years upon a receipt of an application for extension.

### Health insurance

Health insurance coverage (standard tariff of maximum 75 EUR (or equivalent in local currency) per month) will be reimbursed after receipt of an invoice. If possible, the invoice should be submitted by 31.10. of each year so that it can still be paid out in the same year, otherwise the invoice may only be reimbursed in the following year. Please also note that the invoice should be submitted to the DAAD as soon as possible after receipt. In the case of very delayed submissions, it must be checked individually whether a payment/reimbursement is still possible.
