One-Time Password (OTP) is a password that is valid for only one login session or transaction on a computer system or any other digital device. This is done to avoid any malpractices which can often lead to adverse consequences. Nowadays OTP thefts have become common in many places, yet people still don't understand that the OTPs should not be shared as the consequences will be too painful for the person. Recently criminals have found a new way to do OTP thefts by requesting the bank to change the phone number linked to your bank account. A criminal can always find ways on how the crime can be done. For example: the criminal can request a change in the phone number given in the bank and easily invade your privacy

OTP thefts are at its highest in the city of Bangalore which is also the IT hub of India. The cases of OTP thefts are increasing rapidly in the recent years. Privacy is something which everyone respects and something all individuals enjoy. But do we get privacy online? That is the question that lingers in the minds of most people. Invasion of privacy is a serious issue concerning the internet. Lack of privacy policies and employee monitoring also threaten security.

Another problem is the ability of 'cookies' to watch and keep track of the computer user. Cookies are electronic snapshots transmitted between a web server and the browser software and then stored on the client machine. Cookies enable a web page to adjust its display or other configuration options for users, but they can also be used to trace exactly what documents a user access on the site. They can develop a user profile, and many feel this capability is an invasion of privacy. Cookies can operate quietly in the background and collect information about an internet user without his or her knowledge. The next time you get an OTP, think a few times before you share it with someone else. Ensure that the sites you click on are legal and authenticated. This way you can avoid falling into these scams. OTP thefts and privacy invasions have become a common issue in India. It is our responsibility to protect our own systems from such activities.

**SURVEILLANCE** - The New Normality?

It is argued that modern-day capitalist nations have become 'surveillance societies', where surveillance associated activities are embedded in the core of production, cooperation and societal order. But what does staying in a surveillance society imply?

Surveillance societies are societies that function, in part, due to the extensive recording, storage and evaluation of data on people and corporations in a society. The routine collection of data about individuals with the specific purpose of governing, regulating, managing or influencing what they do in the future. Retail loyalty programmes, website cookies, national identification schemes and routine health screening all qualify as forms of surveillance. Thinking about society using surveillance permits us to mount an ethical and social critique of the data processing practices that are a part of the way the society is formed, ruled and managed. It permits us to question its impact on the social fabric: on discrimination, trust, accountability, transparency and social justice. Moreover, it allows us to interact in debates with regulators, organisations and reporters about the outcomes of their surveillance. So, in place of considering surveillance as a single all-knowing oppressive force as George Orwell depicts in the novel 1984- we prefer to think of it as something which is woven into everyday life and is more complex and multi-layered. In this hi-tech world of spies is but a tiny aspect of the surveillance society. During the different activities in which we engage during a single day we interact with surveillance at different times .For example, employers collect performance information of the employees. Managers use that information to let

them know how they are performing in their jobs and how they can improve in future.

As clients, our transactions are monitored through financial establishments to detect fraud and our choices are monitored by loyalty programmes to allow future marketing campaigns to target us. As mobile phone users, our actions and communications may be tracked for use by the emergency services. Some people use area-based services, along with GPS, to find their way in new places. Surveillance is something that may confer access, entitlement and advantage in addition to something that is dangerous, oppressive and discriminatory. Individuals now actively manage their very own profiles knowing they will be able to customise and improve their services if they do so. Wherever we discover surveillance it has a tendency to carry out the same function, it allows organisations and governments to control resources, activities and the population. It works via interconnected chains of organisations and infrastructures, aligned to different organisational strategies and purposes. How is surveillance being performed in call centres, where every minute of the day is monitored and recorded. It can be compared to a military setting where armies use unmanned aerial motors to search for the enemy. If surveillance is an ordinary component of the management and governance of present-day life, then what is wrong with it? Using surveillance to obtain one's aims, regardless of how grand or minuscule, bestows exquisite power. To label a phenomenon as 'surveillance' entails acknowledging that information processing which comes as a part of governance or control in no way takes place on a level playing field.

The risk is that surveillance power will become ubiquitous: embedded within the systems, the structures and interests they represent. Its application becomes taken for granted and its outcomes move unnoticed. As data travels silently throughout global boundaries, among countries, states and within transnational corporations, the effect of surveillance will become even harder to identify, alter and debate. For us, it's far more crucial that this strength, based on the oversight of activities and of personal information, is wielded fairly, responsibly, and with due admiration to human rights, civil liberties and the law. Wielding surveillance power could have very undesirable effects- global leaders appeal to some supposed greater good such as 'the war on terror to justify unusual surveillance processes on ordinary citizens. Sifting through consumer information to create a worthwhile consumer manner that certain groups obtain unique treatment based on the capacity to pay while the others deemed 'less valuable' falls aside. Surveillance fosters suspicion in individuals who wield it. It makes a speciality of correcting the negative and it offers a message to people who are watchingthat they're now no longer to be dependent on to act in the proper manner.

## Building Mental Health




## DANCE THE THEME



rolls have gained so much of our love that we engage mindlessly in enjoying them, unbothered by how sadistic and undermining some of them may be. The right to freedom of speech and privacy applies to everyone, regardless of one's profession or identity, but in a few cases, it can't be completely exercised, especially for celebrities. Celebrities are considered public figures and are under constant surveillance. Freedom of speech has been regarded as a crucial and defining feature of liberal democracy but that doesn't inescapably save freedom from consequences. Trolls, memes and such satirical and skeptical commentary can be used in the most Promethean and laughable ways, capable of taking weary and dogtired minds away from daily drudgery. They can bring new perceptions and refined angles to look at conventions and more. Many popular Instagram and Twitter pages showcase multitudes of such satirical pages, where quick-witted content is constructive. Many memes are weirdly and surprisingly relatable to our daily lives so much that we share them far and wide. This relatability and feeling of belongingness are what nourish them so much. Undeniably, such feel-good posts are worth all the love and hype users give them.

With privileges like anonymity, uncontrollability and lack of real-time communication, trolls feed on the attention and discussion that breeds on them and one can even say that it has changed the personality of the internet as such. Timothy Garton Ash argues that 'free speech has never meant unlimited speech – everyone spouting whatever comes into his or her head, global logorrhea'. A troll is someone who writes deliberately controversial comments online,



with the aim of provoking a reaction or manipulating others' perception, often targeting celebrities, probably thinking they'll never come across it. However, often, those celebrities do see the mean comments but are peculiarly hesitant or reticent to deal with trolls, due to the belief that calling it out will only escalate the conflict and exacerbate the problem,. In a way, it is actually leads to the suppression of one's freedom of speech. All the way from celebrity and mob popularity to downright personal vengeance, trolls and hate posts can demean and crush the victims far worse than we can imagine. Trolls can often create a hostile online and sometimes offline environment for their victims. The psychological impacts of trolling include depression and anxiety. Being 'targeted' has become a nightmare for all known and influential social media users. The targets are often left devastated and ultimately, many are led into questioning their art and metier. For example, Australian television host Charlotte Dawson committed suicide, one major reason owing to the brutality of trolling. An individual's decision to take their own life cannot be attributed to a single factor, but the online abuse that Dawson faced probably didn't

help her condition. Furthermore, the social media platform itself gains an unpleasant name and notoriety, all thanks to the trollers and memesters. Online platforms have been influential in dissolving the traditional boundary between the public and private spheres. With the rise of social media, the distinction between what one would say and do in private and in public has become thinner. The benefits of this development are expressed in the mission statements of various prominent social media platforms, for example, YouTube ('Our mission is to give everyone a voice and show them the world'), Twitter ('Our mission: Give everyone the power to create and share ideas and information instantly, without barriers), and Facebook ('Facebook's mission is to give people the power to build community and bring the world closer together). Social media platforms like these have proved important in democratizing access to information and the right to self-expression around the world. However, the expansion of the public sphere into the realms of formerly private opinion has also given rise to an increased potential for the clash of beliefs and uncensored expression which can hurt the sentiments of others. Also being a celebrity doesn't imply that their lives should always be public, they are normal people, who may want to keep a few things private but aren't given the private space to. Back in 2014, Apple's popular iCloud service went through a security breach through which Actress Jennifer Lawrence,

They also do consultations for governments, UNICEF India, law enforcement and commissions. Here they share with us their thoughts about online safety and accountability. What does the organisation basically offer and how do the public access your service? would help in keeping individuals safe as well as helping them move forward. When you share the resource material, you would be helping at least one life around you heal and move forward along with keeping a lot of others safe.

### What is a message you can give today's youth to prevent such problems?

Our message to the youth would be that-The internet is a beautiful space but try to-Behave online like how you would like to be treated online and offline. Give and take respect. Don't share or believe meswithout verifying them. sages Try not to share or take in, hate inducing, negative messages. It only increases negativity in your lives. Others' likes and shares are not what should be defining your life. Practice digital wellness and online wellbeing and make sure your gadget use is mindful. Do not stalk anyone on social media. It will impact your mental well-being. Be smart and aware of pitfalls online. Keep in mind whether five years from now you want the message to be there if you post something. Understand that there is private message online. no Anything posted online stays there forever. Considering the increasing search for child sexual abuse material online, do not share photos/videos of children that seem provocative. Don't let life be defined by what you see online. We work on the principle that once there is awareness given in the right way, children can and will take care of their safety online, just as they can offline too. We have added a module on healing to the sessions as we believe that life is not to be defined by something bad that happened to you or to be held back in fear or guilt;that each life should be able to move forward to better spaces ahead. Along with this there is material on our social media handles and website which form, there are quite a few such cases that escape these watchful eyes.

Recently, a man residing in Panchkula, Chandigarh was cheated online. He was defrauded for Rs. 75000 under the pretext of giving him a personal loan. While he was still yearning for more money, he had realised that he had been cheated and had immediately filed a complaint. Another recent incident took place in Noida, a man was defrauded of Rs. 9.9 lakh while trying to get his flight ticket rescheduled.

The victim was asked to share an OTP and upon doing so, a total of twelve transactions took place amounting up to 9.9 lakh being deducted from the victim's bank account. These situations are examples of how online fraudsters prey on people who are



He illustrated the software by taking the data collected on celebrity endorsements and interpreting the data and shown in different figures and tables and made the students understand the significance. Towards the end, Linda



## Hate Speech and Online Abuseis it a violation?

Online abuse is the next major issue that poses a serious threat, especially against children and young people. The abuse which happens on the internet,through chats, social media posts, or online games may be in the form of cyberbullying, grooming, and sexual abuse, just to name a few. The internet helps children and young people to play, learn and connect. But, at the same time, it can cause severe harm to them if not properly utilized. Children may face the risk of online abuse from people they know or from strangers. However, there are cyber laws in place pertaining to online abuse which people can use to seek redressal against these violations.

ccording to Article 19 (1) (a) of Athe Indian constitution, "Everyone has the right to freedom of speech and expression". It allows the citizens, "the right to express one's convictions and opinions freely by word of mouth, writing, printing, pictures or any other mode". It also includes "the right to propagate or publish the views of other people". But does that mean one has the right to speak or publish without

for their lives etc.

responsibility? Providing freedom of opinion and expression should not be considered as a license to use all possible uses of language. It also does not mean preventing punishment for those who abuse this freedom.

Hate speech and online abuse have now become major issues when it comes to online media platforms. Can these be considered violations? Speech that is offensive but which does not cause risk is generally not regarded as a violation of human rights. On the other hand, "if it poses any threat, discrimination or violence against an individual or a group based on race, religion, ethnicity or other factors" is considered a violation. Hate speech which is propagated through tweets, YouTube videos, Instagram posts, Facebook posts and other online platforms gives rise to grave dangers and serious setbacks. The victim may experience problems like anx-

"Although there is no specific legislation in India which deals with social media, there are several provisions in the existing so-called cyber laws that can be used to seek redress in case of violation of any rights in the cyberspace, internet and social media".

Thus, both hate speech and online abuse can have long-lasting effects on the victim or the party. As a result, they become a threat to the protection of human rights and a violation of law and order. This in turn can adversely affect the solidarity of a democratic nation.

Privacy is described as freedom from an unauthorised intrusion, or quality of being apart. Social tracking is a way in which social media platforms tend to track various things about the way that people use networking sites. They keep track of the people that you follow, the advertisements you watch, the posts you like, statuses or photos you post, and also the profiles that you visit the most. They can analyse this activity to find out more about the type of person you are and what content can be shown to you. Here are a few things you can do to ensure some amount of safety for yourself on the web -

1. Change your Privacy Settings. You can choose who accesses your profile, stories and content on your account through the settings feature on most social networking sites. You can also

3. Read Pop-Up Notices About Cookies Before Clicking Accept. We are all guilty of mindlessly clicking 'allow' or 'accept cookies', but you would be surprised by the things hidden in the small print. Make sure that you are comfortable with what they can do with your data before clicking accept. It is also a good practice to read through the terms before agreeing to something in order to protect yourself in the future.

4. Be Responsible and Reserved Online Think about what you post. Only post pictures, videos or statuses that you feel comfortable remaining on the internet forever. You can 'delete' them, but they can always be retrieved. Anything that you post on the internet will remain there forever. Consider how future employers, family members and your enemies could view the information that you post on social media.

The best way to define Social Media is to divide it into two terms: social and media. Media is an instrument of communication, like newspapers, radio or TV. So, Social Media would be an instrument for social communication. In India, social media platforms come under the purview of the Information Technology (IT) Act.

Social media platforms such as Instagram, Facebook and Twitter are not just a mode of entertainment or communication, but today they have evolved into an area of trade and commerce activities as well. They have upheld the basic criteria of transmission of information. It has also accommodated a space for people to freely express their views as well as opinions.

Information Technology (IT) Act provides 'intermediaries guidelines' which were notified under the IT Act and the Indian Penal Code. There are so many specific laws to regulate the content available online, which are a few articles and sections that regulate the content available online such as Sections 67A, 67B and 67C of the IT Act. This section provides penalties as well as imprisonment which are to be imposed on anybody who has transmitted or published any kind of obscene materials or any fake news which is against the public. For this, the Central Government has also provided the power to is sue directives and to block certain information to be in public access, under Section 69A in the IT Act.

## I - CONNECT - ENERGY **EFFICIENT KUMBALANGI**

'I - CONNECT - Initiatives for the Conservation of Nature and Energy' was launched by the Department of Physics, St. Teresa's College (Autonomous), Ernakulam. This initiative was coordinated by Teresians in 2017 to build up a responsible generation working towards the cause of conservation of nature and energy. 'I- Connect' works with the Kumbalangi Panchayat in implementing the SAGY scheme for the overall development of the Panchayat. The long-term objective of this scheme is to build a Model Panchayat with zero bulb waste and simultaneously provide sustainable livelihood to women's self-help groups.

They also aim to do the energy auditing of the government institutions of the Panchayat. To promote the use of energy-efficient lighting, I-Connect conducted a workshop on LED bulb assembling and repairing for the

members of local self-help groups of Kumbalangi on 10 December 2021. The workshop focused on assembly, maintenance and repair of reusable LED bulbs. The aim was to enable the beneficiaries to become entrepreneurs of LED, prepare a business plan for the same and facilitate the setting up of an LED clinic for the manufacture and repair of LED lights. I-Connect in association with the Energy Conservation Society has completed the energy audit of the Kumbalangi Grama Panchayat Office. Data collection of all the electrical gadgets and equipment was done on 21 December 2021 by four student members of I-Connect and the completed report was handed over to Sri. Arif Mohammed Khan, Honourable Governor of Kerala on 13 January 2022 in a public meeting of the inauguration of Sansad Adarsh Gram Yojana (SAGY) in Kumbalangi.

On the third and final days, the session provided the participants with an opportunity to interact with three bravuras in the field of travelling and innova-








## **Expression on the Web- The Nasty Duality**



he term 'freedom of expression has existed from around the Athenian Greek era about 2400 years ago. The Constitution of India guarantees this freedom to all citizens according to Article 19(1)(a) - "All citizens shall have the right to freedom of speech and expression". Surprisingly, in this lies hidden, the freedom of the press. This can be considered as one of the cornerstones of a democratic government. The freedom to criticize and express a difference in opinion is part of one's freedom of speech. If the citizens of a nation lack the freedom to express themselves, then their other civil and political rights mean nothing. Hence, such freedom is paramount in

a functional democracy.

In November 2015, various Indian language writers brought out and registered their dissent in the light of attacks against freedom of expression, (the "rising intolerance in India") by returning their Sahitya Akademi awards. Evidently, the argumentative and skeptical Indian, who has been speaking out since the ancient days against injustice, continues to dissent. Such an attitude is still inherent in the Indian psyche. Unfortunately, according to the Press Freedom Index, India's rank in 2020 made a slight decline to 142 from 140 in 2019. The 2021 rank also remains the same. The feedom of speech and expression is not as simple as it may seem as it is

not absolute freedom. It carries with it distinct duties and responsibilities and therefore may be subject to certain restrictions of the law. It does not give citizens the right to speak or publish without responsibility. It is not a license that provides security to use or abuse the freedom and does, in fact, punish those who misuse it according to restrictions outlined under Article 19(2). As rightly said, with power comes great responsibility!

The term 'media freedom' extends the traditional idea of freedom of the press to electronic media, such as radio, television, and the internet. Free media helps to ensure that the democratic principle of publicity, also known as transparency, is attained. Publicity refers to making information about the operations of government open to the public, providing opportunities for public debate and perusal of matters of public concern.

A free press is necessary for democracy as it contributes to the knowledge of the citizens, helps the people communicate with their representatives to better the working of the government and allows citizens to bring to attention any violation of their rights and enables the policymakers to understand how their actions and policies are being viewed by the public. It is related to the transparency of political processes and decisions. The populace would have enough information to form their own opinions with such freedom. It limits the power the government could hold over the people.

The disadvantages of virtual press freedom are caused by the misuse of such freedom. A responsible media would understand its accountability to the people to follow high journalistic standards and respect them. However, press freedom also allows for inaccurate news or news that was written without adequate research to be disseminated among the public, thus continuing to keep the public in the dark. What makes it worse is that the public may now believe they have the correct information when the truth is quite the opposite. The publicity offered by the press has provided terrorist groups the coverage that they wish for. Many even believe that this publicity provides such groups with the "oxygen" it requires to survive. For example, soon after the Al-Qaeda attacks in New York City and Washington D.C., in September 2001, which was widely featured on international media, many American politicians and political parties argued that their existing legislation failed to protect the public against terrorism. Such an observation could be used as a justification for restricting the media.

Unrestricted online media also allows for hate speeches - abusive or threatening speech or writing that expresses prejudice against a particular group, especially based on religion, race, or sexual orientation. Such hate speeches have even led to some gruesome scenarios, such as the anti-Muslim mob violence of 2019 in Sri Lanka where a leader of a Sinhalese nationalist group called to action others of his community against the Muslims, claiming that they are taking over the country with their high population, with a simple video posted on YouTube, Facebook, and Twitter. This led to wide scale riots in Kandy district. The video was made on false claims as Muslims make up only a minority of the country's population (9%), against the 75% made by Sinhalese Buddhists.

Online media has become an indispensable form of communication through which individuals practice their right to freedom of speech and expression with the free flow of information. The world has recently begun to see a growing movement of people who are advocating for change, justice, equality, and respect for human rights. In such movements, online platforms often play a vital role with people connecting and creating a united stand for a cause. Today, it has become necessary to foster the independence of such media and ensure that access can be gained to them. With the growing use of social media, freedom of speech and expression has come to be universally recognized as a fundamental human right.



## Into the cyber world: known and unknown

### Do we really have online privacy? Your opinion.

Yes, I feel it is an important issue which needs to be addressed since we are losing our privacy, day by day. We have to be aware of the fact that our data, both financial and personal, is being collected, tracked or stored. It truly depends on the number of details that are exposed when you are connected online. Privacy being a right, we need to fight for it, taking precautionary measures. The way we use the internet is directly proportional to our online privacy. The way we handle our social media profiles is also an important factor. Seldom do we forget to check their privacy policies. Hence taking precautionary measures can save us from uninvited trouble.

### What are the biggest cybersecurity threats right now?

Ransomware attacks could be seen as the current biggest threats we are facing right now. Specifically talking about incidents, "WannaCry Ransomware Attacks" in May 2017 was a worldwide cyberattack by the WannaCry ransomware crypto worm, which targeted computers running the Microsoft Windows operating system by encrypting data and demanding ransom payments in the Bitcoin cryptocurrency. According to statistics, every 11 seconds, there is a ransomware attack detected. The average amount of ransomware reported transactions in the year 2021 was 2 million dollars. The cyber threat landscape moves fast and such crimes are only going to increase, hence ensuring safety will be a concern. Another important threat that we face today are cloud threats. Today companies all around the world are resorting to cloud infrastructure to store and handle their data. we face today. Social engineering is an attack vector that relies heavily on human interaction and often involves manipulating people into breaking normal security procedures and best practices to gain unautho or physical locations or for financial gain. Human error is the biggest reason for data breach; hence

rized access to systems, networks or physical locations or for financial gain. Human error is the biggest reason for data breach; hence it is often misused by such hackers.

### Can we detect an attempted or successful cybersecurity incident?

Every day is a new obstacle. With the arrival of newer technologies day by day, we find it difficult to stay updated. The detection of a new threat depends upon the cyber security policies and measures that are practiced in an organisation. In our country, it is a common sight to see the ignorance of cyber security aspects in a situation. Hence investing in cyber security professionals and availing the services of newer technology, implementing the right policies and measures can help detect such crimes at a very early stage itself. What are the most common cyber security cases in Kerala and how are their number of cases every year like?

There has been a paradigm shift in our digital life since 2019. Our lives have been confined to our homes to a large extent, where physical interaction with the outer world has become zero and we were willingly or un willingly connected to the virtual world on a larger scale than before. The number of internet users have skyrocketed in the pandemic world, hence the number of cybercrimes reported have also increased. More people resort to making payments and other bank transactions via the internet. This has resulted in the high rates of banking frauds in the past three years. Other frauds include receiving messages in the name of OTP's, Aadhar updating, KYC updating etc. Online job frauds, social media defamation is also not a thing of the past in Kerala.

police districts set up in various parts of Kerala. Taking the case of Ernakulam district, Ernakulam city and rural police stations can be availed. The Ernakulam city station comes underthe commissioner and the cyber police station in the city is situated in the Info Park. The cyber police station works under an inspector of police. A complaint can be filed in person as well as via mail with adequate information regarding the transaction, considering the pandemic situation.

### Can you recollect one of the most challenging cases that you had to deal with as a Cybercell officer?

Since there is a limitation in disclosing certain details, I will stick to the outer details about such cases. Definitely terror related cases are the most challenging cases that we have come across. Some other cases would include catching hold of paedophiles, under the "P Hunt" exercise by The Kerala Police practiced in a gap of every 2-3 months. In such cases, The Police have to come in contact even with the dark web to catch hold of criminals. There is another branch of police, specialised to deal with drugs and narcotic cases. It requires ample time and patience to catch hold of such criminals, sometimes the police may even have to pose as buyers until they get to arrest the culprits. Banking frauds also have a special team in the police. This makes dealing with each case different from the other.

### Which are the most important laws pertaining to cyber security that people are mostly unaware of?

to the internet now. Our home has be come smart. All gadgets are connected to the internet-this is called internet of things (IOT). This is a major development as well as a major threat in information technology. The challenges pertaining to this are the issues concerned with piracy. Next development is Artificial Intelligence. Digital currency is also a challenging domain emerging in the cyber world. Bitcoin, Blockchain technology are all associated with the digital currency. These are the current developments in information technology according to me.

### How can one keep oneself safe from cyber scams?

If you look at the cyber scams, like OTP fraud or banking transaction issues, the emotional manipulation they project through the messages are to be aware of. The notifications coming to your phones and emails are with highly sensitive offers or account security concerns that push you to immediate action without thinking critically. The amount of urgency present in these messages are high. You must be very careful about the messages on transactions, offers and bank accounts. Next is the excitement factor like offering gift coupon cards, lucky spin wheels etc which triggers optimism. We overlook all the potential downsides and go for it. Another factor is fear inducing messages- virus attacks on your system, alerts in your bank accounts, messages stating your sim is about to get blocked etc trigger a fear in us. All these messages manipulate your emotions. So be extremely careful while receiving such messages. Think before moving forward with such messages and never disclose your bank account details through phone or mail. Campaigns for the same are done by police and cyber officers. No authority or officers ask for OTP, CVVs over the phone. Never download any screen sharing apps on anyone's request. Be vigilant on clicking unauthorised links as messages. Check for authenticity and credibility always.

### As girls, in an unsafe world what are a few tips to how to respond in a cyber security emergency?

Girls are of course vulnerable to cyber-attacks. If it is an inappropriate message or one that is making you uncomfortable in any way, immediately report it. If you don't report, block, ignore or unfriend the attacker in the first instance itself, if not the perpetrator takes this opportunity for granted and continues the abuse or attack. You need to have the instinct to block and report the attacker. No need to interact with the person the very moment you feel uncomfortable. Incase of emergencies while travelling, Kerala police have an app "Nirbhayam". The moment you press the help button for 5 second the alert message reaches the control room near you and help is sent right away. Never share your passwords with any person no matter how close vou are. Hate speech and online abuse- Looking at the predators, what is the usual conclusion in most cases? Pertaining the age group, motive etc.. One thing you must understand is that whether it is online abuse or hate speech you are facing on the internet, it is a defamatory offence that whether it is online abuse or hate speech you are facing on the internet, it is a defamatory offence. It is of course punishable under the existing IT act. It is of course punishable under the existing IT act. The point I would like to emphasise here is that the police cannot take direct actionhere. The court must identify what's hate speech and defamatory, then the court will assign the case to the police.

operation 'P hunt' is a dedicated unit to investigate child related cyber issues. The unit is called CCSE (Counter Child Sexual Exploitation unit). There's an inspector and set of officers exclusively assigned to investigate child predator related issues.

It is a common scenario today to see women and young girls fall prey to online predators, promising them a life or other. However, the conclusions in most cases are more or less the same. The victim either suicides or ends up in mental agony. What is your take on it? What message would you like to convey to the young girls of this country?

Most girls end up depressed or in mental agony when intimate pictures are circulated by the attacker. The moment you share anything on the internet, it becomes a digital footprint, and cannot be erased. Even if we catch the culprit, the damage has already been done. So, my message to girls is never ever share anything that's personal or intimate over the internet. Take up online accountability and make safe and effective use of it.



ave you ever wondered if the social media that we use on a \_daily basis is filled with surprises and tricks that can be dangerous to our personal life? YES! Scammers are hiding out on social media using different kinds of ads and offers to market their scams- even a simple forward message can leak a lot of personal details. The Internet is a vast and wide world which doesn't take much of efforts and time to reach out and connect with people. Click baits, which are contents whose main purpose is to attract attention and encourage visitors to click on a link and drive traffic onto a particular webpage, are one of their main ways of reaching out. They make them look so real and credible that the internet users have a hard time understand-

ing which is fact and which is fiction. There are many kinds of social media scams like impersonation scams, online dating scams, sweepstakes and lottery scams, quick money-making and work from home scams. Their main goal is to trick people into parting with money or revealing sensitive personal data. Var ious techniques like creating fake profiles, phishing, robocalls and computer pop-ups are used to collect data. Lead lists are a large contact directory that large sales and marketing teams use to send out cold mails and calls to get their products and services sold. A recent study by SocialCatfish.com showed 10 social media apps and platforms that were used to scam people online with Facebook at the top, having had 152 victims. It is our own responsibility to keep ourselves and our data safe by not falling into these kinds of scams. Keep changing your passwords, never share your personal details with others, don't fall for click bait, check whether the website is secured and legitimate, protect your devices from viruses and malicious programs, and be vigilant all the time. Be aware, be safe!

What are the legal procedures to file a complaint if we have been scammed?

For catching hold of online fraudsters, anyone who feels they are scammed can immediately dial the toll-free number 155260 and can avail the help of professionals. They will in turn block the transaction and take necessary measures to catch hold of the culprit. Time is everything Sudden action issary so that the perpetrator doesn't have enough time to withdraw the money through such fraudulent acts. First of all there is a common misconception that whatever you write on the internet is seldom considered as an offence. Just like Article19 of the constitution enshrines certain freedom to Indian citizens, there are certain restrictions too. One being defamation- you are not supposed to defame a person through digital media. So, any obscene message sent to a person counts as defamation and it is an offence that can be prosecuted under the cyber law. Piracy is another offence people are unaware of. Anti-piracy laws are rarely respected. The moment a new film is released, links for the same are available in Telegram. Any copyrighted content pirated and shared is an offence people consider lightly.

Every second, the number of online users facing cyberstalking, and other issues like social profiling, third-party information sharing and warrantless searches become countless. So, privacy becomes one of the most feared and haunting problems in our social and screen life. Social media platforms now provide users with more privacy protections. Despite all these protections provided, problems still lurk around the corners.

Protection from online scams is a very important matter that every individual from all age groups should have a basic knowledge about in this digital era. Security threats can happen in various forms ranging from surveillance through mobile phones to fraud calls and messages. Hence, while exploring the internet, we should be very careful in each small step we take. Some of the steps to protect yourself from such security threats are mentioned below:

1. One of the easiest steps individuals generally rely on is setting a password for the device. The word may sound simple, but we should know that small raindrops make a sea. The idea is the same when it comes to passwords and we should be careful even in setting up a password. Increasing the length of the password is the best and most simple way to protect your password, or else you could create your password with Morse code. (Either of two codes consisting of variously spaced dots and dashes or long and short sounds used

for transmitting messaged by audible or visual signals) As the password becomes longer it becomes tougher for hackers to break through an individual's privacy.

2. Public networks are not used to help you when you are outside your house, but it's the other way around. Through Public networks, the source could easily access your data and use it maliciously. VPN is the best security measure to protect you from this. It can help you protect from the drainage of data as well as secure your phone from other companies from mining into your browser. It also provides fast and private access to the internet. You can protect your personal social media accounts just by connecting to VPN.

6. Don't download content fromsites

that are not trustworthy. These may contain malware

7. All smartphone users are constantly being monitored through various apps and companies. The best way to look after this is to be careful of what you say online.

8. Even while sitting comfortably in your gaming chair, you should be vigilant in terms of your digital privacy. In that case, remember that we should not communicate personal information with friends, since not everyone is trustworthy.

9. It is a good safety measure to only use verified apps. This is because even if mobile phones prove to be helpful, they are not helpful in terms of digital privacy. It's important to verify the apps before using them.

10. Someone who tries to gain remote access to your computer would mostly be a scammer (a person who commits fraud or participates in a dishonest scheme). They may do malpractices such as downloading a virus and they would demand a huge ransom from the user to help them access their service. The best way to avoid such people is not to communicate with them.

11. Do not bite the bait!- don't click any attachment, link, or picture which is not relevant or if it is not sent by request. Such contents may have come from unidentified contacts, which could prove fraudulent. They are used to lure the users and take personal information; they are likely to borrow money from your account too. No social media would be responsible for such third-party apps. 12. Do not blindly respond to calls, SMS, and email. This is said so because such emails and messages force us to disclose financial details. The fraud callers may make us feel that they are employees of big companies and

ask you per sonal details pointing out things like card expiry, free cashback etc. Sometimes they may take your bank details and draw money from the

account without your knowledge. 13. Never share sensitive and personal information, to any stranger or any third party claiming to be the representative of a bank. Always remember that banks do not ask for such sensitive information, and such mistakes can make vou broke.

privacy policy is a statement that discloses some or all of the ways in which an individual's data is to be collected, disclosed and managed by a website. Personal information can be anything that can be recognized about a person, not limited to their name, address, date of birth and marital status.

Like two sides of the same coin, privacy policies too, come with their own pros and cons. If a child uses various kinds of apps and websites without the permission of their elders, privacy measures could protect them from information that is inappropriate according to their age limit; it makes it easier to ignore the unwanted information on websites, apps, etc; it allows the person to stay anonymous according to their choice. At the same time, privacy measures make it easier for people to steal writings- anyone can copy and paste the text and publish it on websites or apps. Owing to the privacy measures, it is difficult to find who is stealing it.

Have you ever actually read an app's privacy policies before giving permission to it? Most of us have not. When a person installs an app, they give permissions for the terms & conditions/ privacy policies without reading it. Some people read the privacy policies but will struggle to understand them. Each and every app or website has its own privacy policy. When a person installs an app there would be some information which is not always necessary such as location, phone number or allowance to camera etc, which would be asked by them and we would permit them. These phone apps can track our information due to the permissions that we give. Various apps ask permission for the camera, microphone, call logs, location or storage. Prominent social media sites such as Facebook and Instagram use location technology. This use of tracking methods also poses threats to digital privacy. Certain other problems regarding privacy can be solved through the phone settings or in the app settings themselves. We can change the permission by going directly to the settings and can make changes there itself. Most of the changes that everyone makes would be regarding the permission to the camera, location, and phone number. Privacy partially overlaps with security which can include the protection of information about his/her personal life.



Cyberbullying can cause

physical problems such as insomnia and unhealthy eating habits as a result of intense feelings of stress and anxiety. As cyberbullying has grown more common due to technical advances, many countries have updated their laws to include or specify cyberbullying offences. In India, there is no explicit legislation that allows for cyberbullying laws, yet measures like Section 67 of the Information Technology Act deal with cyberbullying in some way. Section 67 stipulates that publishing or transmitting obscene content in electronic form is punishable by up to five years in prison and a fine of up to ten lakh rupees.


