 - d) to take appropriate actions to eliminate the non-conformity and record actions taken;
 - e) to make records about complaints mentioned above available to the certification body when requested.
- Certification Body re-evaluates the product in case of a change of technical specification, in case of changes affecting product performances or in case of significant changes of ownership, structure or management.
- 6. Against this certificate the applicant has the right to appeal to TZUS Prague, Quality Control Department within 15 days of receipt of this certificate.
