

Online Store Agreement

This Agreement ("Agreement") is made and entered into by and between Wyton School Community Association ("WSCA"), and the individual seller ("Seller") of items on the WSCA Online Store ("Store"). By listing items for sale on the Store, the Seller agrees to the terms and conditions outlined in this Agreement.

1. Purpose of the Agreement The purpose of this Agreement is to outline the terms under which individuals can sell items through the WSCA Online Store. The WSCA will facilitate the sales process, manage the transactions, and distribute proceeds to the Seller as described below.

2. Seller's Responsibilities The Seller agrees to:

- List only lawful, appropriate, and acceptable items for sale.
- Provide accurate descriptions, prices, and any other relevant details for the listed items.
- Ensure the items being sold comply with all UK laws and regulations.
- Notify the WSCA immediately if an item is no longer available or if any changes need to be made to a listing.

3. WSCA's Responsibilities The WSCA agrees to:

- Maintain and operate the online store platform where Sellers can list their items for sale.
- Collect full payment from buyers for items sold through the Store.
- Transfer 10% of the sale price to the Seller for each item sold, after deducting any applicable fees, taxes, or transaction charges.

4. Payment Distribution

- The WSCA will collect the total payment for the sale of each item.
- Within 30 days following a completed sale, the WSCA will pay the Seller 10% of the sale price of the item, less any applicable processing fees, charges, or taxes.
- Payments to Sellers will be made via bank transfer and will be issued once the payment from the buyer is confirmed and the Seller has confirmed the item/service has been received by the buyer.
- The WSCA will store details of the Seller's bank account solely to enable to transfer of monies owed to the Seller.

5. Fees and Charges

- The WSCA may charge a processing fee for each transaction (1.5% of the total plus £0.20), which
 will be deducted before the 10% payment is made to the Seller. The Seller will be notified prior
 to items being offered for sale if this fee is going to be applied.
- The WSCA may change its processing fees at any time, provided that the Seller is notified of such changes in advance.

- **6. Intellectual Property** The Seller warrants that they own or have the right to sell the items listed on the Store, and that such items do not infringe upon the intellectual property rights of any third party. The Seller grants the WSCA a non-exclusive license to use any images, descriptions, or other content related to the sale of the items for marketing and promotional purposes.
- **7. Liability and Indemnification** The WSCA will not be held liable for any disputes between the Seller and the buyer or for the quality, legality, or condition of the items sold. The Seller agrees to indemnify and hold harmless the WSCA from any claims, damages, or expenses resulting from the Seller's violation of this Agreement or from the sale of their items.
- **8. Termination** This Agreement may be terminated by either party at any time, with or without cause. Upon termination, the Seller will be entitled to any outstanding payments owed for sales made prior to termination.
- **9. Dispute Resolution** Any disputes arising under this Agreement shall be resolved through informal negotiation. If a resolution cannot be reached, the dispute may be submitted to mediation or arbitration in accordance with the laws of the United Kingdom of Great Britain and Northern Ireland.

10. Miscellaneous

- This Agreement constitutes the entire understanding between the parties with respect to the subject matter hereof and supersedes all prior agreements and understandings.
- If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.
- This Agreement is governed by the laws of the United Kingdom of Great Britain and Northern Ireland and is binding upon both parties and their respective successors.

By listing an item for sale on the WSCA Online Store, the Seller acknowledges that they have read, understood, and agree to the terms and conditions of this Agreement.
