- I understand that I will not be added to Atad Valley Farms LLC CSA membership list until I have completed and submitted the application form, either in-person or by mail or email and payment has been received by Atad Valley Farms LLC. Payment is due within 14 days of application.
- By signing up with Atad Valley Farms CSA, I am committing to the entire 20-week season. I understand that it is important for me to be present each week at my selected location to promptly pick up my CSA box. In the event that I cannot pick up my box on delivery day due to vacation and/or special circumstances, I will notify Atad Valley Farms at least 24 hours in advance. The farm will do their best to arrange alternate pick-up time for me. If an alternate

pick-up time cannot be arranged, I will send either a friend, neighbor or family member to pick up my box, or miss that week's CSA box. I understand that missed CSA boxes cannot be made up at the end of the season and are not eligible for refund.

- I understand that missing a weekly pick-up without prior notice will result in forfeiture of that week's box. Missed boxes will not be held for later pick-up, so I can receive the freshest food possible. Missed boxes cannot be made up at the end of the season and are not eligible for refund.
- I understand that, if at any time during the season, I wish to forfeit my share, it is my responsibility to find a replacement to take over my share for the remainder of the season. I understand that once payment has been made, there will not be a refund should I forfeit my share.
- I understand that, if I am paying for the subscription on a monthly basis, should I cancel my subscription, I agree to pay for one additional month as a cancellation fee.
- I understand that, as a CSA member, I am eligible for a 10% discount on any additional produce that is available beyond what is included in my CSA box.
- I understand that I will need to return my empty box at each pick-up to Atad Valley Farms LLC in exchange for my next box. Failure to return the box will result in a \$5.00 surcharge to replace the box.

Atad Valley Farms LLC CSA Membership Policy, Terms and Conditions

By signing up for Atad Valley Farms CSA, you are committing to the entire 20-week season. Once your subscription fee has been paid, no refunds will be granted for any reason. We respectfully ask that once your pick-up location/time has been selected, please make every effort to stick with that location. We plan our harvest and delivery schedule carefully to ensure that you have the freshest products possible. Changing locations can make that scheduling more difficult. If you need to change pick-up locations, please give us at least 7 days' notice. If you are unable to pick up your weekly CSA box due to vacation or special circumstances, please make every effort to give us at least 24 hours' advance notice. If that is not possible, please send a friend, neighbor or family member to pick up your box for you. Due to the nature of our products, missed boxes cannot be held or reserved for later pick-up. Missed boxes will be considered forfeit and cannot be made up at the end of the season and are not eligible for refund. Forfeit boxes will be donated to those in need, to the best extent possible.

We will make every effort to provide you, our customers, with the freshest and best food possible. Each box will be filled with a variety of fresh vegetables, herbs and fruits, depending on season and availability. The exact types of produce that will be in each box will depend on seasonal and environmental factors. As CSA members, you will share in any surplus we harvest but will also assume some risk related to the farming season. We will guarantee you a regular weekly supply of fresh, locally grown produce throughout the CSA season. In the event we experience a crop failure or extreme weather event that prevents us from harvesting one or more crops, we reserve the right to purchase from other local farms that adhere to our principles of growing, i.e. no chemical

fertilizers or pesticides. This is not expected to be common practice and will only do this to ensure that you continue to receive a plentiful variety of the freshest produce available in each box.
