Early and Late Bird Registration

Article I - Introduction

1. The VI Edition of Oporto Biomedical Summit (OBS) registrations aim to be as fair as possible, providing each potential participant with an equal opportunity to enrol.
2. The target audience is medical students, healthcare-field students and health professionals. Nevertheless, all others interested in the conference topics are welcome to attend.
3. The VI Edition of Oporto Biomedical Summit will take place between March 20th and 22nd, 2026, in Oporto, Portugal.
4. The VI Edition of Oporto Biomedical Summit will be in person, taking place at the Super Bock Arena and the ICBAS School of Medicine and Biomedical Sciences of the University of Porto (ICBAS-UP).

Article II - Registration's Phases, Ticket's Modalities and Fees

1. Registrations for Full and Partial Tickets will take place in two main phases: *Early Bird* and *Late Bird*.
2. The first phase (*Early Bird*) will take place between January 31st (9:00pm GMT) and February 7th (23h59min GMT) 2026, offering a limited number of 60 full tickets and 10 partial tickets.
3. In case the registrant cannot buy their ticket during the Early Bird phase, they can purchase it during the second phase (*Late Bird*), which will take place between February 20th (9:00pm GMT) and March 8th (23h59min GMT), 2026.
4. In the circumstance of the tickets not sold out by the end of the *Late Bird* phase, there may be a third opportunity for registration (*Last Bird*), which will be promoted in the social media of the VI Edition of OBS.
5. There are two ticket modalities: full ticket and partial ticket.
 - a. The full ticket give access to:
 - i. 4 Workshops;
 - ii. 1 OBS Talk;
 - iii. Scientific Programme;
 - iv. Cultural Programme (Gala Dinner not included);
 - v. Lunches, Brunch, Coffee Breaks and Snacks;
 - vi. Opening and Closing Ceremonies and Porto D'Honra.

b. The partial ticket gives access to:

- i.5 OBS talks;
- ii.Scientific Programme;
- iii.Brunch, Coffee Breaks and Snacks;
- iv.Opening and Closing Ceremonies and Porto D'Honra.

6.The VI Edition of Oporto Biomedical Summit will count with up to 280 participants (a maximum of 230 Full Tickets, the surplus is destined for Partial Tickets).

7.The ticket fees for the *Early Bird* phase will differ, depending both on ticket modality and the participant type:

- a.Full ticket:
 - i.The price for an ICBAS student Full Ticket is 36,50€.
 - ii.The price for a non-ICBAS student Full Ticket is 39,50€.
- b. Partial Ticket:
 - i.The price for an ICBAS Student Partial Ticket is 16,50€.
 - ii.The price for a Non-ICBAS student Partial Ticket is 19,50€.
 - iii.The price for a Professional Partial Ticket is 40€.

8.The ticket fees for the *Late Bird* phase will differ, depending both on ticket modality and the participant type:

- a.Full Ticket:
 - i.The price for an ICBAS student Full Ticket is 39,50€.
 - ii.The price for a Non-ICBAS student Full Ticket is 42,50€.
- b.Partial Ticket:
 - i.The price for an ICBAS Student Partial Ticket is 19,50€.
 - ii.The price for a Non-ICBAS student Partial Ticket is 22,50€.
 - iii.The price for a Professional Partial Ticket is 50,50€.

9.The registration as an ICBAS Student will be confirmed by the Organising Committee via the student number.


10.The registration for the competitions and the Gala Dinner will open at a later time.

11.Participants who are applying to the “Apoio ao Estudante” can only benefit from it at the Late Bird Registration.

Early and Late Bird Registration

Article III - Registration

1. The registrations will happen online through the EventKey platform, which will be shared on the VI Edition of Oporto Biomedical Summit social media.
2. By registering for the VI Edition of Oporto Biomedical Summit, one agrees with the ICBAS-UP Students' Association (AEICBAS) Data Protection Policy.
3. The registration process for both tickets- full and partial- will require the following personal data:
 - a. Full name;
 - b. Preferred pronouns;
 - c. E-mail;
 - d. Cell phone number (with indicative)
 - e. Ticket Modality
 - i. Student:
 1. ICBAS;
 2. Non- ICBAS;
 3. International;
 - ii. Professional
 - f. University and Curricular Year OR ;
 - g. Student number (ICBAS Student only);
 - h. Ambassador code (if suitable);
 - i. Tax Identification Number (NIF) and Fiscal Address (if desired).



1. Regarding full ticket holders, we inform that the allocation and selection forms for the Workshops, OBSTalks, Cultural Programme and Lunch will open at a later time. The participants will receive the respective allocation and selection forms through the provided email account.
1. Participants who enrol at the Professora Corália Vicente Award will have a 25% discount on the ticket fee, regardless of the ticket modality chosen.
 - a. The refunding of the corresponding value will be assured after the congress has ended, up until one month;

Article 3.1 - Registration Method II

1. The selection forms for Workshops and OBSTalks will require:

- a. Acceptance of the Data Protection Policy;
- b. Full Name;
- c. E-mail;
- d. Phone Number;
- e. OBS Talks and Workshops preference.

2. The selection forms for Lunch will require:

- a. Acceptance of the Data Protection Policy;
- b. Full name;
- c. E-mail;
- d. Lunch options for each day;

3. The selection forms for Culture Programme will require:

- a. Acceptance of the Data Protection Policy;
- b. Full name;
- c. E-mail;
- d. Cultural Programme activities preference.

4. The allocation process of participants to Workshops, OBSTalks and Cultural Programme activities will occur as stated below:

- a. Each participant will select their option by availability in each session.
- b. The time of submission will be the determinant of the final allocation.

Article 4 - Payment and Refund

- 1.The payment of the ticket fee must be performed through the EventKey platform during the registration act. The registration will only be considered after its respective payment, which must be completed within 24 hours.
- 2.In case the payment is done by Bank Transfer, the participant must send **proof of transfer** to publicrelations.obs@gmail.com within 24 hours of registering.
- 3.The tickets are non-refundable.

Article 5 - Certificate

- 1.The participants shall receive the Certificate of Participation if present in 80% of their assigned Workshops and/or OBSTalks.
 - a.Participants with a Full Ticket: 4 Workshops or OBSTalks out of 5 sessions;
 - b.Participants with a Partial Ticket: 4 out of 5 OBSTalks;
- 2.Besides the mandatory attendance, the participants must answer the Satisfaction form that will be sent after the event on the established dates.



Early and Late Bird Registration

Article 6 - Disclaimers

1. All the best efforts will be made to present the Programme as close as possible to the version available on OBS social media. However, the Organising Committee of the VI Edition of OBS reserves the right to alter or cancel, without prior notice, any of the arrangements, timetables or plans relating directly and indirectly to the conference or exhibition, for any cause beyond its reasonable control. The Organising Committee is not liable for any loss or inconvenience which may be caused as a result of such alterations.

1. In the event that the conference is either cancelled by the Organising Committee or cannot take place for any reason beyond their control, the registration fee shall be fully refunded. The Organising Committee shall not be liable for any other loss, cost or expenses.
