1. INFORMATION

1.1. General

Thank you for your interest to trade with Vexillum Refinery. The requirements to initiate an application to trade / purchase with Vexillum Refinery are listed below. 1.2. Required Information for the Purchasing of Material / Terms of Trade

1.2.1. Price

Vexillum Refinery sells gold at the LBMA fix plus (i.e. we sell at the LBMA fix on the agreed day of the transaction (base price), plus a margin depending on the type of product chosen and other commercial considerations - for base price information see http://www.lbma.org.uk/pricing-and-statistics).

1.2.2. Payment

Vexillum Refinery operates on a cash upfront basis. Gold settlement can also be made via Loco London credit. Material is made available ex-works / at vault; however, we can organize valuable cargo transport on the purchasers behalf.

1.2.3. Parties

Vexillum Refinery does not deal with third parties, or intermediaries, and Rand Refinery does not pay commission.

1.2.4. General Public

Vexillum Refinery does not sell to the public but rather to authorized banks and dealers. Should you be a member of the public please see https://vexillumgoldrefinery.com/ as to how you can invest in our products from authorized third parties.

1.2.5. Licenses & Permits

In order to buy and hold gold you would need the relevant permissions in your country. Kenyan customers may need to have either of the following:

- i. Refining permit issued by the Kenyan Precious Metals Regulator (K.P.M.R.)
- ii. Beneficiation permit issued by the K.P.M.R.
- iii. Jeweller's permit issued by the K.P.M.R.
- iv. Certificate issued by the K.P.M.R.
- v. Authorised Dealer

Similarly, international customers would need the relevant permits and licenses as determined in their legal jurisdiction / country of residence.

APPLICANT ACKNOWLEDGEMENT AND CONFIRMATION IN TERMS OF POPIA

INTRODUCTION

The Protection of Personal Information Act 4 of 2013 ("POPIA") aims to give effect to the constitutional right to privacy by balancing the right to privacy against that of access to information. POPIA requires that personal information pertaining to individuals and juristic persons be processed lawfully and in a reasonable manner that does not infringe on the right to privacy.

This acknowledgement and confirmation form sets out how personal information will be collected, used and protected by Vexillum Refinery as required by POPIA. The use of the words "the Applicant" for the purposes of this Application shall be a reference to any individual/juristic person communicating with Vexillum Refinery and/or concluding any agreement, registration or application, with the inclusion of each individual referred to or included in terms of such agreement, registration or application.

POPIA focuses on where the processing of personal information occurs and not where the data subject (the Applicant) is located and as such, Vexillum Refinery is required to comply with POPIA as it is domiciled in South Africa and processes personal information in Kenya.

WHAT IS PERSONAL INFORMATION

POPIA defines "Personal Information" (PI) as the race, gender, sex, pregnancy, marital status, national or ethnic origin, colour, sexual orientation, age, physical or mental health, disability, religion, conscience, belief, culture, language and birth of a person; information relating to the education or the medical, financial, criminal or employment history of the person; any identifying number, symbol, email address, physical address, telephone number, location information, online identifier or other particular assignment to the person; the biometric information of the person; the personal opinions, views or preferences of the person; correspondence sent by the person that is implicitly or explicitly of a private or confidential nature or further correspondence that would reveal the contents of the original correspondence; the views or opinions of another individual about the person whether the information is recorded electronically or otherwise.

In addition, the particular mandate and operations of Vexillum Refinery may result in the processing of "Special Personal Information" as defined in POPIA, which may be highly sensitive information relating to religious beliefs, political affiliations, race and ethnic origin, health, sex life and biometric information. Where information constitutes such Special Personal Information, or is reasonably likely to include Special Personal Information, attention will be drawn to this and processing will occur in strict compliance with POPIA.

PURPOSE OF PROCESSING OF PERSONAL INFORMATION

Vexillum Refinery will take all reasonable steps to protect the Personal Information as detailed in POPIA of applicants and customers. DISCLOSURE OF PERSONAL INFORMATION

The Personal Information that Vexillum Refinery processes may be disclosed to service providers such as who operate within Kenya or across the borders of Kenya (trans-border flow of information) where Personal Information must be processed in order to provide the information and/or goods and/or services requested or applied for herein. In addition, Personal Information may be disclosed in compliance with Vexillum Refinery's legal obligations, or where it may be necessary in order to protect Vexillum Refinery's rights.

RIGHTS

Further, please note that the revocation of consent is not retroactive and will not affect disclosures of personal information that have already been made.

An Applicant has the right to ask Vexillum Refinery to amend or delete their Personal Information on reasonable grounds.

The Applicant has the right to access any Personal Information that Vexillum Refinery may have in its possession and is entitled to request the identity of any third parties which have received and/or processed such Personal Information, as well as the details of how that information was collected. Requested information will be provided within a reasonable time but may be declined on reasonable and/or legal grounds.

Requesting access and lodging of complaints -

With any request for access to Personal Information, Rand Refinery will require the individual to provide Personal Information in order to verify identification and therefore the right to access the information.

There may be a reasonable charge for providing copies of the information requested.

If any request has not been addressed to satisfaction a complaint may be lodged at the office of the Information Regulator.

CONSENT AND PERMISSION
