

# A Siren's Shine Terms & Conditions

#### 1. General Agreement

By booking a service with The Siren's Shine, you agree to the following terms and conditions. These terms are binding upon payment and/or submission of the booking form.

### 2. Nature of Services

The Siren's Shine provides in-home cleaning and lifestyle assistance performed by the provider in lingerie. These services are strictly non-sexual, professional, and visual-only.

This is not an escort service. Any implication, solicitation, or expectation of sexual activity will result in immediate termination of the session without refund and possible legal action.

### 3. Session Requirements

- Sessions take place in client residences or other approved locations.
- A **security presence** is at all sessions to maintain safety, professionalism, and boundaries.
- The client must provide a safe, respectful, and clean environment.
- The provider retains the right to decline entry or end a session immediately if she feels unsafe, disrespected, or violated in any way.

## 4. Rates & Payments

• The current rate is \$200/hour, with a 2-hour minimum per booking.

- Travel outside San Antonio is subject to a \$50 per hour travel fee, one way.
- Payment is due in full upon booking confirmation. No services are rendered without full prepayment.
- Accepted payment methods will be communicated upon session approval.

## 5. Cancellations & Rescheduling

- Cancellations must be made at least 24 hours in advance for a full refund.
- Cancellations made less than 24 hours before the appointment are **non-refundable**.
- Rescheduling may be accommodated once per booking with advance notice.

#### 6. Client Conduct & Boundaries

- **No touching** of the provider is permitted at any time.
- **No filming, recording, or photographing** the provider during the session without prior written consent.
- Clients are expected to maintain a respectful tone, manner, and space at all times.
- Any behavior deemed inappropriate, including suggestive language, gestures, or disrespectful conduct, will result in immediate session termination with no refund.

#### 7. Confidentiality

All client information, session details, and communications are kept strictly confidential. The Siren's Shine does not share client data except where legally required.

## 8. Limitations of Liability

Lovegood Amenities LLC and its providers are not liable for any incidental or consequential damages arising from the use of services. Clients assume full responsibility for their space and any valuables within it during the session.

## 9. Right to Refuse Service

We reserve the right to refuse service to anyone, at any time, for any reason, especially if we feel that safety or boundaries may be compromised.

# 10. Health Expectations

To maintain a safe and healthy experience for everyone, the Client is required to reschedule if they are experiencing any signs of illness. If the Client is feeling "a little off," they are expected to err on the side of caution and reschedule — we promise, the shine can wait.

The Provider also commits to rescheduling if experiencing symptoms of illness and will not attend any session if there is any risk to the Client or their space. If either party is sick, the session will be rescheduled with **no cancellation penalty.** 

Communication is key. The Client should contact the Provider as soon as possible if they are feeling unwell. If the Provider arrives and observes clear signs of illness, the Provider reserves the right to cancel the session on the spot. In such cases, the session is **non-refundable** and will not be rescheduled unless cleared in advance.

By booking a session and submitting payment, you acknowledge that you have read, understood, and agreed to these Terms & Conditions in full.
