SHIPMENT

We are prepared to ship 200 tons of charcoal or briquettes to your nation. Our shipping option includes:

1. FCA (Free Carrier)

FCA is a highly recommended option for sea freight where you prefer managing the main ocean carriage. We will deliver your export-cleared goods to your nominated carrier at an agreed-upon location, such as a port terminal or our warehouse. From this point of handover, the responsibility for all risks and costs, including the main ocean freight, fully transfers to you.

2. The FOB option is ideal for straightforward sea freight. We are fully responsible for getting your goods safely loaded onto the vessel you designate at the agreed port of shipment, including handling all export customs procedures. Once the goods are on board the ship, all risks and costs (like ocean freight, insurance, and import duties) become your responsibility.

3. EXW (Ex Works)

EXW offers maximum control for experienced importers managing their entire sea freight logistics. We will simply make the goods available at our premises (factory/warehouse) in Indonesia, ready for your collection. All costs and risks, from loading the goods onto your transport, local haulage to the port, export customs clearance, main ocean freight, to the final delivery at your destination, are entirely your responsibility.

FLEXIBLE PAYMENT OPTIONS FOR YOUR TRANSACTIONS

We understand the importance of security and flexibility in international trade. That's why we offer a payment scheme that combines the ease of an initial transfer with the assurance of final payment.

Payment Scheme: 50% T/T (Down Payment) & 50% L/C (Final Payment)

This method is designed to offer convenience for you and security for us:

- 50% Down Payment via Telegraphic Transfer (T/T): You make an initial payment of 50% of the total order value via T/T. This secures your order and allows us to immediately begin the production or preparation of your goods.
- 50% Final Payment via Letter of Credit (L/C): The remaining 50% will be paid via a Letter of Credit (L/C). This L/C will be activated and paid once the goods are loaded onto the vessel and all required shipping documents have been submitted by us and confirmed compliant by the bank. This ensures payment is only made after your goods are ready to sail.

- Guaranteed Security: Final payment is only processed after your goods are on board the vessel and valid documents are available.
- Efficient Cash Management: You don't have to pay the full amount upfront.

Brief Process:

1. You transfer the 50% down payment via T/T.
2. We process your order.
3. You open an L/C for the remaining 50%.
4. We load the goods onto the vessel and submit documents to the bank.
5. The L/C is activated, we receive final payment, and you get the documents to claim your goods at the destination port.
