What is ReOrg and Why it's Critical

Every two years, we clear more swamp out of the Republican Party in Greenville County and Columbia, SC! **Let's make sure that MAGA is in control in 2025-26**, both here at home, as well as in the leadership role for the Republican party in South Carolina. All we need is your attendance on March 1, so you can vote MAGA.

The entire power structure of the Republican (GOP) party actually bubbles up from the precincts during ReOrganization, also known as "ReOrg." The few who simply show up to participate actually make the rules for all the GOP voters in the County and State!

Why do most MAGA Republicans not know about ReOrg? Because the RINOs have been in control of our State and County party for decades, and they don't want you to know about it. With your attendance and vote at ReOrg, we can change that.

We also need to make sure that Greenville County's MAGA-led Republican Party STAYS MAGA. What to do BEFORE ReOrg

- 1. Leadership should determine and arrange precinct meeting locations. Meetings must be held in a public location. They cannot be held in your home. Try to find a location that is free to use.
- 2. Suggested locations include:
 - Precinct voting place
 - Neighborhood clubhouse
 - Neighborhood church
 - Fire Station with a public meeting room
 - Library¹
- 3. Review location special requirements including:
 - Hours of operation
 - Rental fees
 - Does it require insurance
 - Restrictions on food/ beverages
 - Handicap access
 - WiFi access
- 4. Contact current precinct members, neighbors, etc. and invite them to ReOrg. Refer to the "Advertising your Meeting" section in this manual for sample emails, text messages and other marketing tools that you can use for outreach. Remind attendees to bring:
 - Driver's License
 - Voter Registration Card or Voter ID number (if you have it)
 - Check, Cash, or be prepared to pay any fees online through a link or QR code (Directions for using the payment link to Anedot are provided in this document)
- 5. Determine a Slate of America FIRST candidates to fill the precinct offices and Delegates to the County Convention.
 - Executive Committeeman (EC)
 - President
 - Vice President
 - Secretary
 - Treasurer
 - Delegates & Alternate Delegates

¹ Libraries restrict the collection of fees. If people want to pay membership dues or fees to attend the county convention, you will need to collect them using the Anedot QR code or link. See the Fee Collection page for details.



What Leaders Should Prepare or Bring to ReOrg

- Laptop Computer / Smart Phone to look up voter information
- Ink pens
- ReOrg packet with label that lists the number of Delegates to elect for your precinct
- Sign-in sheet
- Multiple copies of the meeting agenda (sample included here)
- Multiple copies* of any pre-determined precinct slate
- Form 1 enough copies for all attendees
- One copy of Form 2 (included in packet)
- Extra copies of Parliamentary Procedure wording
- Refreshments (optional)
- Signage directing people to the meeting location (optional)

If your precinct needs to elect 20 Delegates and can also elect up to 20 Alternates, you will need at least 40 copies (and please work to have that many people in attendance to fill both delegate and alternate positions for County Convention). Alternates do get called to fill in, so elect plenty.

A week or so before the meeting, talk with your invitees about the critical positions to be filled (EC and President). Determine who wants to hold a precinct office and if they can be reliable. Then you'll be able to create a "Slate" (of officers to vote for) using the included form, for distribution to the invited attendees. Having a slate makes voting smooth and fast.



Requirements to be an Executive Committeeman (EC) and Responsibilities of Precinct Officers and Delegates to the County Convention

Requirements to be an EC

- Per GCRP local Rules, each EC must have voted in at least 2 of the last 3 even-year Republican primaries to be eligible for election as precinct EC.
- Check your record at SCvotes.gov (click on Voters / Check My Voter Registration) or get your records from where you previously voted
- Younger Republicans, who may not have been of legal age for two even-year primary elections, may be voted into office but then must be confirmed by a majority vote of the Executive Committee at the next regular meeting of the Executive Committee.

County Executive Committeeman (EC)

- Attends Greenville GOP business meetings and vote on behalf of the precinct
- Maintains contact with GCRP Leadership and reports to precinct members the activities of the GCRP as appropriate.
- Begins term at the conclusion of the GCRP's County Convention.

President

- Organizes and presides at precinct meetings as needed.
- Organizes the next precinct ReOrg meeting at the end of his or her term.
- Attends Greenville GCRP business meetings.
- Serves as automatic proxy and votes at GCRP Business meetings if Executive Committeeman is unable to attend (when no proxy is given).

Secretary

- Keeps meeting records/minutes at any precinct meetings.
- Keeps a list of precinct members.



Treasurer

- Collects the funds paid by precinct members to attend the County and State Conventions.
- Receives, disburses and accounts for any funds generated by the precinct members.

Vice President

• Fills in for President and Executive Committeeman when necessary.

Delegate to the County Convention

- Attends the County Convention in April, usually on a Saturday morning.
- Votes on business matters and the election of GCRP County Officers at the Convention, to include:
 - County Chairperson
 - 1st Vice Chairperson
 - State Executive Committeeman
- Precinct Officers can and should be Delegates to the County Convention

Alternate Delegate to the County Convention

 Elected Alternate Delegates from each precinct are activated as needed at the County Convention, in the order the names are written on Form 2. They vote in place of any Delegate who has not arrived, or who must leave before voting started.



Advertising Your ReOrg Meeting

- Sample emails, letters, and text messages are provided on the following pages.
- GCRP will also be posting social media messages about ReOrg on the "Greenville GOP" Facebook page. Save some of these graphics to your phone and then share. Digital invites work because they're easy to share and engaging. We also encourage you to comment on any posts and indicate that you'll attend. Most importantly, we need you to "Like" and "Share" these posts to your own Facebook page, so your family, friends and neighbors become informed about ReOrg.
- There will be a 4-page newspaper available at the GCRP office, as a door hanger about ReOrg. There will be a small charge for each paper.
- Zoom Calls Beginning February 11, GCRP member Joe C will be doing 'Speed ReOrg Training' twice a day via zoom at noon and 5pm for anyone to attend and learn more about ReOrg. You can ask questions about running your meeting. And potential attendees can find out the basics about ReOrg and why this meeting is so important. How to Run Your Precinct ReOrg Meeting

- The precinct president, vice president or person designated by the County Chair should call the meeting to order and proceed by the agenda. A sample agenda should is provided on page 16.
- 2. **Familiarize yourself** with the materials in the packet as well as the proper procedures explained throughout the manual.
 - Prior to the meeting starting, secure volunteers to offer the invocation/prayer, lead the Pledge of Allegiance, and recite the Republican Creed (provided in this manual).
- 3. Also ensure that whoever plans to nominate your America FIRST slate **knows the proper parliamentary procedure wording** or can refer to it at their table.
- 4. At the beginning of the meeting all attendees MUST complete the top half of Form 1 with their name, address and voter registration number. This Form 1 document will serve as a certified roll sheet and will certify the individual names of those in attendance.
- 5. The person planning to be the temporary credentials committee should sit at the sign-in table and confirm everyone's precinct membership on SCVotes.gov.
- 6. At the sign-in table, have multiple copies of:
 - the meeting agenda
 - your America FIRST Slate
 - the Parliamentary Procedures for elections
 - fee schedule
- Only people in attendance may fill out a Form 1; no proxy forms are allowed. A valid voter registration certificate in that precinct must accompany each membership signature on the form (State Party Rule 4c-3).
- 8. Adjustments/edits to Form 1 cannot be made after this meeting under any circumstances.



- 9. To verify membership within the precinct, and thus qualify to vote in ReOrg, each participant must have a current, valid voter registration card in that precinct² or the voter registration must be verified via *SCVotes.gov*
- 10. Following the sample agenda (provided in this manual), the Precinct President or such person designated by the County Chair must call the meeting to Order by stating something like "May I have your attention please. I call this meeting to Order."
- 11. **Follow proper parliamentary procedure** (Roberts Rules of Order) **throughout the meeting**, especially during the later election of officers and delegates/alternates. (Included in this manual for reference).
- 12. **Open the floor for nominations** for the **Election of Temporary Officers** using the sample wording from the Parliamentary Procedures page. You need to elect:
 - Temporary President
 - Temporary Secretary
 - Committee on Credentials (can be one or more people)

The newly elected temporary president will then run the remainder of the meeting.

- 13. The credentials committee shall report the names of those in attendance who are eligible for membership, verifying that each member is in fact eligible for membership / registered voter in the precinct.
- 14. Read or explain the responsibilities of the Precinct EC, President and other precinct officers to the attendees. (Descriptions are provided in this manual). One person may not hold more than one office unless there are fewer than five (5) people present at the meeting.
- 15. Election of America FIRST Slate of Officers, Delegates and Alternates. Using the sample wording from the Parliamentary Procedures page, open the floor for someone to nominate the slate as written.

² Either of the following per State Party Rule 4-c-5 and 4-c-3: (1) the person having voted in the election designated for the purposes of delegate allocation or (2) the person being elected to membership at a precinct meeting.



If the America FIRST Slate is approved, then your elections are complete and you can move on to any resolutions, new business, announcement, then adjourn.

If the America FIRST Slate is not approved, then you will need to hold elections for individual offices and delegate/alternate positions.

- 16. Thank the winners and announce that the term for newly elected officers starts immediately after the County Convention in April.
- 17. Announce to Precinct members that **if they wish to attend the County Convention in April**, to vote on county GOP leadership, they must check the box "I attended my precinct meeting in person" on their Form 1. There is also a small fee associated with attending. All fees are listed on the next page.
- 18. Precinct Members who wish to be a Candidate to the SCGOP State Convention in May 2025 <u>must also be County Delegates</u> and must check the designated box on Form 1 which includes the following Pledge: "I have voted in 2 of the last 3 GOP Primaries". (State Party Rule 2-f). This will be verified by the county and state before your name is put on the ballot. Go to *SCVotes.gov* to check your voting record.
- 19. Once the election of your America FIRST Slate is complete, ask if there are any Resolutions to review and be voted on (usually there is none).
- 20. If none, then ask if there is any New Business (usually there is none), or Announcements.
- 21. After all new business has been conducted, each precinct member must sign and date the Precinct ReOrganization Form 1.
 - If you were elected to an office, please circle the office.
 - If you were elected as a delegate or alternate to the County Convention, please check the appropriate box.
 - This portion of the form will reflect the results of the elections held at the precinct meeting.



- 22. Precinct President and Secretaty must verify & sign the bottom of Form 1 and complete Precinct ReOrg Form 2. This form should reflect the results of the elections held at the meeting (this is a final report on all business conducted during the precinct meeting).
- 23. **Existing treasurer collects all relevant fees** according to the fee schedule included in this packet, and notes cash, check or online payment for each attendee.
- 24. Adjourn the meeting
- 25. <u>Take a picture or copy of all completed Form 1s AND Form 2 in case one or more is lost.</u>
- 26. Give all forms and payments to the existing President at the end of the meeting. The President then brings all Form 1s, the Form 2 and any payments to GCRP County Office at 2505 Wade Hampton Blvd as soon as possible but not later than 5 days after the meeting.





FEE SCHEDULE

Make any check payable to GCRP. Voluntary membership in GCRP is encouraged to support local efforts and initiatives.

- \$25 for individual membership; includes fee to attend County Convention as delegate (\$20) or alternate (\$10). Convention date, Saturday April 14.
- \$40 for joint membership; includes a fee for 2 people to attend the County Convention as delegate (\$20 each) or alternate (\$10 each). Convention date, Saturday April 14.
- \$15 to be a candidate to attend the State Convention in May (Saturday, May 3rd).

You can also pay online using this link to Anedot: https://secure.anedot.com/gcrp/ReOrg or via the QR Code below Once the member has paid online, they will let the treasurer know so they can mark them as paid via Anedot on their Form 1. There is no specific place on Form 1 to indicate online payment, so please just note it at the bottom of the page.





Precinct Makeup Meeting (Date TBD)

- The County Chair will set up a Precinct Make-Up Meeting (date TBD) no later than five days prior to the County Convention for precincts that failed to have anyone attend the March 1 meeting or that need to conduct further business, such as electing precinct officers or filling their delegate/alternate allotment to County Convention (State Party Rule 4-b-1).
- The make-up meeting for all 151 precincts shall be held in one central location in the county and shall be properly advertised (State Party Rule 4-b-1). Counties may use a County Party meeting to conduct this business.
- Current County Leaders will assist attendees with conducting makeup meetings. Newly elected precinct officers may attend if they like, but DO NOT need to attend.

Precinct members who were elected to an officer position at the March 1 ReOrg meeting, but were unable to attend the March 1 meeting need to attend this meeting so they can complete their Form 1.

Any member who DID NOT attend the March 1 ReOrg meeting and wants to be a precinct officer or Delegate needs to attend this meeting.



State Party Rule 4- Precinct Organization

(a) Initial Organization

- (1) Initial organization of a precinct in a county that does not have a county organization that is recognized by the State Executive Committee shall be in accordance with such instructions and procedures as the State Chairman shall direct. Such initial organization may be accomplished at any time in the manner as hereinafter stated.
- (2) Initial organization of a precinct in a county that has a county party organization, which is recognized by the State Executive Committee, shall be under the direction of the County Chairman, their designee, State Chairman or other Party official designated by the State Chairman upon noncompliance or refusal by County Chairman. Precincts undergoing initial organization that did not go through ReOrganization may be organized at any time and shall be immediately recognized by the County Executive Committee without a makeup meeting.

(b) ReOrganization

- (1) Organized precincts shall meet during the month of March at an appropriate place within the county at a time and day set by the County Executive Committee of each non-general election year, or at such other time and date as may be required by law for ReOrganization.
- (c) Proceedings In all organization and ReOrganization meetings of precinct, business may be conducted as follows:
- (1) The meeting shall be called to order by the precinct president or vice president, if the president is not present, in an organized precinct. In an unorganized precinct, the meeting shall be called to order by such person as may have been designated by the county chairman (or State Chairman, if applicable) to arrange the meeting, and if none, then by some person in attendance who is eligible for membership in the precinct. See Rule 4(c)(3) for eligibility requirements.
- **(2)** A temporary president, a temporary secretary, and a committee on credentials for the purpose of organizing or ReOrganizing shall be elected.
- (3) The credentials committee shall report the names of those in attendance who are eligible for membership and who have signed the membership roll, verifying that each member is in fact eligible for membership. Membership eligibility is determined by the



member having a current, valid voter registration certificate in that precinct, and either (1) the person having voted in the election designated for the purposes of delegate allocation set forth in Rule 4(c)(5) or (2) the person being elected to membership at a precinct South Carolina Republican Party Rules 8 meeting.

- (4) When organized, a permanent president, one or more vice-presidents, a secretary, a treasurer, and a county committeeman to the county executive committee (a minimum of five (5) officers) may be elected. One person may not hold more than one office unless there are fewer than five people present at the meeting. Such committees as may be desired may be created. Precinct officers do not assume the duties of their office until after the county convention set forth in Rule 5(b) has been held, unless they are elected from a precinct not organized during the month of March under regular precinct ReOrganization.
- (5) Delegates and alternates to the county convention shall be elected from among the members of the precinct in attendance at the ReOrganization meeting. In situations where there are more members present wishing to run for county delegate than delegate positions available, a vote shall be taken with each present eligible member having as many votes to cast as delegate positions available. In the case of fewer members present than delegate slots allotted, all members shall become delegates. A list of the candidates showing total votes received shall be arranged in descending order of the number of votes received. In the case of a tie, the position of the tying candidates on the list shall be determined by drawing lots. Those candidates with the most votes shall be delegates, and the rest shall be alternates in descending order of the total number of votes received.
 - (6) *Rule Not Applicable
- (7) The precinct secretary and precinct president shall certify the names of precinct members, precinct officers and delegates and alternates, along with their own certifications, to the county chairman no later than five (5) days following the initial precinct meeting.
- (8) Vacancies in any precinct delegation at any county convention or reconvened convention shall be filled from among the alternate delegates present.
- (9) No delegate or alternate shall be elected by the precinct less than five (5) days before the County Convention. A certified list of precinct members, precinct officers and delegates and alternates shall be forwarded to the state chairman by the county chairman no later than seven (7) days following the initial meeting, and no later than three (3) days after a make-up meeting.
 - (10) The county chairman shall make the certified list of delegates and alternates to



the county convention available to any delegate, alternate or precinct officer no later than three (3) days after a makeup meeting. Upon receipt of the lists from the precinct, the county chairman shall promptly notify the precinct president of any irregularities found therein, and conversely, the precinct president shall South Carolina Republican Party Rules 9 be informed if the lists are in order.

(11) The county chairman shall also set a date for a make-up meeting no later than five (5) days prior to the county convention for precincts that have failed to organize or reorganize or that need to conduct further business, including the ability of precincts to fulfill their delegate allotment to the county convention. The make-up meeting for all precincts shall be held in one central location in the county and shall be properly advertised. In the delegate election process for the make-up meeting, delegate positions shall be filled first from among individuals who attend the meeting in person, then by individuals whose membership is set forth in the poll list of the preceding primary election and/or those who are absent from the meeting but who have submitted the properly signed forms. No member absent from the meeting may cast a vote, but they may be voted for and considered a candidate.

RULE 2(2) as currently numbered – Modify the existing rule as follows:

(e) "All elections to a party office at all levels of organization shall be decided by a majority vote unless otherwise directed by the rules; all delegates shall be elected by plurality vote. Candidates must be a member of a precinct or convention body to be eligible for election by the body at each respective level. Candidates for party office above the precinct level, as well as for delegate to the State and National Conventions must have voted in at least two (2) of the three (3) most recent statewide Republican primaries, either in this or any previous state of residence, provided they were old enough to have done so."

(Rationale: This clarifies that someone must be a member of a body in order for the other members of the body to elect them to any office, as well as establishing an objective minimum standard of support for the Republican Party in order to run for Party office or delegate positions to the state and/or national conventions.)

Sample Parliamentary Procedures

- Having a prepared Slate is beneficial to having a smooth and organized meeting. Our precincts will have mostly "uncontested" officer elections, which means "no competition for each nominated position." A few precincts, however, will have "contested elections" with multiple nominees for the same position.
- Below is the Parliamentary Procedure if you have a completed America FIRST slate. If you don't have a prepared AF Slate, the Parliamentary Procedures you need to follow for your elections can be found at the end of this document.

 - President: It has been moved and seconded that the nominations be closed. All those in favor of the America First Slate for Precinct officers, delegates and alternates, signify by saying 'aye,' and those opposed by saying 'no.' All those in favor? All opposed?

FAQs

 Can Precinct Officers also be Delegates/Alternates to the County Convention?

Yes, Precinct Officers can and should be delegates to the County Convention.

- Can a person be elected to more than one office?

 One person may not hold more than one office unless there are fewer than five (5) people present at the meeting.
- Can any adjustments be made to a Form 1 document after it has been submitted to GCRP?

No adjustments or changes can be made to a form 1 document after this meeting under any circumstances.

- Can anyone who attends ReOrg be elected to the EC office?

 Yes, anyone can be elected as an EC as long as they are registered voter in that precinct, and they have voted in the Republican Primary in 2 of the last 3 even-year primaries.
- Can anyone who attends ReOrg be elected as a Delegate or Alternate to the County Convention?

Yes, anyone can be elected to the County Convention as long as they are a registered voter in that precinct.

 Can anyone who attends ReOrg be elected as a Delegate or Alternate to the State Convention?

To be included on the ballot to be elected to the State Convention you must show that you have voted in two of the last three statewide Republican primaries either in this state or any previous state of record, provided they were old enough to have done so. This can be done by looking at their voter record on SCVotes.gov. for South Carolina primaries. For other states voting records, they would need to provide that information. You also have to pay the appropriate fee.
