

## HOLT VILLAGE HALL - Appendix 1 Premises Licensing Conditions

### CONDITIONS FOR THE SALE OF ALCOHOL

#### **Holt Village Hall , The Street Holt is licenced under the 2003 Act for the Sale of Alchaol (and other activities) Premises Licence Number W1100048LAPRVA**

1. Supply of alcohol under the premises licence must be made or authorised by the management committee.
2. If the hirer wishes to sell alcohol on the premises, a responsible person must be nominated and that name provided to the booking secretary. The hirer must accept ultimate responsibility for the management of the bar.
3. The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. An irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children:
  - a) Games or other activities which require or encourage, or are designed to require or encourage, individuals to:
    - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol).
    - drink as much alcohol as possible (whether within a time limit or otherwise);
  - b) Provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
  - c) Provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
  - d) Provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on:
    - the outcome of a race, competition or other event or process
    - the likelihood of anything occurring or not occurring
  - e) Selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
4. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
5. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available. When dancing takes place after 23.00 hours in any premises, the responsible person shall ensure that there is an adequately signed free portable water supply within at least one area of the premises, excluding the kitchen, and that free drinking vessels are available when necessary.
6. The premises licence holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
7. The responsible person shall ensure that where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:

• Beer or cider:	½ pint
• Gin, rum, vodka or whisky:	25 ml or 35 ml
• Still wine in a glass:	125 ml

Customers must be made aware of the availability of these measures.
8. Individuals who are present to guard against:
  - a) Unauthorised access or occupation (e.g. through door supervision)
  - b) Outbreaks of disorder
  - c) Damagemust be licensed by the Security Industry Authority.
9. Due to the location of the Hall in a residential area and with due consideration to our neighbours, **-sales of alcohol to stop 30 minutes before the end of the event to allow for drinking up, and unless agreed otherwise in writing: music to stop by 23.00, Hall locked up by 23.30**

Noise generated by the premises should be kept at such a level at the boundary of any occupied property that it would be unlikely to be a nuisance to the occupier. The Licence Holder shall monitor noise at the boundary of dwellings likely to be affected on at least a minimum of three occasions during each event to prevent the condition being breached and shall maintain a written record of such monitoring, available for inspection at any reasonable time. When the venue is let to a second party then the Licence Holder shall ensure the second party enforces this provision. The hirer must:

  - Ensure that noise emanating from the premises is kept to an acceptable level;
  - Not allow disorderly conduct on licensed premises;
  - Not sell alcohol to a person who is drunk;  
Not to sell alcohol to those aged under 18, unless they are eating a table meal, in which case no alcohol shall be supplied to those under 16 years.
