### **Terms & Conditions**

KLW shall provide a limited warranty for each of the products against defects in material and workmanship under normal use and service for a period of 30-days from the date of delivery to the retailer.

This does not extend to problems that arise from normal wear and tear or misuse and abuse. Belts and accessories that have been altered (stretched, cutting, addition of holes or any other alteration) prevent us from determining if the merchandise is defective in materials and workmanship, and for this reason, cannot be considered for credit, repair or replacement.

Because our leathers are natural products, there may be some irregularities and variations in color and texture. These traits are characteristic of fine leathers and add to the aesthetics and character of the product. These variations and irregularities are not covered under the limited warranty.

If retailer feels they have received a defective piece of merchandise, we request photos of product be submitted to KLW for evaluation at [kyleatherworks@gmail.com](mailto:kyleatherworks@gmail.com). If product is deemed covered under limited warranty, KLW will replace the product.
