

## Muscle Coin (MSCL) – Short Summary

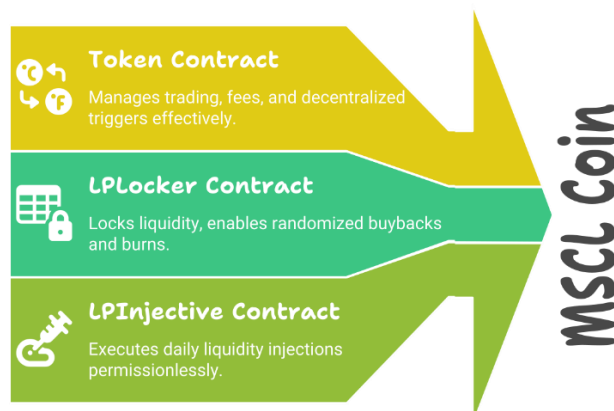
Muscle Coin (MSCL) is an antifragile, meme-powered BEP-20 token designed to have fun in volatile markets. Built from scratch by an experienced developer, MSCL combines serious tokenomics with meme culture to create a decentralized, self-sustaining ecosystem that strengthens with every trade.

- **Max. Supply:** 21 billion MSCL
- **Launch Model:** 100% supply to liquidity over 21 days
- **No Presale. No Team Allocation. No Hidden Funding.**
- **Core Philosophy:** Fair, decentralized, manipulation-resistant

## What Makes MSCL Different?

- **Fair Launch, Pre-Announced** – No presale, no private deals, no hidden allocations. Launch date and time are announced in advance, giving all participants equal opportunity.
- **21-Day Progressive Liquidity Release** – 100% of supply is injected into liquidity over 21 days via public triggers, ensuring no early dumps or insider advantages.
- **Antifragile by Design** – Gains strength from volatility, using burns, buybacks, and progressive liquidity to reward activity.
- **Fully Decentralized** – No owner control, no admin keys, and no manual overrides.
- **Permissionless Triggers** – Anyone can execute liquidity injections, burns, or buybacks.
- **Immutable Code** – Once deployed, the contract runs without control.

## Core Features

### 1. Progressive Daily Liquidity Injection (PDLI)

- **Purpose:** A groundbreaking mechanism that prevents market manipulation by gradually releasing liquidity over 21 days — the first of its kind in meme coin history.
- **How it Works:**
  - Day 1: 1 billion of supply paired with \$1000 BNB goes into liquidity and is locked.

- Remaining 20 billion: Released in 20 equal daily injections, each public-triggered managed by ownerless smart contract.
- **Benefits:**
  - Fair market entry
  - Strong liquidity growth
  - Transparent on-chain tracking

### **MSCL Launch: A Truly Fair Start**

There are **no coins allocated to the team**. Although the team contributes funds for initial liquidity and advertising, they **do not reserve any tokens for themselves**, associates, or promotions. The team starts at the exact same time as everyone else; **no privileges, no insider advantage**. This ensures **a truly fair launch** where everyone begins equally. A launch model this transparent and community-first is **rarely seen in the meme coin space**.

---

## **2. Automated Treasury Buyback & Burns**

- **Every 5 days LP Unlocks:** Randomized (0.1%, 1.25%, or 2.5%) unlock to create unpredictable supply shocks - public-triggered managed by renounced smart contract (zero owner).
  - **Two-Step Burn:**
    1. Burn MSCL from unlocked LP.
    2. Use paired BNB to buy back and burn more MSCL.
  - **Impact:**
    - Continuous deflation (~2.5% on average LP burned every 5 days)
    - Price pressure that attracts traders
    - Cyclical Strength: more trades → more fees → stronger liquidity → more trades

## **3. Fee System**

- A 2.5% LP fee applies to both buy and sell transactions, with no fee on transfers.
- **100% of fees go back into liquidity** – no team wallets, no external claims.

Because buyback and burn occur every 5 days (up to 5% of MSCL tokens burned from the LP pool), you effectively pay no overall fee.

## **4. Anti-Bot & Market Protection**

- **Randomized Trigger Delay:** 0–300s unpredictability for all public triggers, preventing bots from timing events.

## 5. Protocol Mechanics

- **LP Burns & Buybacks:** Community-triggered deflation cycles.
  - **Auto Liquidity Swaps:** Contract swaps collected fees and adds to LP automatically.
  - **Immutable & Trustless:** Ownership renounced, code verified on BscScan.

## Why MSCL is Antifragile

- **Volatility = Strength:** More trades → more fees → more liquidity → stronger trading floor.
  - **Randomized Burns:** Creates unpredictable supply shocks, rewarding coin eco systems
  - **Decentralized Control:** No one has a control or exploit the system.
