## 1. Orders & Pricing

## 2. Payment Terms

- 30% Advance: via T/T on order confirmation.
- 70% Balance: via T/T within 5 days of receiving scanned shipping documents (BL, Invoice, Packing List).

## 3. Shipping & Delivery

- Goods are shipped FOB, CIF, or as agreed.
- Delivery dates are estimates; JM Impex is not responsible for delays due to transport, customs, or unforeseen events.

## 4. Quality & Claims

- All products meet international quality standards.
- Claims for damaged or non-conforming goods must be reported within 7 days.

- Governed by Madagascar law; disputes fall under Madagascar courts unless agreed otherwise.
