Second Line: Compliance Management

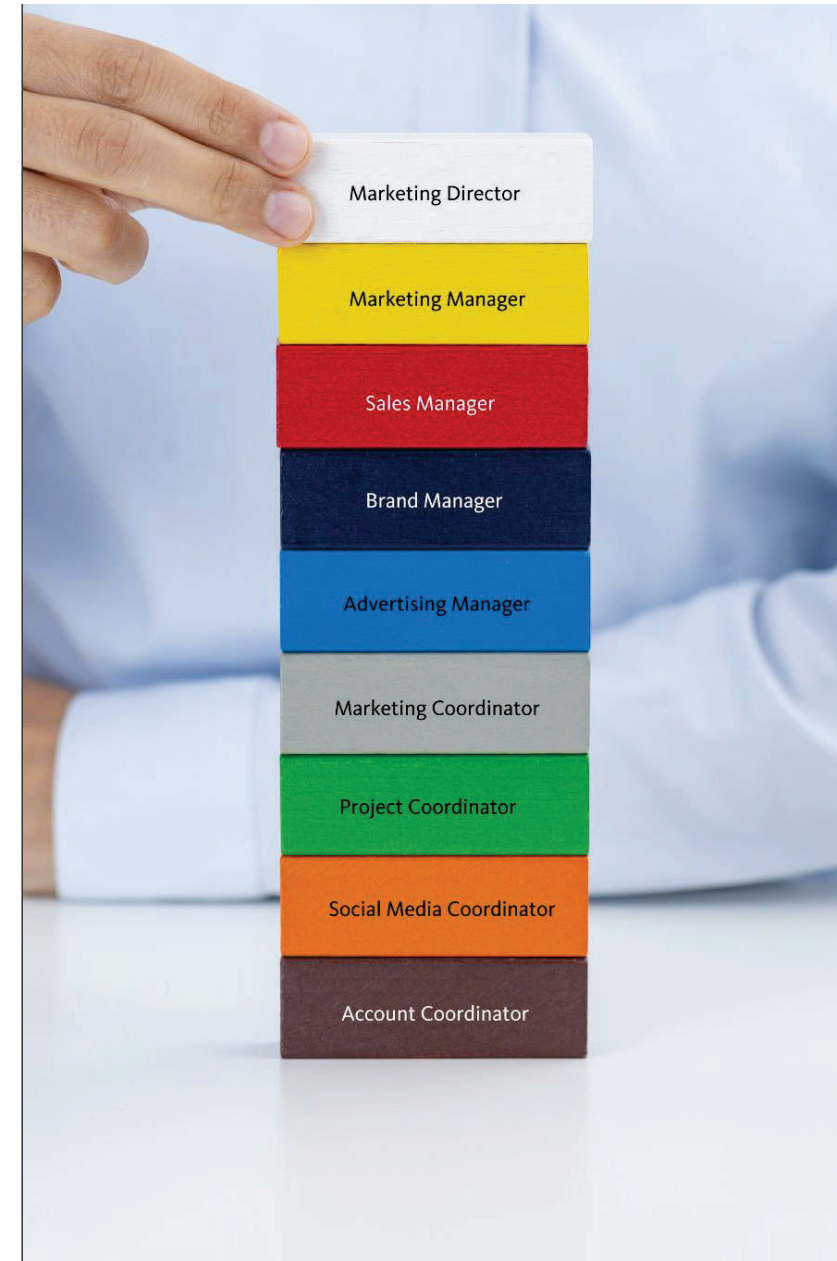
Compliance Management monitors risk frameworks and ensures regulatory alignment and compliance.

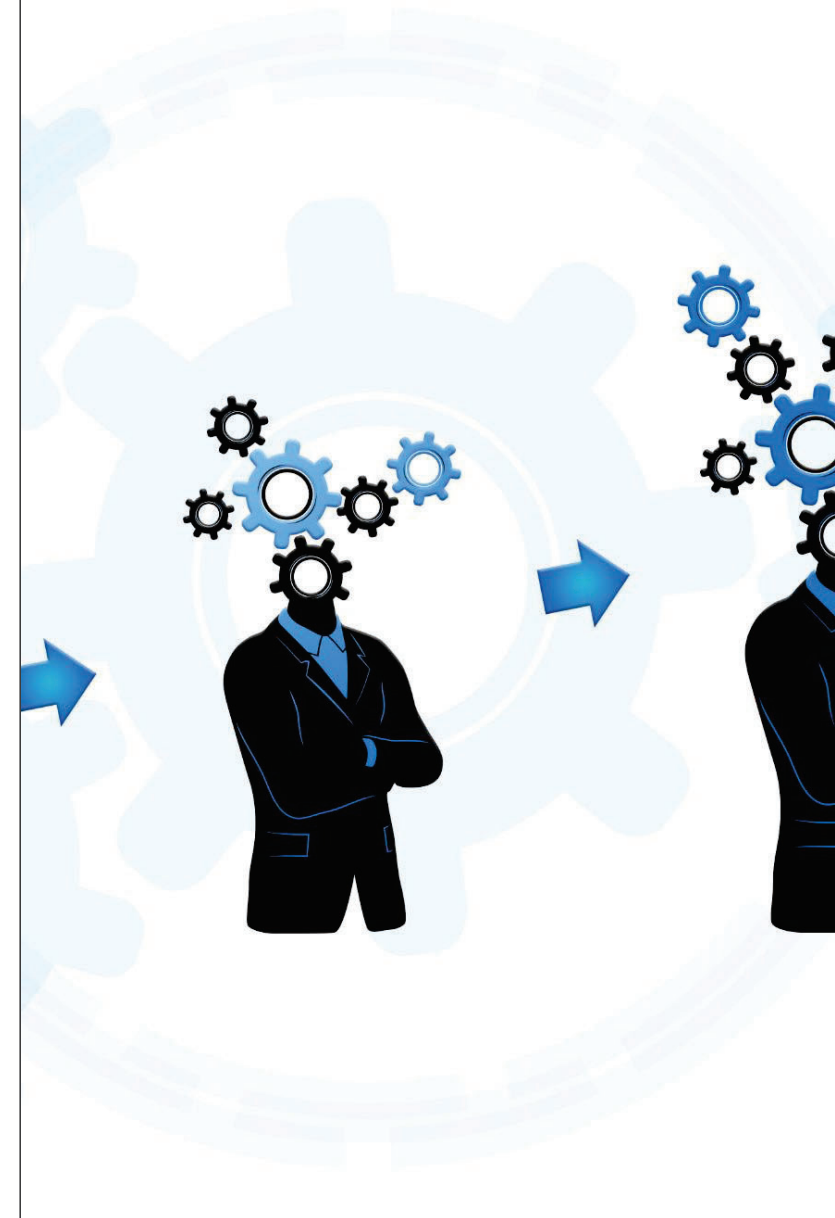
