#### e-SDS 2026: The Ultimate Conversion Guide for SMEs

Are You Really Ready for the Digital Requirements from May 2026?

Why This Topic is Urgent Now

From May 2026, new or amended safety data sheets (SDS) must be updated, including new Hazard Classes (ED, PBT/vPvB) according to Delegated Regulation (EU) 2023/707. SDS must be structured (e-SDS format) for PCN submission via IUCLID, with UFI, QR code for digital access, and ECHA-compatible data (Source: ECHA).

From January 2027, this applies to all existing SDS.

- Simple PDF-SDS are no longer sufficient; they must be machine-readable (XML/IUCLID)
- QR code recommended for quick access to the current version
- Poison Centre Notification (PCN) expanded with new classes

2.	$\square$ You have no access to IUCLID/ECHA-Cloud $\rightarrow$ Without it, no PCN submission
3.	$\square$ Your SDS is older than 3 years $\rightarrow$ Must be updated anyway (new Hazard Classes)
4.	☐ You have no current exposure scenarios → Mandatory for >10 t/year (REACH
	Annex)
5.	$\square$ The UFI code is missing or incorrect $\rightarrow$ Immediate violation in PCN
6.	$\square$ You plan to do it yourself $\rightarrow$ Risk: Expensive errors + time loss (up to 50
	hours/SDS)

Your Points: out of 10 (the more checks, the higher the risk)
What You Absolutely Should Do Now (the 5 Most Important Steps – High-Level)

- 1. Inventory of all your SDS (number, age, complexity; prioritize >10 t/year products)
- 2. Check if you have IUCLID access and data (UFI, classifications) are current
- 3. Test a first SDS in structured format (IUCLID export; often fails due to XML errors)
- 4. Plan how to provide new SDS digitally/PCN-compliant from May 2026 (incl. QR for e-access)
- 5. Decide: Do it yourself (high time expenditure + risk) or hire experts (safe & fast, e.g., for pharma/chemistry-specific adjustments)

Conclusion: The implementation is more complex than it looks. Many SMEs lose 20–50 hours per SDS or end up paying consultants anyway. With timely planning, you save costs (Source: ECHA guides).
