## General Terms and Conditions

The following terms and conditions apply to all contracts concluded between the trainer Hinako Sakuraoka and her participants. They also apply to all courses offered.

### 1. Conclusion of contract and subject matter

Courses are offered in the form of monthly contracts, individual, or package bookings (e.g., 10-session cards). Each lesson lasts 60 minutes. Enrollment in a course is binding and obligates payment of the course fee.

An individual lesson or a duo lesson must be paid in cash or by bank transfer before each lesson begins. If a package is booked, such as a 10-session card, it must also be paid in cash or by bank transfer before the first lesson begins.

All amounts are gross price. A 10-class pass is valid for 4 months from the date of purchase.

### 2. Cancellation of course sessions

Individual and group training sessions agreed upon orally or in writing must be canceled by the member at least 24 hours in advance. If this deadline is missed, the cost for the missed training session will be charged in full.

### 3. Withdrawal from Teacher Training

Withdrawal from a teacher training registration can be done at any time without stating reasons in writing (by post or email). If the withdrawal occurs within 14 days of invoicing, it will be fully refunded 100 %. After this period, the participant is obliged to pay the following compensation to the trainer:

25 % of the invoice amount for withdrawal from the 15th day after invoicing up to the 15th day before the start of the teacher training.

50 % of the invoice amount for withdrawal from the 14th day to the 8th day before the start of the teacher training.

100 % of the invoice amount for withdrawal from the 7th day up to the start of the teacher training.

The compensation is due immediately upon receipt of the corresponding invoice. If the compensation is not received by the trainer within 14 days after receiving the invoice, the full original invoice amount becomes due.

The right to extraordinary termination for good cause remains unaffected.

#### 4. Transfer of contract

Transfer of the contract to third parties is excluded. Participation in courses is also non-transferable.

#### 5. Behavioral rules and liability

Participants attend the training at their own risk. The trainer assumes no liability for injuries and their consequences that occur in connection with the courses/training.

The participant is not insured against accidents, illnesses, and the loss of personal items that occur due to their own fault during the courses/training. No liability is assumed for wardrobes either.

#### 6. Requirements on the participant

The participant is fundamentally responsible for ensuring that he or she meets the requirements necessary for the course/training and is particularly health-wise capable of participating. If the participant is unsure whether he or she meets the requirements in full or in part, the trainer recommends undergoing a medical examination before the start of the course/training and obtaining certification as »physically and mentally fit for fitness training, health courses, and mental work.«

Additionally, the participant confirms that he or she has fully understood all the safety instructions and instructions for the safe and healthy execution of an exercise or correct use of small equipment provided by the trainer and confirms that he or she voluntarily and willingly can carry out these instructions. The trainer assumes no liability for accidents due to inattention or other reasons.

The participant is obliged to ensure that he or she has health and accident insurance.
