ORDINANCE NO. 416

AN ORDINANCE REGULATING TRAFFIC WITHIN THE CORPORATED LIMITS OF THE CITY OF HAVILAND, KANSAS: INCORPORATING BY REFERENCE THE LEAGUE OF KANSAS MUNICIPALITIES 2025 STANDARD TRAFFIC ORDINANCE, 52nd EDITION; PROVIDING CERTAIN PENALTIES AND REPEALING ORDINANCE NO. 409.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF HAVILAND, KANSAS:

SECTION 1. There is hereby adopted and incorporated by reference for the purpose of regulating traffic within the Corporate Limits of the City of Haviland, Kansas, that certain standard traffic ordinance known as the *2025 Standard Traffic Ordinance, 52nd Edition*, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas, such code being made as a part of the ordinances and code of the City as if the same had been set out in full herein, all as authorized and in the manner proscribed by K.S.A. 12-3009 through 12-3012 and K.S.A. 12-3301 and 12-3302. There shall be at least one official copy of the *2025 Standard Traffic Ordinance, 52nd edition*, on file with the city clerk which shall be marked or stamped, "Official Copy as Adopted by Ordinance No. 416" and to which shall be attached a copy of this ordinance and filed with the city clerk to be open to inspection and available to the public at all reasonable hours.

SECTION 2. An ordinance traffic infraction is a violation of any section of this ordinance that prescribes or requires the same behavior as that prescribed or required by a statutory provision that is classified as a traffic infraction in K.S.A. 8-2118. All traffic violations that are included within this ordinance, and are not ordinance traffic infractions, as defined in subsection (a) of this section, shall be considered traffic offenses.

SECTION 3. The fine for violation of an ordinance traffic infraction or any other traffic offense for which the municipal judge establishes a fine in a fine schedule shall not be less than \$30.00 nor more than \$500, except for speeding which shall not be less than \$45.00 nor more than \$500. A person tried and convicted for violation of an ordinance traffic infraction or other traffic offense for which a fine has been established in a schedule of fines shall pay a fine fixed by the Court not to exceed \$500.00.


SECTION 4. Ordinance No. 409, adopting the *2024 Standard Traffic Ordinance, 51st Edition*, is hereby repealed.

SECTION 5. This ordinance shall be in full force and effect from and after its publication once in the official City newspaper.
