Posted front and center to defend the Federal cannon, The Marine Battalion and the New York Fire Zouave Regiment Were shot to pieces and withdrew. The 7th New York Militia Regiment of silk stocking dandies and gentlemen Should have stepped up, taken its beating and triumphed. However, just weeks before, rich Mamas back in New York Got them discharged from service and shipped home. Everyone on the cannon line was cut down or swept away. Charging Rebels turned the guns on a Federal ammunition wagon. Big explosion, panic, Union rout. Nowadays, Anacostia is the East Coast Marine spook shop. A few hundred qualified riflemen, TV-briefed in real time? Why were they not lined up on the Capitol steps? If only symbolically, in dress blues, at ease behind police lines? Or a visible Company in riot gear, its Battalion support under cover? Either way, no trouble. Fort Belvoir once housed an Armored Cavalry Regiment. I don't know. A few National Guard battalions are tucked miles from DC down secondary roads. Thousands of cops in DC. tens of thousands of police? Federal, Park, Executive Secret Service and Departmental, Contract, Armed Forces, Tri-State, Municipal and County. Not to mention bloated intelligence shops around DC: Contract workers by the hundreds of thousands, so far successful At suppressing terror (or error) attacks, Nuke or bio, state actor or non-, external or black flag. There's the Third Infantry Regiment at Fort Myer, Arlington: Two battalions of palace guards, per their website, With standing orders to defend the Capital against insurrection. The Pentagon could have launched thousands of troops

From its warrior ant nest across the Potomac, By the bus and subway load, to flood it and swarm trouble.

When Fort Sumter's bombardment set off the first Civil War, Federal facilities were lost to rebel militia and turncoat officers. No-one from top to bottom knew what to do. Troops loyal to the Union sat stunned Their officers paralyzed by circumstantial orders, no orders, wait, Contradictory, delayed, betrayed or nothing. The Merrimack's hull of Monitor-fought fame Was burned to the water line and surrendered to local rebels without a fight, Along with many southern ports, forts and arsenals. The pro-slaver Congress stockpiled Southern arms And starved those elsewhere (in the West, in the North), Just like today's military-industrial complex Has been monopolized By Repugnants, far from Democratic cities. So, after the Civil War, Every officer candidate in military academies and schools Was taught a standard rule. "In the event of trouble or suspected insurrection, Rally loyal troops and occupy Federal facilities. Until further orders, defend them against any comer, With lethal force if necessary." Nothing circumstantial, no uncertainty, No waiting around to be told what to do. "Move out fast and stand your post. Wait for new orders from the real chain of command, From the Federal Government that pays your salt." Those who held to this longstanding rule Were grounded on 1/6 from the top down, Like the USAF on 9/11. I fear for this country, even more so than prior. It is bad enough if the military are muzzled, Worse yet if they muzzle themselves. Democracy chugs along with more or less honesty; Collects taxes, pays the nation's bills, runs the mail, Keeps things on even keel indefinitely. Dictatorship sucks a country dry and then implodes. Not to mention its many innocent victims: A disgrace reduced by Democracy at its best, Proudly maximized by the other kind. An army of draftees underserves a military coup. They would mutiny or just go home.

So where were you , My father's Army, On January 6, 2022? Just Whose Presidency Was Stolen?, notes before the Second Civil War #3

During the Presidential election of 2016, both Parties had to carry three States or lose: Pennsylvania, Michigan and Wisconsin. Republicans and Democrats gerrymandered voting districts as lopsidedly as the Supreme Court allowed. But I'm going off topic (see later). State-level gerrymanders just promote crooked State officials, insane legislation or none, and terrorized voting station volunteers. As for the Presidential election, it was best defrauded by the electoral college. At least until now.

Before 2016, all three States polled as Hilary Clinton victories. Trump won all three. Already polled ahead by 3.5 points in Ohio, Trump won there by 8.1 points. Clinton polled ahead by 3 points in Iowa, but Trump won there with an incredible 13 point lead.

Appointed FBI Director by Obama, James Comey announced the investigation of a Clinton e-mail fumble ten days before the election. His announcement shifted several percentage points of undecided electors Trump's way, pushing him closer to a victory contrary to the polls. Once that announcement had served its purpose, the FBI dropped the charge for lack of evidence. Comey should have shut his fat mouth pending sufficient evidence, per standard FBI protocol.

In another incident, March 2016, Russian intelligence phished emails from Clinton campaign officials. They got access to the messages of over one hundred of her co-workers. The FBI did not report the crime at the time; it has muddied that evidence since.

Those emails must have included details about deep purple electoral districts in purple States. Neither Republican red nor Democratic blue, they could go either way. If one party could win all those special districts, some by just a few hundred votes, it might obtain all the State's electoral college votes without needing the State majority.

Those districts therefor drew special attention from both sides: more grass roots campaigning by Democrats, more MAGA Republican rallies and unspecified "outside interference" by not-so-covert allies. Trump won all the toss-up districts in key States. They were mandatory without exception for him to win. If he didn't cheat, he had a 50-50 chance to win each one. He won them all.

While the 2016 Wisconsin vote recount found nothing fishy, those in Pennsylvania and Michigan were cut short by judicial decree. Most of the fifty States never got a recount, despite election returns way off from polling predictions.

"It was the pollsters' fault. Each of them got four years of state-of-the-art research wrong. Trump was 'much more popular' than his electors admitted. They were 'too embarrassed to admit to pollsters' they favored such a viper." Subjective bullshit journalism to cover unbelievable statistics

Trumpoids filed many appeals and recounts after the 2020 defeat, whether he lost that State or not. His Royal Narcissism should have won many more votes everywhere; his election was obviously stolen! The paid media and Beltway bureaucrats have repeated his lies a thousandfold since, despite zero evidence after countless hearings. Trump's loss

to Biden was about as fair as American elections get. Repubs and Dems had good reason to keep elections mostly honest up 'til then. No longer.

We should exclude Gore's 2000 surrender to Bush the Lesser, based on the recount of a few hundred extremely questionable returns, so .000...01 percent of the Florida vote. Gore won a national majority against Bush, and lost; Clinton won it against Trump, and lost; Biden did too against Trump, and won. Gore's win was blocked by a howling mob in Florida, the way they would shout down a Little League softball score, then by the Supreme Court just as intransigent.

The 2016 Trump upset didn't trigger the scrutiny Republicans demanded from Biden in 2020. On the contrary, no effort was made to evaluate the security of voting machines some of which produced no paper trail. In some States, every election machine contractor was a Republican, as were their software programmers and all the officials supposed to monitor and pay for them. Later on, amateur hackers found they could break into old voting machines and manipulate their data with ease, especially with the help of expert outsiders.

The Press dismissed any hint of electoral fraud, based on slippery statistical regression analysis. Otherwise, deafening silence on this topic, despite daily, loving reportage of Trump's every political burp before and since. Everyone just let him win and washed their hands of his stink.

The rich got their millionaires' welfare checks; democracy got sold down the river as slick as you please.

Before the first Civil War, this country locked itself into a system of legal slavery intended to spread everywhere and last forever. Chief Justice Taney and his Court upheld slavery until he died mid-war and Lincoln annulled his noxious influence, supported by the masses but much less by the rich.

The same question applies to Mike Pence (honorable if nothing more) and other constituents of the big Trump fish that stank from day one from the head down.

F) No Congressional or Judicial review, no hemming and having; just summary cancellation pending in-depth investigation?

G) Again, in detail please: how would that work? Must we depend on twicefailed presidential impeachment: slow, clumsy, gleefully undermined by the bad guys and most reluctantly by the others by-the-book, but highly successful in the long run -- for Putin and his agents?

H) Who orders this cancellation and executes it?

I) When will this revocation process begin? Why not immediately? What would happen to you, to me and to anyone else but Trump? His boots of fascist impunity are reverently bootlicked no matter what dog turds he's stepped in.

J) A hypothetical Putin mole like Trump could penetrate how many American security breaches? How many triple backwards flips did the Pentagon have to land to patch things up? Forget the Constitution, civilian freedom from military interference, the safety of our spies overseas, forget anything right side up in DC.

Current reportage barely covers the tip of this iceberg, if that. The TV networks' nightly newscast? Cable's? Any other's? It is only small talk of tired neighbors on a bus: sports, weather, illness, free "news" about commercial products, celebrity stories, political bickering as stupid as it is useless, criminal rampage stories (a half dozen stories

of authorized crime, nauseatingly retold), and puppy in a basket stories. "See you tomorrow, folks!"

Solid international reportage? Balanced news from abroad? Anything but the next Big Brother war scare and military spending bill?

"Sorry, we don't have enough air time for quality stuff like that. Enjoy instead our bread and circus, our pony show aimed at the info proletariat we must lie to."

Note our airtight national security apparatus so hermetic it can't tell a mole hill from a hyena den.

Note, too, the hundreds of sparkling careers ruined heroically, from top to bottom (thousands, counting State officials), merely to slow down this monstrous takeover. Leadership we can lose and die, or promote and maybe survive.

This Republic's iron is Presidential steel. We can make a cardboard President, We will get a cardboard Republic. That is your only choice on WeaponWorld. How many betrayals, , notes before the Second Civil War #5

Concerning the French defeat in 1940, modern historians cannot see the forest for the leaf mold they study so meticulously. The combat friction of total war would cancel all but one of the German tactical advantages, once set against Allied advantages in numbers, fortification and equipment quality.

Three examples in history.

First, the battle of Manzikert in 1071. The Byzantine Army, under Romanos IV, was the most professional, veteran and expensive (socially disruptive, see the third example) army in the world. However, it flew apart from mutinous mercenaries, unreliable allies, strategic over-reach (Manzikert is at antipodes of Anatolia from Byzantium), high-level political treason, cowardly abandon and runaway disobedience. The

Byzantine army outnumbered and was qualitatively superior to Alp Arslan, his Turkic army and many allies; but it fell apart from corruption, inertia and centrifugal politics. Numbers, troop quality and equipment were irrelevant. Anatolia was lost that day through no lack of such.

The second example, France, 1940. Marshal Petain grandfathered the French Army since WWI. He believed French society must purge itself of liberal tendencies by communal sacrifice. He and his hand-picked officers drank up Nazi ideology with a stiff pour of Catholic bigotry. As a result of decades of funding and industrial sabotage, the French Army was short of radios (the exception mentioned above), anti-tank and antiaircraft weapons, first-line fighter and light-attack aircraft. It knew it needed those things in quantity and superiority to slow down the Blitz. It had enough time and talent to field them, but somehow never got them. Modern historians attribute this lack to what? Magical mass senility? A bad mood that decade? Sour wine at lunch? Very hazy explanations so far.

After the defeat, the entire French officer corps was debriefed in Nazi POW camps. Certified fascists were released to administer Vichy and Occupied France. Many French officers were Nazi proxies, from Petain and Gamelin down to reserve staff lieutenants who "lost" a supply train or phoned it in to the Luftwaffe. Mass betrayal outweighed every other factor. Ignoring betrayal as the proverbial thumb on the scale, that leads to the dangerous conclusion that other factors are more important than they really are. Combat friction against a peer adversary levels all of them off to nothing special. Asymmetric warfare is the frictional leveling of comparative military skills, regardless of duration and casualty ratios as long as they are endurable and non-genocide.

Third example: the octopus of U.S. "Defense." Pro-fa political sabotage spreads like blood-poison through the American electorate, its governing bodies and military especially. America's super-sized military budget has hollowed out civil society. This eaten-out commonwealth leaves our politics in the hands of professional eatersout: warmongers among do-nothing centrists and radical rightists of every stripe. There is no political Left, no Peace Party or Green Party. Try nursing this political amputation like that in peace for any length of time.

The U.S. Air Force refused to do on 9/11 what it had done faultlessly for the last sixty years, secure our skies. The U.S. Army hasn't won a war since WWII. And on January 6, no Army officer did what every cadet had been taught to do since the Civil War. "If there is insurrection, gather loyal troops and occupy Federal facilities until further orders from the Federal chain of command that pays your salt. Do not wait for orders, do not follow contradictory orders, do not freeze in place, man Federal facilities and wait." A squad of Marines stationed at rest in full dress uniform behind the Capital Police would have deflated the Jan 6 riot.

Where were they? In barracks watching on TV? Gloating?

Based on the first two examples, I leave it to your imagination how this bloated bag of corruption will stand up against its next existential threat (not just the last asymmetric war speed bumps of corporate profit and convenience). 1) Fascist American planning reminds me of fever dreams from Mein Kampf, Marxist writings and the Bushido Greater Co-Prosperity Sphere: ruthless, seductively proposed, unworkable and destructive for everyone involved.

2) Republicans share attitudes of undeserved entitlement, mediocre exceptionalism, fantasy victimhood, insatiable power hunger and escalating brutality. They favor fantasy and petty profit over wisdom and compassion.

3) They do not administer progress in the American States they control; they impose a Third World extraction economy to fill their pockets. Their states rank worst at anything positive, much higher at everything bad.

4) Like Putin, Republican Rebels believe their troops will be greeted as liberators. They will be fought to the death and react with Nazi predictability.

5) Expect them to enslave, expropriate and exterminate local minorities and their cosmopolitan allies. That will entail guerilla warfare in Republican controlled areas, vast manpower and resource wastage to control rural spaces between the small towns they secure, weakened front-line resistance against Democratic attacks and more recruits for them.

6) As in the Confederacy during the first Civil War, regional fears and desires will neutralize Republican demands for local sacrifice. Republican leaders will compete for power and resources more destructively than Nazi Party bosses did.

7) Army and Marine Corps troops may violate their oath, the way Rebel West Point graduates did. But well-trained minority enlistees will desert from Republican combat units and cadre Democratic ones quickly. The Republican political taint of the U.S. Navy officer corps is revealed by its professional incompetence (the Bonhomme Richard fire, inadequate officer training, Destroyer collisions). While the deep water U.S. Navy may place Democratic cities under embargo, those cities may build river flotillas to penetrate into Republican territory. After its 9/11 fail, expect U.S. Air Force biblethumpers to bomb Democratic civilians for the greater glory of God.

8) Republican politicians routinely violate their oath of office and no-one seems to care. We will regret not having punished them when we had the chance.

9) The latest Republican schemes shove Big Government down people's throat against their will. During Civil War, they will do so at gunpoint.

10) Europe could arm itself and reinforce Democratic forces surprisingly quickly. Compared to it, Russia and China are hollow husks. Anti-American treason will just increase chaos.

11) Once Republican tin-pots impose Civil War regulations, mass arrests, extraction budgets and gag rules on the communities they highjack, American Libertarians will regret all the beer belly freedoms they scorn today.

This Civil War will not end soon. It will cause crippling losses, destroy America as a world power. It will take the U.S. centuries to recover from its fascism infection. Too bad! The USA nowadays, minus their nefarious input, would be the strongest nation in world history.

Chronology past and future, Notes before the Second Civil War #7

1856-7

Chief Justice Roger Taney rules, in the Dred Scott v. Sandford Supreme Court decision, that African-Americans cannot be American citizens. He leaves unfilled the three longest vacancies in the history of the Supreme Court so as to maintain his proslavery minority in power. His breaking the rules to satisfy his prejudices is typical of pro-slavers back then and of Trump Republicans today. For them, success is incompatible with good conscience. The first is necessary; the second is not. His conviction drives the United States into Civil War until his death late in the fourth year of the War. The Dred Scott decision forms part of the anticanon of U.S. common law: four and twenty or so of the stinkiest of many rotten U.S. Supreme Court decisions.

1981 +

As of President Ronald Reagan, the Common Law majority rule of the Supreme Court -- nurtured since the first Civil War, the World Wars, the New Deal and the partial reversal of Jim Crow -- gradually erodes into its anticanonical opposite, openly profa(scist), pro-repression, pro-slavery. After the 1929 Stock Market Crash, toxic wealth disparities between the rich and poor had contracted in America and mutual prosperity held great promise. Thanks to Reagan Republicanism, American (and world) wealth disparities have swollen and prosperity has vaporized for all but the few.

Family planning, LGBT issues and minority human rights and voting rights are gradually eroded as "conservatives" pay more and more money to dictate their twisted political tastes. Evangelical Christian Churches eject every real Christian from their political action congregations and profit centers; they support forced pregnancy, corrupt political and preachers, school censorship of real science and history. They hold political and financial power more important than the Sermon on the Mount; their medieval prejudices and harm done to others for their own good more important than any Christian sense of love. In May 2022, we await the reversal of Roe v. Wade by the current Supreme Court. I will so note when the time comes.

12-12-2000

Bush v. Gore, 531 U.S. 98 (2000), a Scalia Supreme Court decision lets the village idiot Bush the Lesser beat Al Gore for President despite Gore's more numerous national votes. Anticanon.

9-11-2001

A catastrophic cascade of errors deliberate or otherwise overwhelmed the U.S. Defense establishment from top to bottom. A platoon of jihadi martyrs drops the Twin Towers of the World Trade Center in New York City cleanly on its own footprint. Instead of carefully set demolitions (or an amateurish truck bomb attack that failed in 1993), these fools for God crash into buildings with hijacked airliners. How half of Manhattan was not bombarded with thousands of tons of glowing construction material like some

big box office catastrophe movie, who cares? Bush the Lesser was deep in negotiation with the Taliban over a too-good-to-be-true pipeline deal through Afghanistan that would checkmate Russian pipelines to the North (a one-up on his much smarter father President). Anyway, he and his much smarter security advisors neglect many warnings. The U.S. Air Force does not secure American skies like it had done since WWII; then fails to investigate what just happened and sack its command staff for incompetence or worse. The 9/11 Commission Report, released in 2004, does the same job for 9/11 that the Warren Commission Report did for President Kennedy's execution: it smothers the mess under black lava fields of redacted findings that wink with red hot eyes of lies. The Department of Homeland Security stifles the USA under massive new layers of surveillance and control.

2010

In Citizens United v. Federal Election Commission, 558 U.S. 310 (2010), the Roberts Supreme Court grants legal personhood to mere corporations and authorizes unlimited, anonymous political bribes. It could not have left its citizens more disunited. Anticanon.

2012

The Defense Authorization Bill of 2012, legislated by a vile Congress and signed by Weimar Republic President Obama, authorizes the indefinite detention or execution of American citizens by military authorities without due process. Many such violations of Habeas Corpus litter the U.S. Defense bureaucracy and its Continuation of Government disaster contingency plans.

2013

In Shelby County v. Holder, 570 U.S. 529 (2013), the Roberts Supreme Court neutralizes protections of the Voting Rights Act of 1965, thus clearing State Houses to jerrymander districts and suppress fair elections at will. Anticanon.

Otherwise, apart from the page title and this paragraph, this text is entirely his.

So the aristocratic judge finds steady support in society just as much as in government.

... He works as much for the future as for the present. The aristocratic judge is therefore pushed toward the same goal all the time, by the passions of the governed, by his own, and I could almost add by the passions of posterity.

(107) - (108)

If you ask me where I would place American aristocracy, I wouldn't hesitate to say: it is not among the rich. No common bond brings them together. The American aristocracy is at the bar of lawyers and judges.

The more we reflect on what is happening in the United States, the more convinced we become that the body of lawyers in this country forms the most powerful and, so to speak, the only counterweight to democracy.

In the United States, we can easily tell that the legal spirit -- by its qualities and I might even say by its faults -- can neutralize the vices of popular government [author's note: or its virtues].

When Americans intoxicate themselves with their passions, or indulge in the promotion of ideas, lawyers apply an almost invisible brake to moderate and stop them. To the people's democratic instincts, they secretly oppose their aristocratic inclinations; to its love of novelty, their superstitious respect for what is old; to the immensity of its designs, their narrow views; to its contempt for rules, their taste for forms; and to its passion, their habit of proceeding slowly.

The courts are the most visible organs the legal profession uses to influence democracy.

Judges are lawyers who, alongside their taste for order and rules acquired from the study of law, still draw love of stability from the fixed nature of their function. Their legal knowledge secures them a high position among their peers already; political power ends up elevating them to distinctive rank and the instincts of a privileged class.

Armed with the right to declare laws unconstitutional, American judges are always into political affairs[29]. They cannot force the people to make laws, but they can at least force them to keep the faith in their own law and keep agreeing with each other.

• • •

There is hardly a political question in the United States that is not resolved sooner or later as a legal question. Thus all parties, in their daily controversies, must borrow ideas and language from justice. Since most public figures are, or have been, lawyers, they bring their own customs and range of thought to their handling of affairs. The jury completes this familiarization process for every class. So judicial language almost becomes common language. Thus the legal spirit, born in schools and courts, gradually spreads beyond them; it infiltrates society, so to speak; it descends to the lowest ranks; and the entire people ends up engaging in some of a judge's tastes and habits.

Lawyers in the United States form a power base that is little feared, that we barely see, with no banner of its own, which bends flexibly to the demands of the times, and lets go without resistance of all arrangements of the social body. But they wrap around the entire society, penetrate each class that composes it; work on it in secret, act on it all the time without it knowing, and end up molding it to their desires.

I believe, however, that we are far away from the time when federal power, incapable of protecting its own existence and giving the country peace, will somehow die of its own accord. Union is among our values, we want it; its results are obvious, its benefits are evident. When we realize that a weak federal government jeopardizes the Union, I have no doubt we will see the rise of a reactionary movement in favor of force. The government of the United States, of all the federal governments established up to now, is the one most naturally destined to act. As long as it is attacked only indirectly by the interpretation of laws, as long as its substance is not deeply altered, a change of opinion, an internal crisis, a war, could suddenly restore its needed vigor. What I wanted to note here is just this: many of our people assume there is a movement in the United States in favor of centralizing power in the hands of the president and Congress. I claim we can find notable movement in the opposite direction. Far from the federal government gaining strength as it matures, and threatening State sovereignty, I claim that it tends to weaken daily and that Union sovereignty is the only thing in danger. This is what the present [1830s] shows us. What will be the final outcome of this trend, what events can stop, delay or hasten this movement as described? The future conceals those answers, and I do not pretend I could lift that veil.

If republican principles are to perish in America, they will only succumb after a long bout of social work, frequently interrupted, often resumed. Several times they will come back to life, and will only disappear for good once an entirely new people takes the place of that today. However, nothing suggests such a revolution, no sign announces it. [...]

... There are, in terms of political institutions, two kinds of instabilities we should not confuse: the first one deals with secondary laws; it can rule for a long time in a wellestablished society; the other often shakes the very foundations of the constitution, and attacks the generating principles of law. This is always followed by unrest and revolutions; the nation which suffers from it is in a violent and transitory state. ...

• • •

However, I believe that by changing their administrative processes as often as they do, the people of the United States jeopardize the future of republican government.

Their projects hampered without cease by the nonstop flexibility of legislation, it is to be feared that men will end up considering the republic an inconvenient way to live in society. Then the evil that results from the instability of secondary laws could call into question the existence of fundamental laws, and bring about a revolution indirectly; but this age is still very far from us. [...]

What we can predict right now is that in abandoning the republic, Americans would quickly shift to despotism without stopping very long at monarchy. ... In the United States, judges are not elected by a particular class of citizen, but by the majority of the nation; they immediately represent the passions of the multitude, and depend entirely on its wishes. Therefore they inspire neither hatred nor fear. I also point out the little care that has been taken to limit their power by drawing limits around their actions, and the immense space that has been left open to their vagary. This order of things creates habits

that might outlast it. An American judge could keep his power indefinitely by ceasing to be responsible, and it is impossible to tell where tyranny would stop at that point.

•••

However, I cannot claim that one day Americans won't manage to limit the circle of political rights at home, or confiscate these same rights for the benefit of one man; but I cannot believe that they will ever entrust the exclusive use of it to a particular class, or, in other words, that they will install an aristocracy.

An aristocratic body is made up of a certain number of citizens who, without straying very far from the crowd, nevertheless rises above it forever; that we can touch yet cannot hit; with whom we mingle every day, and for whom we cannot be mistaken.

An aristocracy, to last, must institute inequality in principle, legalize it in advance, and introduce it into the family even while it spreads throughout society. All these things so repugnant to natural equity that they can only be gotten from men by force.

•••

... But a people who, starting from civilization and democracy, gradually draws nearer to inequality, and winds up establishing core privileges and exclusive categories: that would be a new thing in the world.

There is no indication that America will be the first to enact such a spectacle. [...]
