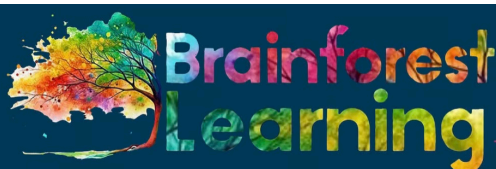
3.3. Automated Technical Data
