Spaniel Trials - Preference is that you type your entry, print and post to the Spaniel Sec. Draws will be published on the club website and returned via SAE if provided. Separate form and cheque for each trial please payable to: Carmarthenshire Working Gundog Society. Alternatively Aran will accept E-mail Entries. WhatsApp/Messenger entries WILL NOT be accepted. The Entry form is available on our website for you to open and type into.

Draws take place at FT Secs home address 7pm, please contact the FT sec if you would like to attend the draw.

Directions to the trial will be communicated with the draw and returned via S.A.E.

Start Time – All Trials meet at 9.00am for a 9.30am prompt start – where reserves will be put in.

Withdrawals – Reg J6f applies. After an applicant has been successful in a draw, or reserve accepted an offer of a run the applicant may be liable for the full entry fee.

Prizes – Certificates & Appropriate trophies. **Trophies** must be returned 1 month before the trial – Failure to return a Trophy by this date will result in a fine of £50.00. Engraving of trophies is the responsibility of the holder.

Please clean trophies before return.

RULES AND REGULATIONS

Dogs entered at Kennel Club Licensed Field Trials must be registered at the Kennel Club in accordance with Kennel Club Regulations for Classification and Registration B. The society may reserve to itself the right to refuse any entry. Persons who have been refused membership may not enter this society's Trials.

No substitution of dogs while reserves stand. All dogs resident outside the UK must be issued with a Kennel Club Authority to Compete number before entry to the show/event can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor. If entries or nominations exceed the number of permitted runners, the right to compete in a Trial shall be decided by ballot. Should circumstances so dictate the society, in consultation with the judges, may alter arrangements as necessary. Such changes and the circumstances surrounding them will be reported to The Kennel Club. No modification may be made to the schedule after publication except by permission of The Kennel Club, followed by advertisement in appropriate journals if time permits before the closing of entries. Judges at a Trial are prohibited from entering a dog which is recorded in their ownership or part ownership. Videography and photography will only be permitted with the express permission of the Chief Steward and the host.

Welfare of Dogs An exhibitor (or competitor) whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met and should not knowingly put their dogs' health and welfare at risk by any action, default, omission or otherwise. A breach of this Regulation may be referred to the Board for disciplinary action under Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any field trial licensed by the Kennel Club. This shall apply at the venue or within the precincts of the trial.

DOGS IN CARS ON HOT DAYS Your dog is vulnerable and AT RISK if left in a vehicle in high temperatures and even on days considered as slightly warm. Please take care of your dog(s).
