CORONIAL MANNER OF DEATH DETERMINATION •

A multidisciplinary international exploration of factors that can influence coronial manner of death determination when investigating cases such as equivocal deaths and staged crime scenes. Suggestions made for upskilling dedicated inquisitorial medicolegal death investigators to assist coroners to establish the truth as to how a decedent came by their death.

MSC FORENSIC BEHAVIOURAL SCIENCE • 2002 • Liverpool

Dissertation focused on the antecedent and motivational factors that lead people to self-harm. The key findings were published in a book by Jan Sutton 'Healing the Hurt Within: Understanding Self-Injury and Self-Harm, and Heal the Emotional Wounds' (October 2005).

Dissertation was in Bloodstain Pattern Analysis – analysing how the type of material affected the pattern of spatter, and hence the accuracy of spatter interpretation at crime scenes.
