This Privacy Policy describes how [<https://www.ginamarieharrison.com> the Site collects, uses, and shares information when you visit or use the website <https://www.ginamarieharrison.com>, including our life coaching services and virtual prayer group (collectively, the "Services").

1. Information Collected

- **Personal Information:** This includes information that can be used to identify you, such as your name, email address, phone number, and billing information (if applicable). We collect this information when you register for an account, subscribe to a newsletter, purchase services, participate in the virtual prayer group, or complete the contact form.
- **Usage Data:** This includes information about how you use the Site and Services, such as your IP address, browser type, operating system, referring URLs, pages viewed, and the dates/times of your visits. This information is collected through cookies, log files, and other tracking technologies.
- **Communications:** The website may collect and store communications you send to it via electronic means, such as emails and chat messages. Information shared during the virtual prayer group sessions, including spoken words, text chat messages, and potentially video/audio recordings (see section 3 for more information) may also be collected.
- **Prayer Requests:** If you submit prayer requests through the website, we will collect and store the content of those requests. Be aware that these requests may be shared with members of the prayer group unless you specify otherwise.
- **Testimonials/Reviews:** If you submit a testimonial or review, your name and the content of your testimonial on our Site may be collected and displayed on the Site.

2. How Your Information Is Used

- **To Provide and Maintain the Services:** Your information is used to provide you with access to the Site and Services, to process your payments, and to respond to your inquiries.
- **To Communicate with You:** Your information is used to send you updates, newsletters, marketing materials, and other information that may be of interest to you.
- **To Improve Our Services:** Your information is used to understand how you use our Site and Services and to improve their functionality and user experience.
- **To Personalize Your Experience:** Your information is used to personalize your experience on our Site and to provide you with content and services that are relevant to your interests.

- **To Conduct Research and Analysis:** Your information is used to conduct research and analysis to improve the Services and to understand users' needs.
- **To Administer the Prayer Group:** Your information is used to manage the prayer group, facilitate discussions, and share prayer requests (with consent, as applicable).
- **Legal Compliance:** Your information is used to comply with applicable laws and regulations.

3. Virtual Prayer Group Considerations

- **Recordings:** We Do Not record the virtual prayer group sessions. If we do record, we will obtain your explicit consent before recording begins.
- **Sharing of Information:** Please be aware that information shared during the virtual prayer group sessions, including spoken words and chat messages, may be visible to other participants. You are encouraged to be mindful of the information you share.
- **Moderation:** We Do moderate the virtual prayer group sessions. If we do moderate, we may remove content that is inappropriate or violates our terms of service.
- **Confidentiality:** While we strive to maintain a safe and respectful environment, we cannot guarantee the confidentiality of information shared during the virtual prayer group sessions. Participants are encouraged to respect the privacy of others.

4. Sharing Your Information

Your information may be shared with the following third parties:

- **Service Providers:** We may share your information with third-party service providers who assist us with providing and maintaining the Services, such as payment processors, hosting providers, email marketing providers, and analytics providers.
- **Legal Authorities:** We may share your information with legal authorities if required to do so by law or legal process.
- **Business Transfers:** In the event of a merger, acquisition, or sale of all or a portion of our assets, your information may be transferred to the acquiring entity.
- **With Your Consent:** We may share your information with third parties with your consent.
- **Other Prayer Group Participants:** Prayer requests and potentially other shared information during the prayer group sessions will be shared with other participants.

5. Cookies and Other Tracking Technologies

We use cookies and other tracking technologies to collect information about your use of our Site and Services. Cookies are small text files that are stored on your computer or mobile device. We use cookies for the following purposes:

- **To remember your preferences:** We use cookies to remember your preferences, such as your language and font size.

- **To understand how you use our Site and Services:** We use cookies to understand how you use our Site and Services and to improve their functionality and user experience.
- **To personalize your experience:** We use cookies to personalize your experience on our Site and to provide you with content and services that are relevant to your interests.
- **To serve targeted advertising:** We may use cookies to serve targeted advertising on our Site and on other websites.

You can control cookies through your browser settings. However, please note that disabling cookies may limit your ability to use certain features of our Site and Services.

6. Data Security

We take reasonable measures to protect your information from unauthorized access, use, or disclosure. These measures include:

- **Encryption:** We use encryption to protect your information during transmission.
- **Firewalls:** We use firewalls to protect our servers from unauthorized access.
- **Access Controls:** We restrict access to your information to authorized personnel only.
- **Regular Security Assessments:** We conduct regular security assessments to identify and address vulnerabilities.

However, no method of transmission over the Internet, or method of electronic storage, is 100% secure. Therefore, we cannot guarantee the absolute security of your information.

7. Data Retention

We will retain your information for as long as necessary to provide you with the Services, to comply with our legal obligations, to resolve disputes, and to enforce our agreements. Specifically, consider the following:

- **Account Information:** Account information for inactive users will be kept for 12 months or less.
- **Prayer Requests:** Prayer requests will be stored for 12 months or less.
- **Recordings (if applicable):** Prayer group session recordings will be stored for 12 months or less (if recorded).

8. Your Rights

You have the following rights with respect to your information:

- **Access:** You have the right to access the information we hold about you.
- **Correction:** You have the right to correct any inaccurate or incomplete information we hold about you.
- **Deletion:** You have the right to request that we delete your information.
- **Objection:** You have the right to object to our processing of your information.
- **Restriction:** You have the right to restrict our processing of your information.
- **Portability:** You have the right to receive your information in a portable format.
