Re: Attorney James Wiggins is recorded as the foreclosure auditor but he is retired

I sent a public information request to the Baltimore City Circuit Court foreclosure auditor James Wiggins via first class mail. This were the instruction I received from the Baltimore City Circuit Court clerk's office. I never received any communication from Mr. Wiggins. I called his office day after day and there was no answer. There was also not a message. I googled Mr. Wiggins name and found out that he was retired. Mr. Wiggins' office was closed. There is a possibility that Mr. James Wiggins has been retired for a few years, despite foreclosure audits being submitted in his name. When I contacted the Baltimore City Circuit Court's senior legal assistance, I was advised to "LET IT GO". My concern is the mortgage fraud that has been allowed in the Baltimore City Circuit Court Case No. 24-O-17-002196. None of the Maryland foreclosure laws §7-105 have been followed. I wanted to know if Mr. James Wiggins was aware that BWW Law Group posted an ad in the paper for a Substitute Trustee's sale for June 12, 2025. The day before the auction date June 11, 2025, Selene Finance who is the mortgage servicer sent a letter to the Better Business Bureau that the account is being serviced in accordance with the terms of the original agreement. This is not a letter that would have been sent if there was any foreclosure action.

at the point of a foreclosure auction. I wanted Mr. James Wiggins to have this information. There was no Mr. Wiggins. Mr. Wiggins never notified the Maryland Bar Counsel that he was retired and his office is closed and the foreclosure audits submitted to the Baltimore City Circuit Court are fraudulent. I never received ny communication from Attorney James Wiggins.

Selene Finance sent a letter to the homeowner stating that they wanted to offer loss mitigation. These are not actions that would have been sent to a homeowner if foreclosure actions were
