The following is the claims report for the period ending on July 31, 2025.

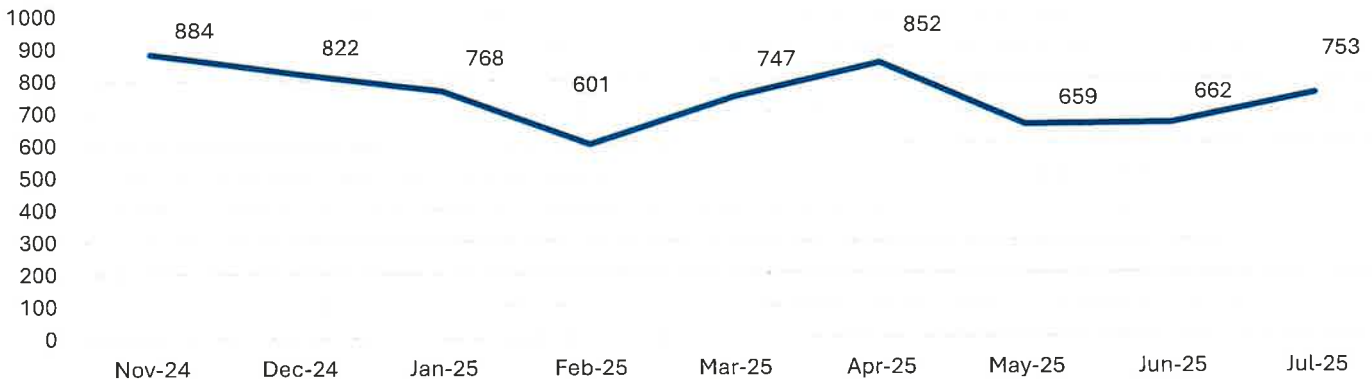

The following is a breakdown for each fund code for the period ending on July 31, 2025:

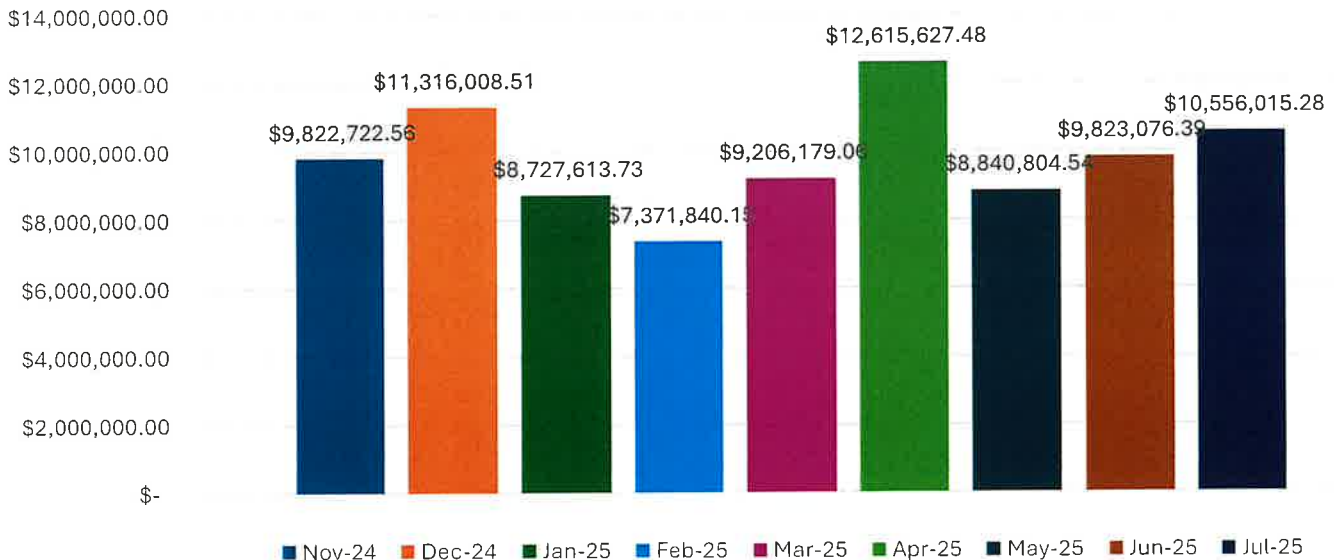
