1. Services Provided

Dr. Richard House (“DJ”) agrees to provide professional DJ services for the above event, including music performance, family-friendly emcee, and sound system suitable for the event size. Consultation regarding the playlist before the event is welcome. Every effort will be made to accommodate music and emcee requests submitted in advance of the event.

2. Fees and Payment

- **Minimum Fee:** \$300 for up to 3 hours of service.
- **Hourly Rate (After 3 Hours):** \$100 per hour for each additional hour.
- **Non-Refundable Deposit:** \$150 due **at least 30 days prior** to the event to secure the booking.
- **Balance Due:** The remaining balance must be paid **on the day of the event**, prior to the start of the performance.
- **Check or Cash Only in US funds.**

3. Cancellation and Refunds

- The \$150 deposit is **non-refundable** (unless waived).
 - Cancellations must be made in writing via email at djmusicdoctor@gmail.com
 - If the DJ is unable to perform due to illness, emergency, or unforeseen circumstances, all payments including the deposit will be refunded in full.
 - If the event is rescheduled, every effort will be made to accommodate, but there are no guarantees to appear on the revised schedule.

4. Setup Requirements

- A **reliable electrical power outlet** must be available **within 20 feet** of the designated speaker and DJ setup area. If a longer distance is needed, a quality long extension cord must be provided.
 - Client agrees to provide reasonable access to the event site for setup and takedown.

5. Liability

- The DJ is not responsible for any damages or injuries resulting from guest behavior or venue conditions.
 - The client is responsible for any damage caused to DJ equipment by guests or attendees.

6. Additional Terms

- Any changes to this agreement must be made in writing and signed by both parties.
