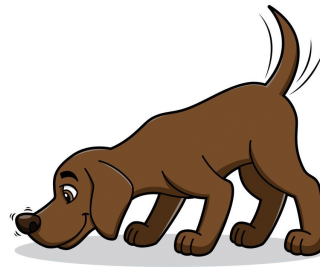

This seminar will introduce dogs and handlers to the beginning principles of scent work. The focus for the dogs will be introducing them to hunting and understanding the game through a primary reinforcer (food or toy). The focus for the handlers will be on understanding how to build and maintain the foundation of scent work. Perfect for beginners looking to start their scent work journey or a seasoned handler looking to introduce a new dog to the game of scent work.

There will be only 10 working spots available for dogs and handlers to get started in scent work along with an unlimited number of auditing spots for handlers only (no dogs) to observe and ask questions.
