## Third Amendment of Declarations of Covenants, Conditions, and Restrictions For Madison Park Subdivision, Phase I & II

This third amendment to the Covenants, Conditions, and Restrictions for Madison Park Subdivision Phase I and II is made and entered constituting the required majority of property owners within Madison Park Subdivision Phase I and II pursuant to the authority granted by the CCRs to amend the same.

## AMENDMENT

Amendment to Article V, Section 10 - "Animals"

The section of the CCRs that currently limits no more than two (2) dogs and two (2) cats may be kept at any residence or on any one lot at any given time is hereby deleted in its entirety, and replaced with the following:

## Article V, Section 10

"Animals" No animals, livestock, or poultry of any kind shall be raised, bred, or kept on any homes or lots, except for dogs, and cats, or other household pets maybe kept. Provided that they are not kept, bred, or maintained for any commercial purpose. All domestic animals must be maintained in a clean, humane, and safe environment, and their presence shall not create a nuisance, safety hazard, or otherwise violate any applicable law or ordinance. No animal other than customary domestic house pets may be kept on a lot or in a home. All animals outside the homeowner's fenced area of their home must be leashed at all times.
