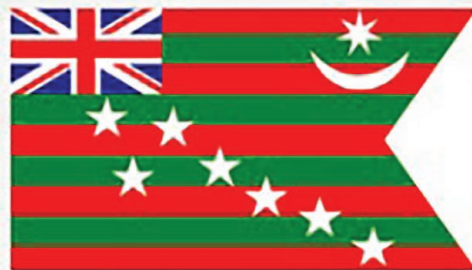
HOW INDIA GOT ITS TRICOLOUR



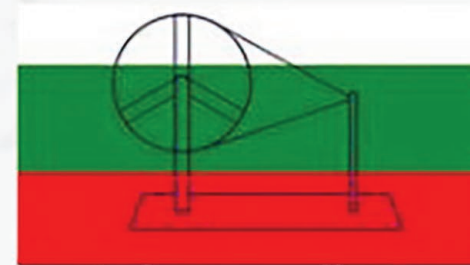
Unofficial flag of India in 1906.

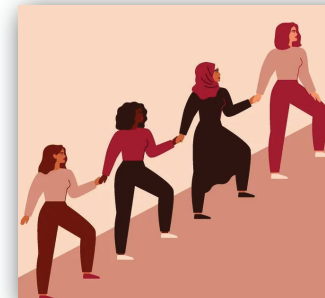
