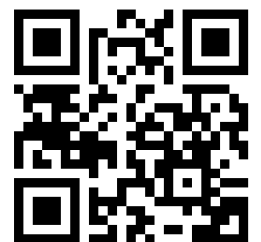

## One-week STP : Law in Daily Life: Practical Insights into New Legislations

The Malaviya Teacher Training Centre, Shri Ram College of Commerce (MMTTC, SRCC) is pleased to invite academicians from colleges and universities to participate in this interdisciplinary six-day online Short-Term Programme (STP). Designed to enhance legal awareness, the programme equips educators with practical knowledge of laws shaping modern India and their implications for individuals, institutions, and society.

Through expert-led sessions, participants will explore how key legislations influence daily interactions, governance, and civic responsibility. The programme covers, but is not limited to, the following legislations:

- Bharatiya Nyaya Sanhita (BNS): New criminal law framework
- Bharatiya Nagarik Suraksha Sanhita (BNSS): Provisions for citizen security and public order
- Bharatiya Sakshya Adhiniyam (BSA): Rules on evidence and legal procedures
- Consumer Protection Act, 2019: Rights and remedies for consumers

Participants will gain practical insights to support students, colleagues, and communities while fostering ethical, lawful, and responsible behaviour.

Recognizing the critical role of academicians in Higher Education Institutions (HEIs) and society at large, this programme emphasizes the importance of legal literacy in cultivating a law-abiding and informed citizenry. By attending, participants will be empowered to guide students and communities toward informed decision-making, promoting civic responsibility, social harmony, and a proactive academic environment.

## Concept Note

The introduction of the three new criminal laws represents a landmark transformation in India's legal framework. Replacing the long-standing Indian Penal Code (IPC), Code of Criminal Procedure (CrPC), and Indian Evidence Act, these new legislations: **Bharatiya Nyaya Sanhita (BNS)**, **Bharatiya Nagarik Suraksha Sanhita (BNSS)**, and **Bharatiya Sakshya Adhiniyam (BSA)**, are designed to modernize the criminal justice system, enhance efficiency, and ensure timely and victim-centric justice.

In addition to these reforms, evolving legislations such as the **Consumer Protection Act, 2019**, **Information Technology Act**, **Right to Information Act**, and others are reshaping the responsibilities of institutions and individuals alike. Educators, being key influencers in society, must be well-versed in these legal changes to guide students and communities effectively.

This six-day programme aims to provide college and university educators with a deep understanding of the new criminal laws, their practical implications, challenges, and integration into everyday academic and civic life. Through interactive sessions, real-world case studies, and expert discussions, participants will be equipped to navigate the changing legal environment, foster responsible citizenship, and support ethical and lawful practices within their institutions.

The programme stands as a transformative learning experience, empowering educators to become informed leaders who can translate legal knowledge into positive action and contribute meaningfully to the advancement of education and society.



## Six-Day STP will emphasise:

- (a) **The Law in Daily Life:** Practical insights into essential and emerging legislations.
- (b) **Collaboration & Leadership:** Equipping participants to engage effectively with students, colleagues, and institutional stakeholders.
- (c) **Tools for Efficiency:** Introducing technologies and methods for enhanced productivity and smoother workflows.
- (d) **Holistic Development:** Fostering self-growth, emotional intelligence, and work-life balance to sustain motivation and professionalism.
- (e) **Case Study Method of Teaching Law:** Real world case discussions and use of case study pedagogy in classroom teaching

## Structure of the Programme

The six-day programme, with four interactive 90-minute Live Sessions each day, is designed to equip educators with practical legal knowledge and collaborative skills. ***The sessions will include:***

- Simplified explanations for better understanding of laws
- Expert-led discussions
- Real-world case studies and practical examples

## Mode and Delivery of the Programme

The Short-Term Programme (STP) will be conducted entirely online over six days, from 3 November 2025 to 10 November 2025. Each day will consist of four interactive sessions, with each session lasting 90 minutes, providing a total of six hours of structured learning per day. Please note the following guidelines for participation:

- The live sessions will be conducted through a reliable online platform to ensure smooth access, interaction, and engagement.
- Participants are required to join the sessions using a computer or laptop with a stable internet connection to facilitate uninterrupted participation.
- The programme will feature expert presentations, case-based discussions, interactive Q&A sessions, and collaborative activities to enhance practical understanding. Participants are expected to actively engage in discussions with their camera on throughout the sessions.
- 100% attendance is mandatory, and participants are required to remain present for the entire duration of each session.
- Active participation is essential to derive the maximum benefit from the programme. Participants are encouraged to ask questions, share experiences, and interact constructively with facilitators and peers.
- All programme protocols, including attendance requirements, assignment submissions, and ethical conduct, must be strictly followed for successful completion.
- Certificates of completion will be awarded only to those participants who meet the attendance and participation requirements.



## Programme Timings (Tentative)

The programme will be conducted from 9:30 AM to 4:30 PM on all six days, from its commencement to completion, with a structured schedule designed to balance learning, interaction, and reflection. The tentative timing for each session is as follows:

**Session I      9:30 AM – 11:00 AM**

**Session II     11:00 AM – 12:30 PM**

**Session III    1:30 PM – 3:00 PM**

**Session IV    3:00 PM – 4:30 PM**

A **one-hour lunch break** will be provided from 12:30 PM to 1:30 PM to allow participants to refresh and prepare for the afternoon sessions. Participants are encouraged to log in at least 10 minutes before the start of each session to ensure timely commencement and avoid disruptions.

## How to Apply for the STP

This interdisciplinary programme is open to academicians from Higher Education Institutions (HEIs), including Central, State, Deemed, and Private Universities, as well as affiliated Colleges.

- Faculty members teaching law or related subjects are encouraged to apply.
- Applicants must submit a No Objection Certificate (NOC) in the prescribed format, issued by the Head of their Institution, confirming their eligibility and consent to participate.

## Requisites for Completion of the STP

- Participants must attend 100% of the sessions to be eligible for certification.
- Assessments will follow UGC guidelines, and participants are required to submit all assignments within the stipulated timelines.
- Session-wise feedback is mandatory to ensure active engagement and continuous improvement.
- Participants must pass the assessments to validate their understanding of the programme content.
- The Certificate of Completion will be awarded only upon meeting all attendance, feedback, and assessment requirements.

This structured approach ensures academic rigor, promotes accountability, and maximizes the learning experience.

- The programme is offered free of cost to all eligible participants.
- It will be conducted entirely online; full attendance is required for certification.
- Admission is on a first-come, first-served basis, so early registration is recommended.
