As an official and independent contractor in CCHRA, you will have the opportunity to officiate many top hockey organizations the state has to offer. Furthermore, as a member of CCHRA, you are not prohibited from working games from other associations. We ask as officials you ask questions, participate and foster the recommendations that all have to offer as this will help you grow and increase your on ice skills. CCHRA follows the recommendations set forth by USA Hockey, Roberts Rules of Order and the Constitution and Bylaws established by the organization. You as an official, must abide by the CCHRA Code of Conduct for ice hockey referees. Below you will find helpful information about CCHRA and the various aspects that make up the organization. Please feel free to contact anyone on the Executive Board or Board of Directors for questions and/or concerns you may have as you begin your path to officiating. Again, welcome and we look forward to your success in our group.

### **Association Dues / Fees**

Dues are \$25.00 each year, removed from your first paycheck of more than \$25.00.

Mandatory association meetings are held throughout the season (see below section on meetings). For each missed meeting you will be deducted \$20.00 from your monthly earned income.

For games accepted through our scheduler and then "turned back" you will be charged \$5.00 for each game. For games that are missed by the scheduled official a full fee of the game assigned will be deducted for each game missed from your monthly earned income.

For refereeing a game for which your scheduled partner misses you will be paid double the game fee.

For each game scheduled, a 3% administrative fee and a 0.5% Thomas Demartino Scholarship Fund fee is removed from the game fee.

### **Assigned Games**

CCHRA uses a web based scheduling system called The Arbiter. The Arbiter is where you will enter your availability so the scheduler can schedule accordingly. You will use the Arbiter to block off dates you are not available and accept or decline games for which you have been assigned. Once assigned a game if you are not able to make the game or your availability has changed for some reason you must turn the game back through our Scheduler – Jim Henkel, do not ask another referee to cover your game. If you have questions regarding any scheduling information you may contact Jim Henkel via his email or phone.

We service the following rinks Yale, Cromwell, East Haven, West Haven, Hamden, Milford, Northford, Bridgeport, Shelton, Choate, Trinity & Wesleyan. Jim assigns games to referees at all rinks based on the officiating strength, level and availability.

As a friendly reminder to all CCHRA members that serve as independent contractors, as per USA Hockey, under the subject title of Scheduling of Games, "Registration with the USA Hockey Officiating Program does not guarantee any official any game assignments. Officials are responsible to obtain their own game assignments from Local Game Schedulers as designated in each District."

## Game Day Appearance and Equipment

For games you are scheduled to work, please arrive at the rink no later than 30 minutes before game time. While there is no formal dress code, please dress appropriately for when you arrive at the game. No ripped clothing, tank tops, etc. The first impression you give the teams/parents/coaches when you arrive is your appearance. Make a good first impression.

Required referee equipment consists of a black helmet with attached half-shield, referee sweater with USA Hockey patch, black referee pants, ice hockey skates (no goalie or figure skates), and a hockey referee whistle (examples include ACME Thunderer or Fox 40 Superforce). It is highly recommended to also wear shin guards (with shin tights to keep them in place), athletic supporter, and elbow pads. Additional padding (girdle and/or padded shirts) is acceptable if it is covered by your pants or sweater. Effective August 1, 2024, neck laceration protection is required for officials under the age of 18. This added level of personal protective equipment may be of value for all on ice officials.

## Meetings

CCHRA holds general membership meetings from August to March. Mandatory meetings for the 2025-26 season are **August 26, September 23 and December 16** and start at 7pm. Meetings take place at the Columbus Lodge, 2630 Whitney Ave. Hamden, CT 06518.

## 2025-26 On-Ice Training Sessions

**For new officials and those with 3 years or less experience, the CCHRA on-ice training sessions are as follows: Sunday, August 10, 9-10:30am, Sunday, September 28, 8-9:30am and Sunday, October 26, 8-9:30am. All sessions will take place at the Northford Ice Pavilion, 24 Firelite Place, Northford, CT. New officials and those with 3 years or less are required to attend 1 session. A mass email will be sent out with registration information. Full referee protective equipment is required. You must be registered with USA-H prior to attending this training.**

### **Payment**

Payment to officials is distributed monthly via the ArbiterPay system which is linked to the Arbiter Sports scheduling website. In order to be paid for the games you have worked for CCHRA, you must be registered with ArbiterPay.
