## Reservation and Rental Agreement

#### Campground Rules:

- Use of alcohol, tobacco and drugs is forbidden on campground.
- No firearms, ammunition, knives, or anything considered to be a lethal weapon is permitted on the grounds. Tractors, mowers, and the tool shed (next to volleyball court) are off limits to guests. No graffiti. Keep all areas of camp free from litter. No open fires except by permission of camp manager (see section on use of <a href="the firepit">the firepit</a>). Camp to be left in the same condition in which it was found. No sticks, debris or other items are to be thrown into the creek.
- Only leashed, non-aggressive pets are allowed on the grounds. Owner assumes responsibility for cleanup and must not allow animals on neighboring properties.
- Maintain egress requirements by keeping the driveway areas clear at all times.
- o Park in lower parking lot (except for handicapped, and loading and unloading.)
- Keep all doors closed at all times, other than when entering or exiting. Quiet hours are from 10pm to 6:30am. Loud noise is prohibited at all times.
- o No fireworks (for fire safety, insurance reasons, and neighbors)

### **Deposit Requirements**

Effective January 1, 2024

1. **Reservation Deposit** = 25% total projected rental cost (as calculated from Fee Schedule)

#### **Example** Cleaning/Damage Deposit Calculation

For Rental Of:

5 sleeping cabins + Director's room (\$25 x 6) = \$150 Kitchen / Dining Hall = \$100 Bathhouse = \$100

3 RV spaces = \$50

TOTAL: \$400 cleaning deposit + 25% projected rental fees
