PUBLIC DECLARATION OF DISPUTE AND CLAIM FOR DAMAGES AGAINST AMAZON KDP

CONTEXT AND BACKGROUND

On October 4th, 2021, Amazon Kindle Direct Publishing (KDP) unilaterally terminated the author account of Javier Clemente Engonga Avomo, citing vague accusations of "tampering with services" and violating content guidelines. This decision was executed without proper evidence, procedural dialogue, or respect for the author's digital sovereignty.

As a result:

- *He lost direct access to his KDP dashboard.*
- *He was denied rightful royalty collection from 176 published titles.*
- *He was blocked from editing, updating, or managing his own intellectual property.*
- *Amazon continued distributing the books internationally without consent or payment.*

These actions constitute a breach of contract, violation of intellectual property law, and disregard for ethical authorship rights.

PUBLISHED WORKS

The affected works include cultural, historical, spiritual, and technological literature, officially registered under the digital sovereign imprint: Biblioteca de Guinea Ecuatorial™. These titles were originally published exclusively through Amazon KDP.

ECONOMIC DAMAGES ESTIMATE

1. Unpaid Royalties

- *Average royalty per title: \$100–\$500 monthly*
- *176 titles x 44 months = 7,744 royalty cycles*

- *Estimated loss:*
 - *Minimum: \$774,400*
 - *Maximum: \$3,872,000*

2. Unauthorized Global Distribution

Books were distributed without license to at least 17 platforms (e.g. Walmart, FNAC, Waterstones).

- *Estimated damages: \$500,000 – \$1,500,000*

3. Moral, Psychological & Professional Harm

Including mental distress, reputational damage, and strategic limitation as a published author.

- *Estimated damages: \$100,000 – \$500,000*

TOTAL DAMAGES CLAIMED:

\$1,374,400 – \$5,872,000 USD (Subject to verification through audit or international publishing mediation)

DEMAND FOR ACTION

In the name of digital sovereignty, authorial dignity, and economic justice, we demand:

- 1. Complete removal of all titles by Javier Clemente Engonga Avomo from Amazon KDP and partner platforms.*
- 2. Restoration of full account access and data control.*
- 3. Immediate settlement of unpaid royalties for the period 2021–2025.*
- 4. Formal public apology acknowledging breach and mishandling.*

Failure to comply will result in formal litigation through:

- International Copyright Arbitration Tribunals*
- Sovereign Jurisdictions of Literary Protection*
- Public Naming through Decolonial Intellectual Property Coalitions*
