REMAKES POLICY

A crown is only as good as the impression. It is the only guideline we have, therefore if the impression is an accurate representation of the patient's mouth then the crown will fit exactly the same way in the mouth as on the model made from that impression. If the impression, however, is not accurate, then the crown will fit the model but not the patient's mouth.

Due to increases in materials and labor we are forced to charge for remakes. We cannot absorb the cost of any remake that is the result of an inaccurate or distorted impression. If a patient changes their mind during or after production of any case, you will incur the cost of any and all changes. Once a case has been completed, any changes made will be regarded as a new case. We will only be held responsible for the fit of the restoration on the model that it was made on.

We'll remake or repair the case free of charge under most conditions. However, charges will be applied under the following circumstances:

The original dental restoration is not returned.
New bite or impression is different from the original
The shade differed from the original order.
Restorative materials are different from the original order.
Abutments and/or teeth are re-prepped.
Study models and/or specific instructions were not provided for anterior cases.
Requested a new impression but you asked us to proceed without one.
Requested a try-in but you asked us to proceed without one.
Advises you the quality of the order cannot be guaranteed but you asked us to proceed anyway.
The lab questions the die, margin, or impression and is told to proceed as is.
Specific instructions were not provided in the original order.

The restoration fits perfectly on the master model and solid model.

Terms & Conditions

You have the right to inspect the product prior to acceptance, however your failure to reasonably notify and return the product within ten days of receipt constitute acceptance. Other forms of acceptance include but are not limited to installing the product into a patient's mouth, or requesting a change of shade. Change of preparation, bite or design modification of any sort to the product. In the event that any case is cancel for any reason before shipment the dentist shall

pay the reasonable value of all work performed prior to receipt of cancellation of order by S.A.N Creations Dental Lab. Notice by a dentist for a non-conforming case shall include a specific and detailed statement of the reason for rejection laboratory shall be given the opportunity correct the defect or replace the case. Where the cause of the non-conforming case cannot be clearly and reasonably identified as due to either the fault of the lab or the dentist. The cost of remaking the case shall be borne equally by the parties hereto.

Where Dentist requests re-manufacture or repair of the Case(s), Dentist shall resubmit all originals to Laboratory including but not limited to original impressions, models and restoration(s).

Remakes are costly for everyone, and we want to make sure that the way we handle this issue makes for a better relationship for all of us.
