



7. रोप लेडर व दो रस्सा भवन के सभी टावर में टावर कि उंचाई जितना हर समय भवन में रखना होगा।
8. यह अग्नि सुरक्षा प्रमाण पत्र अग्नि सुरक्षा की दृष्टि से ही मान्य होगा।
9. यदि राज्य सरकार या निगम द्वारा भविष्य में कोई नियम/उपनियम जारी किया जाता है तो प्रबंधक को मान्य होगा।
