 - ✓ Make and model of all safety equipment used at the job site.
 - ✓ Photos (optional for an AHA): Entire work area. All access points. All potential hazards. All equipment, valves, piping, electrical sources, meters,

The Process:

- ➤ A draft copy will be prepared and provided to Client within 7 business days of receiving ALL "necessary" information to complete the AHA.
 - For an additional fee, expedited draft copies will be provided within 3 business days of receiving all required information. See Fees and Payments below.
- Client will have the opportunity to make corrections and/or provide additional information for the draft copy and return to Preparer.

NOTE: Even though this review is a critical, time saving step for AHA approval, edits are very costly in both time and money. Thus, it is critical that the drafts are reviewed thoroughly before being returned for edits.

- Preparer will complete/update and provide the final copy to the client for submission to the GC SSHO. Upon submission by the client, the client assumes ownership of the AHA.
- ➤ In the event that the submitted AHA, as written by the preparer fails to get approved by the SSHO, the preparer will remain available to consult and will continue to work with the client until an approved AHA is achieved.
