General Terms and Conditions - as of 07/01/2023

1. Validity

These general terms and conditions (hereinafter GTC) apply to all sales contracts that are concluded between the small business owner Ales Trnka and companies and consumers (hereinafter customer) and relate to products that are offered in the online shop: schwarzdorn.io. We only recognize conditions of the customer that deviate from our General Terms and Conditions if we expressly agree to their validity in writing.

2. Conclusion of contract

In our online shop, the customer can first collect the products offered in the shopping cart without obligation and then place a binding order after entering his data and choosing the payment method. As part of the ordering process, the customer has the opportunity to check and, if necessary, correct all the data he has entered before concluding the contract.

We make a binding offer for the products offered in the online shop schwarzdorn.io. The purchase contract is concluded when the customer completes the ordering process. The customer will be sent a confirmation of the transaction to the e-mail address specified during the ordering process. This email will also be saved by us and will be sent to you again on request.

3. Prices

The prices shown in the web shop are total prices, as indicated. They include all taxes (note: Ales Trnka is exempt from sales tax - small business owners according to § 6 Para. 1 Z 27 UstG) but without shipping costs.

The shipping costs can be found in the online shop (EU: 250 EUR, exception Vienna: free of charge)

In the case of delivery to a non-EEA country (on request), the customer must bear all import and export expenses including any customs duties, fees and charges. If you are not from the EU, please contact us before purchasing at: ales@schwarzdorn.io

4. Terms of Payment

You can choose from the following payment methods in our web shop:

5. Delivery

Unless otherwise agreed, we deliver within 1 to 21 working days after receipt of your order. We indicate any deviating delivery times on the respective product page.

6. Transport damage

If you, the customer, are a consumer, we ask you to complain about any transport damage straight away to the deliverer and to contact us immediately. This helps us to assert our claims against the transport service provider. Your right to warranty remains unaffected.

As an entrepreneur, the risk of accidental loss or accidental deterioration passes to you as soon as we have handed over the goods to the

8. Warranty

9. Right of Withdrawal

To meet the cancellation deadline, it is sufficient for you to send the communication regarding your exercise of the right of withdrawal before the cancellation period has expired.

10. Consequences of Revocation

If you revoke this contract, we have to pay you all payments, that we have received from you, including the delivery costs (with the exception of the additional costs resulting from the fact that you have chosen a different type of delivery than the cheapest standard delivery offered by us) immediately and at the latest within fourteen days from the day on which we received the notification of your cancellation of this contract. For this repayment, we use the same means of payment (or transfer to your account that you tell us) that you used for the original transaction, unless something else was expressly agreed with you; under no circumstances will you be charged fees for this repayment.

We may refuse repayment until we have received the returned goods or until you have provided proof (registered mail only) that you have returned the goods, whichever is earlier.

You must return or hand over the goods to us immediately and in any case no later than fourteen days from the day on which you inform us of the cancellation of this contract. The deadline is met if you send back the goods before the period of fourteen days has expired.

You bear the direct costs of returning the goods.

You are only liable for any diminished value of the goods resulting from the handling other than what is necessary to establish the nature, characteristics and functioning of the goods.
