Happy Monday.. here's my next noise abatement complaint email.

Attached is a log I keep (and have screen snapshots of) for aircraft not following the noise abatement path and flying over Tomoka Estates homes.

The log this time is 6 pages and I added a few images on page 7 showing some repeat noise issues. My log has **165 entries** and a short summary of daily activity.

It's not like the Ormond Beach Airport is a small airport and only getting a handful or less complaints in a week but it is a constant noise issue, mostly from Phoenix East Aviation and Embry Riddle University (hasn't changed in several past reports I made)

I have added a column showing minutes between an airplane I am hearing if less than 5 between the next plane

Take a look at April 23, between 2:12 pm and 2:25 pm (not much quiet time and different aircraft). Also April 23 between 6:33 pm and 7:02 pm. April 25 between 8:48 am and 9:48 am.

5 or more passes daily

April 23 – BPX271, 7 passes; BPX201, 7 passes; BPX292, 5 passes; BPX202, 5 passes

April 24 – N541WS between 6 and 11 passes, difficult to distinguish because of the exact same pattern making it show thick lines; BPX203, 7 passes; N624TC, 8 passes (yellow sporty type plane)

April 25 – BPX290, 5 passes; BPX289 7 passes; BPX206, 6 passes

April 27, ERU820, 7 passes; ERU848, 8 passes; ERU846, 6 passes; BPX293, 5 passes
