Attached is a log of my incursion noise abatements for Tomoka Estates from October 9 to October 19, 2025

Worst day, Oct 17 a page and half on my logs (pages 2 and 3). Phoenix East continually ignoring the voluntary noise abatement path. Approximately 10 Embry Riddle aircraft and **48 (FORTY EIGHT)** ignored the the voluntary noise abatement path. 48 is ridiculous..I wonder how much money the City of O.B. could acquire with landing fees for Phoenix East. This is just ONE DAY!

Sun Oct. 12, 6:49 pm Phoenix East BPX272 made its 6th pass over Tomoka Estates

Mon Oct 13, 2:07 pm Embry Riddle ERU963 took off east and never even passed US 1 turning into Bear Creek – needs a noise abatement awareness check

Mon Oct 13, 7:05 pm Phoenix East BPX279 made its 9th pass over Tomoka Estates

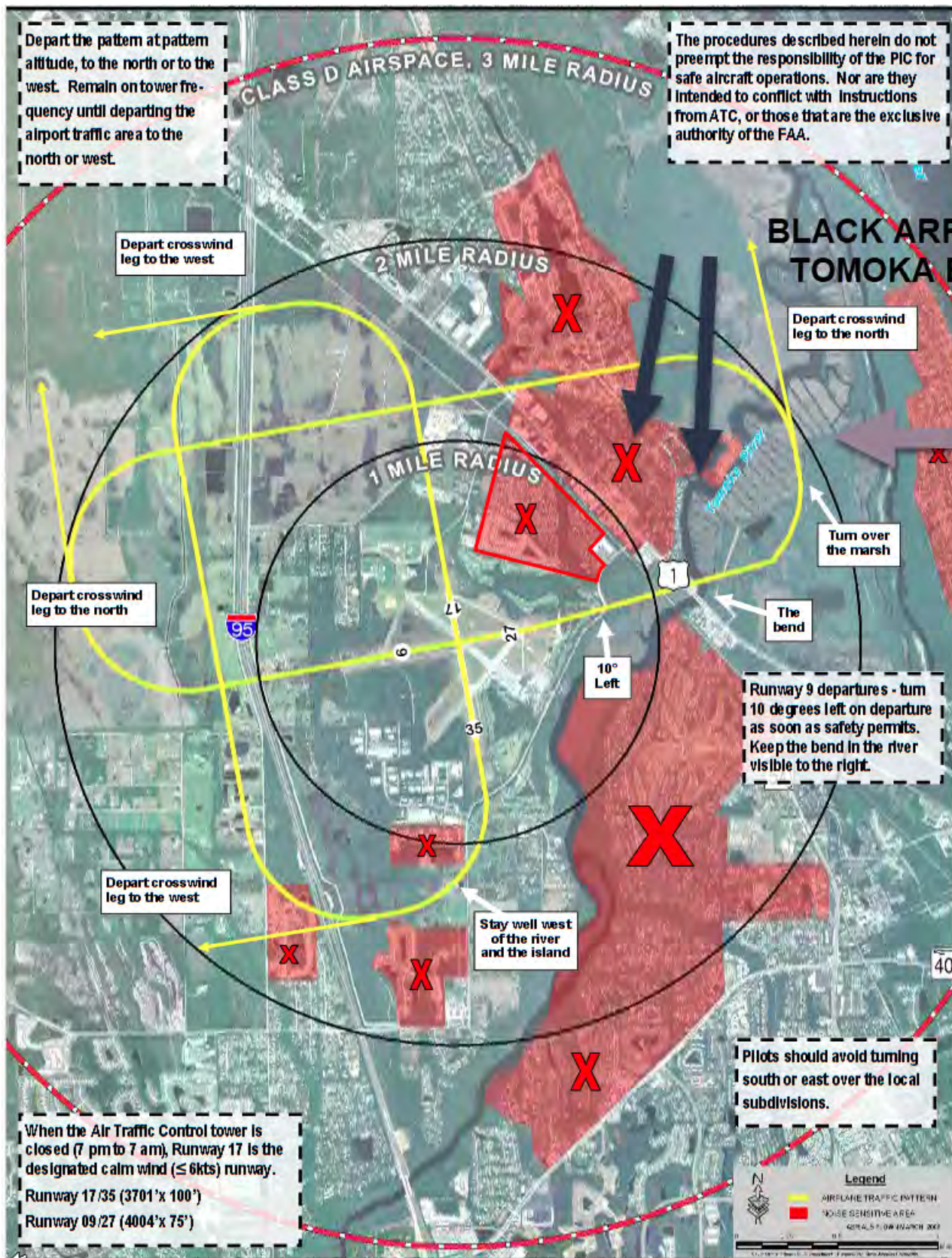
Fri Oct. 17, 8:35 am Phoenix East BPX252 made its 6th pass over Tomoka Estates

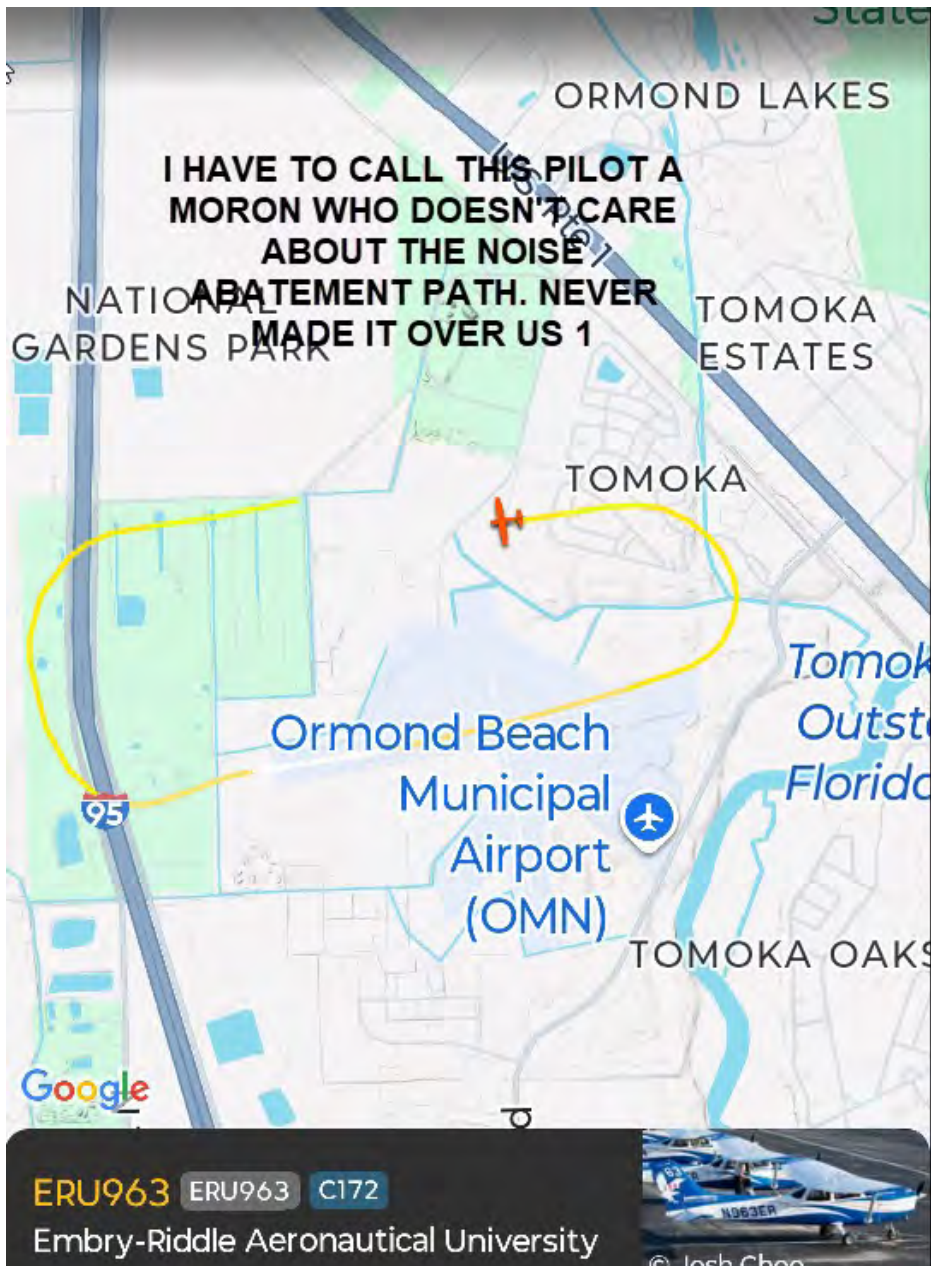


BLACK ARROWS AT TOMOKA ESTATES
