Dear Feauto Aviation LLC,

I'm writing to formally raise a serious concern regarding your aircraft (FEAUTO, KEVIN J), N2056E (Cessna 172M), which flew over my residential neighborhood in Ormond Lakes on Date: 06/17/2025 at approximately 9:00–10:00 PM. The plane passed directly over or near my home at an estimated altitude of 500 feet or less—not once, but twice.

There was no justifiable reason for this aircraft, reportedly originating from Merritt Island, to route through my neighborhood at such a low altitude, especially at that time of night. The nature and path of the flight, combined with similar incidents involving other training schools, strongly suggest this may have been a deliberate act of harassment.

I believe these repeated, unprovoked flyovers are coordinated or spread through word of mouth among flight operators. I want to be clear: this is unacceptable and will not be ignored. I am actively documenting these incidents with video, date, time, registration numbers, and submitting them to the FAA and my lawyer and other oversight bodies. Your aircraft's flight has been added to this growing case.

You are now on notice that your operations are being monitored, and that further unjustified flights over residential areas—particularly at low altitudes—may result in formal legal action and FAA escalation.

Cease immediately. Respect the community you fly over and the residents trying to live in peace, but hey please keep building my case doing stupid flyovers! I know you all believe you are better then the residents.
